# Annual Executive Summary of Interim Activities Virginia State University § 23-9.14:1 of the Code of Virginia

#### **EXECUTIVE SUMMARY**

Pursuant to § 23-2.05 of the Code of Virginia (as amended), Virginia State University hereby submits prior to the first day of the General Assembly an annual summary of interim activity of the work of the Board of Visitors. The University submits as required information related to Virginia Code § 23-2.01 (public access to information); Virginia Code § 23-2.02 (adopting bylaws); Virginia Code § 23-2.03 (BOV annual meeting with the president), and Virginia Code § 23-2.04 (duties of the executive committee). The University also provides a narrative summary demonstrating compliance with these sections and a summary of activities for the year.

### NARRATIVE SUMMARY

During 2015, the Virginia State University Board of Visitors convened four regular meetings: January 15-16, 2015, April 16-17, 2015, September 17-18, 2015 and November 19-20, 2015. One special meeting was called on April 27, 2015. The Board's Annual meeting was held April 16-17, 2015. In addition to the regularly scheduled meetings of the Board, the Board's standing and special committees (Executive Committee; Academic and Student Affairs Committee; Facilities, Finance and Audit Committee; Institutional Advancement Committee; Resource Committee; and President's Residence Committee) convened two special meetings. The President's Residence Committee convened on April 1, 2015 and the Institutional Advancement Committee convened on October 30, 2015.

On January 16, 2015, an entrance conference was conducted by the Auditor of Public Accounts. The related exit conference took place on September 17, 2015 for the fiscal year ending June 30, 2014. The University received an unmodified audit opinion.

An orientation session for new Board member Dr. Darryl Dance was held on May 6, 2015 on the University's campus. In addition, Board member orientation was also completed for new board members, Michael Fleming, Glenn Sessoms, and Wayne Turnage on the University's campus on August 20, 2015.

The Board's annual retreat was held on August 21, 2015. During this retreat, the Board discussed its board survey results, desired workshop outcomes, top strategic issues confronting Historically Black Colleges and Universities (HBCUs), the role and responsibility of a governing board, and consequential boards.

# **II. Public Access to Information**

### A. Requirements

## § 23-2.01. Boards of visitors; public access to information.

Notwithstanding § 2.2-4342 and the Virginia Freedom of Information Act (§ 2.2-3700 *et seq.*), the board of visitors of each public institution of higher education and the State Board for Community Colleges may conduct closed meetings pursuant to §§ 2.2-3711 and 2.2-3712 and may conduct business as a "state public body" for purposes of subsection B of § 2.2-3708.

# **B.** Current Practice and Compliance

The Virginia State University Board of Visitors continues to comply with the Virginia Freedom of Information Act (FOIA) in conducting business as a state public body. Explanation of the compliance follows.

All Board of Visitor meetings, including meetings of its committees and subcommittees, were conducted in a public setting and in accordance with FOIA. Public notices of all Board of Visitor meetings were posted no later than three working days prior to said meeting and these notices indicate meeting times, purpose, and locations. Board of Visitor meeting notices can be found posted on the first and third floor of Virginia Hall on the University's campus, on the University's website under

"Announcements" (<a href="www.vsu.edu/">www.vsu.edu/</a>), on the Board of Visitor's webpage (<a href="www.vsu.edu/about/leadership/board-of-visitors/index.php">www.vsu.edu/about/leadership/board-of-visitors/index.php</a>), and on the Commonwealth of Virginia's Commonwealth Calendar (<a href="www.virginia.gov/connect/commonwealth-calendar">www.virginia.gov/connect/commonwealth-calendar</a>).

All closed sessions of the Virginia State University Board of Visitors were conducted in accordance with the provisions of the FOIA. The Office of University Legal Counsel ensures that all required FOIA procedural steps are recognized and complied with prior to, during, and following closed sessions.

All electronic meetings and electronic meeting participation of the Virginia State University Board of Visitors were conducted in accordance with FOIA. These electronic meetings also strictly comply with the Act under Virginia Code § 2.2-3708.

# III. Adoption of Bylaws

# A. Requirements

# § 23-2.02. Boards of visitors; bylaws.

The board of visitors of each public institution of higher education and the State Board for Community Colleges shall adopt bylaws for its own governance. This document shall be posted conspicuously on the board's website **and shall include provisions that**:

- 1. Establish the requirement of transparency, to the extent required by law, in all board actions;
- 2. Describe the board's obligations under the Virginia Freedom of Information Act (§ 2.2-3700 et seq.), as set forth in § 23-2:1, including the requirements that:
  - a. The board shall record minutes of each open meeting and post the minutes on the board's website, in accordance with subsection I of § 2.2-3707 and § 2.2-3707.1;
  - b. Discussions and actions on any topic not specifically exempted by § 2.2-3711 shall be held in an open meeting;
  - c. The board shall give public notice of all meetings, in accordance with subsection C of § 2.2-3707; and
  - d. Any official action taken in a closed meeting shall be approved in an open meeting before it can have any force or effect, in accordance with subsection B of § 2.2-3711;

3. Require that the board notify and invite the Attorney General's appointee or representative to all meetings of the board, executive committee, and board committees.

# **B.** Current Practice and Compliance

The Virginia State University Board of Visitors continues to comply with the Virginia Adoption of Bylaws Code Section. Explanation of the compliance follows.

The Board last updated its bylaws on April 11, 2014. At its April 2015 meeting, the Virginia State University Board of Visitors reviewed and affirmed its bylaws. These bylaws are posted on the University website at www.vsu.edu/files/docs/bov/board-membership/vsu-bylaws.pdf.

# IV. Annual Meeting with the President of the Institution

### A. Requirements

# § 23-2.03. Boards of visitors; annual meeting with the president of the institution.

A. In addition to all meetings prescribed in Chapters 5 (§ 23-39 et seq.) through 16 (§ 23-214 *et seq.*), the board of visitors of each public institution of higher education and the State Board for Community Colleges shall meet with the president of that institution at least once annually, in a closed meeting pursuant to subdivision A 1 of § 2.2-3711, and deliver an evaluation of the president's performance.

B. Any change to the president's employment contract during any such meeting or any other meeting of the board shall be made only by a vote of the majority of the board's members.

## **B.** Current Practice and Compliance

The Virginia State University Board of Visitors continues to comply with the requirement of holding an Annual Meeting with the University's President. Explanation of the compliance follows.

It has been the practice of the Board of Visitors to meet annually with the President to deliver its evaluation of the President's performance. During 2015, the University was led by Interim President Pamela V. Hammond. In December 2015, the University completed its formal Presidential Search and secured a contract for its new President. As a result, an evaluation of the President did not take place in 2015.

### V. Duties of the Executive Committee

# A. Requirements

§ 23-2.04. Boards of visitors; executive committee.

The executive committee of the board of visitors of each public institution of higher education and the State Board for Community Colleges shall (i) organize the working processes of the board and (ii) recommend best practices for board governance.

## The committee shall:

- 1. Develop and recommend to the board a statement of governance setting out the board's role;
- 2. Periodically review the board's bylaws and recommend amendments;
- 3. Provide advice to the board on committee structure, appointments, and meetings;
- 4. Develop an orientation and continuing education process for visitors that includes training on the Virginia Freedom of Information Act (§ 2.2-3700 et seq.);
- 5. Create, monitor, oversee, and review compliance with a code of ethics for visitors; and
- 6. Develop a set of qualifications and competencies for membership on the board for approval by the board and recommendation to the Governor.

## **B.** Current Practice and Compliance

The Virginia State University Board of Visitors continues to comply with the Code of Virginia provisions governing the Duties of the Executive Committee. Explanation of the compliance follows.

The Board's Statement of Governance was adopted June 14, 2013. The Board reviewed and affirmed the Statement of Governance on April 17, 2015. The Board's Code of Ethics was adopted June 14, 2013. The Board reviewed and affirmed the Code of Ethics on April 17, 2015. All new board members received an initial on campus VSU orientation and FOIA orientation and continuing education was provided by University Legal Counsel. In August 2015, the Board participated in the Initiative for Strengthening Historically Black Colleges and Universities (HBCU) Governance and Leadership training session provided by the Association of Governing Boards (AGB), and in November 2015, the Board participated in a Shared Financial Leadership and Financial Management for Board Members session led by the State Council of Higher Education for Virginia (SCHEV).

Development of set qualifications and competencies for membership on the Virginia State University Board of Visitors continues to be a standing agenda item at the Board's Annual Meeting.
