I am writing to provide you with an update on the report required by Item 319.C.2 of the 2016 *Appropriation Act*. This report requires the Department of Behavioral Health and Developmental Services (DBHDS) to procure a contractor to develop a comprehensive plan for the publicly funded geropsychiatric system of care in Virginia.

As you may recall, on July 25, 2016, DBHDS requested and was granted an extension until October 1, 2017 for this report. This extension was granted due to the statements by vendors that the November 15, 2016 timeframe was not realistic given the specialized nature of the required work and the need to subcontract with geropsychiatric experts.

DBHDS is writing to provide you with an update on DBHDS's work to repost and resolicit the request for proposals for an array of community and state hospital geropsychiatric services. The chart below provides an overview of the steps DBHDS has taken to obtain a qualified vendor to provide the required services and report by the October 1, 2017 extended due date.
