Annual Report on Construction Procurement (July 1, 2015 – September 30, 2016)

December 1, 2016

BACKGROUND

The Department of General Services (DGS) was directed by the legislature to perform a Construction Procurement Survey and provide Quarterly and Annual Construction Procurement Reports as indicated in Chapter 760, 2015 Acts of the Assembly, excerpted below:

4. That all public bodies as defined in § 2.2-4301 of the Code of Virginia, including public institutions of higher education, shall submit a written report to the Director of the Department of General Services (the Director) for any non-transportation-related construction project in excess of \$2 million that was procured by any method other than competitive sealed bidding. Such report shall be in a form and manner prescribed by the Director after consultation with the contractor community and state and local government procurement officials. The report, at a minimum, shall identify the justification for the procurement method chosen and contain such other information deemed necessary or appropriate by the Director, including whether or not the procurement meets the standards as set forth by the Secretary of Administration guidelines. The Director shall (i) report such information quarterly to the Chairmen of the House Committee on General Laws and the Senate Committee on General Laws and Technology and (ii) post such reports on the Department of General Services' central electronic procurement website. In addition, on or before December 1 of each year, the Director shall submit an annual report to the Governor and the Chairmen of the House Committee on General Laws and Senate Committee on General Laws and Technology that includes (a) the Director's evaluation of and findings regarding the methods of procurement used for such construction procured by designbuild or construction management at risk method and (b) any recommendations for the improvement of (1) the method of procuring construction generally and (2) the Virginia Public Procurement Act (§ 2.2-4300 et seq. of the Code of Virginia).

To meet the legislative requirement that the report be created "after consultation with the contractor community and state and local government procurement officials," DGS contacted these stakeholders in several ways:

- 1. Draft questions were provided to state agencies for comment.
- Draft questions were provided to the Virginia Association of General Contractors, Virginia Associated Builders and Contractors, Virginia American Institute of Architects, American Council of Engineering Companies of Virginia, Virginia Municipal League, Virginia Association of Counties, and the Virginia Association of Government Purchasing for comment.
- 3. Draft survey forms were provided to cities, counties, and state authorized boards, authorities, and commissions for comment.

In addition to soliciting input from the above stakeholders above, DGS made significant efforts to identify all public bodies with construction procurement authority. DGS classifies these public bodies as follows:

- State Agencies (including higher education)
- Cities and Counties
- Towns
- State-established Boards, Authorities, & Commissions
- Locally-established Boards, Authorities & Commissions

DGS reviewed the Code of Virginia to identify all Boards, Authorities, and Commissions with construction procurement powers that were established by the General Assembly. In an effort to identify the locally-established boards, authorities, and commissions, DGS sent several requests to the Cities and Counties requesting their assistance in gathering the names and appropriate contact information for these locally-created entities. DGS also worked to identify as many of these local entities as possible, but without confirmation from the localities, it is possible that some of these locally-created public bodies are not included in the survey.

DGS created a web-based survey through eVA to ensure the efficient and accurate collection of data from the public bodies. Repeated efforts were made to contact the public bodies so that they could be registered for access to this online survey and the reporting deadline was extended to allow additional time for registration and reporting. Despite continued outreach over a three month period, not all entities registered.

SUMMARY OF REPORTED DATA

This report addresses projects both the quarterly reporting requirement for the quarter beginning on July 1, 2016 and ending on September 30, 2016 and the 2016 Annual reporting requirement which includes projects initiated between July 1, 2015 and September 30, 2016 (i.e., for Construction Management at Risk and Design-Build procurements, a Request for Proposal was issued between July 1, 2015, and September 30, 2016).

The overall survey <u>registration rates</u> of known public bodies with construction procurement authority for this reporting period is 66% (compared to 63% for the prior reporting period).

The overall survey <u>reporting rates</u> of the 389 entities <u>who registered</u> as of this reporting period is 82% (compared to 84% of the 361 entities who registered as of the prior reporting period).

The group which completed the required survey includes the majority of larger state and local entities likely to spend significant amounts on construction. The overall reporting rate for the primary construction procurement entities (state, city, and county) is 78%.

From those entities responding to the survey, the following information can be reported on the use of alternate procurement methods:

Reported Use of Construction Manager at Risk (CM@Risk) Procurement:

Entities reported 7 projects this quarter using the CM@Risk method of procurement. See attached for distribution of construction cost, justifications provided, and guidelines utilized. To date, 12 entities reported the use of CM@Risk under a PPEA agreement on 20 projects.

Reported Use of Design-Build (DB) Procurement:

Entities reported 2 projects this quarter using DB procurement. See attached for distribution of construction cost, justifications provided, and guidelines utilized. To date, 6 entities reported the use of Design-Build on 9 projects.

Reported Use of Energy Savings Contract (ESCO) Procurement:

Entities reported 1 project this quarter using ESCO procurement. See attached for distribution of construction cost, justifications provided, and guidelines utilized. To date, 5 entities reported the use of ESCO on 5 projects.

Reported Use of PPEA - Construction Manager at Risk (CM@Risk) Procurement:

No entities reported the use of the CM@Risk method of procurement under a PPEA agreement this quarter. To date, 1 entity reported the use of CM@Risk under a PPEA agreement on 1 project.

Reported Use of PPEA – Design-Build Procurement:

No entities reported the use of the Design-Build method of procurement under a PPEA agreement this quarter. To date, 4 entities reported the use Design-Build under a PPEA agreement on 4 projects.

Reported Use of Job Order Contracting (JOC):

No entities reported the use of JOC this quarter or to date.

EVALUATION, FINDINGS, AND RECOMMENDATIONS

Chapter 760, 2015 Acts of the Assembly requires that the Annual Report includes "the Director's evaluation of and findings regarding the methods of procurement used for such construction procured by design-build or construction management at risk method and (b) any recommendations for the improvement of (1) the method of procuring construction generally and (2) the Virginia Public Procurement Act (§ 2.2-4300 et seq. of the Code of Virginia)" which are outlined below:

Evaluation and Findings:

Only 3% of the reporting entities reported utilizing Design-Build or Construction Management at Risk procurement methods. While there is limited data to draw any definitive conclusions from, some observations can be made.

To provide context, the following descriptions of Design-Build and Construction Manager at Risk are offered.

<u>Design-Build (D/B)</u> – A method of construction procurement that creates a contract between a public body (the Owner) and another party in which the other party (General Contractor) for both design and construction based upon defined characteristics and program requirements

described in the Request for Proposal. In this delivery method an A/E is employed by the General Contractor and does not have a contract with or represent the Owner. Since the design is controlled by the General Contractor, adjustments and substitutions may be made at the contractor's discretion as long as the changes are not contrary to the RFP requirements (bridging documents) and the building code. The RFP requirements (bridging documents) must be sufficiently detailed to assure that the program requirements of the Owner are met.

Construction Manager at Risk (CM@R) - A method of construction procurement that creates a contract between a public body (the Owner) and another party (General Contractor) to provide construction and all related services for the cost of the construction work plus a fixed fee for a Guaranteed Maximum Price (GMP) and is "At Risk" for constructing the entire project within the agreed upon GMP. This delivery method typically uses a two part contract. The first contract is for Preconstruction Services where the CM@R participates and contributes to the project planning including: progress cost estimates, constructability review, evaluation of building systems and components, value engineering, project phasing and logistics, subcontractor outreach and pregualification, final cost estimates and proposed GMP. Assuming a GMP is agreed upon, the second contract is for Construction Services where the CM@R bids and manages the subcontractor work in accordance with the plans and specifications as well as the phasing and logistics plan established during the Preconstruction phase of the project. In this delivery method the A/E has a contract with the Owner; therefore, is representing the Owner's interests. The CM@R procurement method is intended to provide for collaboration during the design process to help the project team manage the budget, schedule, quality, and constructability of the project. This collaboration provides the project team with the opportunity to integrate project phasing, scheduling, construction methods, cost feedback, and other project specific issues into the project planning to allow the owner to mitigate the risks inherent to all construction projects. Due to the open-book and collaborative process, the requirements of the Owner's project manager are increased. To effectively control the process, the Owner's project manager must have the expertise to review and evaluate detailed construction estimates, trade bid packages, Guaranteed Maximum Price Proposals and any associated gualifications and clarifications.

Section 2.2-4308 of the Virginia Public Procurement Act states that "Prior to issuing a Request for Proposal for any design-build or construction management contract for a specific construction project, the public body shall:

1. Have adopted, by ordinance or resolution, written procedures governing the selection, evaluation and award of design-build and construction management contracts. Such procedures shall be consistent with those described in this chapter for the procurement of nonprofessional services through competitive negotiation. Such procedures shall also require Requests for Proposals to include and define the criteria of such construction project in areas such as site plans; floor plans; exterior elevations; basic building envelope materials; fire protection information plans; structural, mechanical (HVAC), and electrical systems; and special telecommunications; and may define such other requirements as the public body determines appropriate for that particular construction project. Such procedures for:

a. Design-build construction projects shall include a two-step competitive negotiation process consistent with the standards established by the Division of Engineering and Buildings of the Department of General Services for state agencies.

b. Construction management projects shall include selection procedures and required construction management contract terms consistent with the procedures as adopted by the Secretary of Administration.

2. Have documented in writing that for a specific construction project (i) a design-build or construction management contract is more advantageous than a competitive sealed bid construction contract; (ii) there is a benefit to the public body by using a design-build or construction management contract; and (iii) competitive sealed bidding is not practical or fiscally advantageous."

In addition, Chapter 760 states that "The report, at a minimum, shall identify the justification for the procurement method chosen and contain such other information deemed necessary or appropriate by the Director, including whether or not the procurement meets the standards as set forth by the Secretary of Administration guidelines." The analysis below reflects this requirement.

Design-Build: Most reported projects were procured in a manner consistent with the Secretary of Administration's Procedures.

When entities deviated from the Secretary of Administration's Procedures, it was due to a failure to include the procurement justification in the Request for Qualifications. However, for the majority of those projects, the procuring entities are exempted from the requirement to follow the SOA procedures by the VPPA.

Construction Management at Risk: Most reported projects were procured in a manner consistent with the Secretary of Administration's Procedures.

When entities deviated from the Secretary of Administration's Procedures, it was due to a failure to include the procurement justification in the Request for Qualifications. However, in most of these cases, the procurement justification was included in the Request for Proposals.

In addition, there were a number of projects where the Construction Manager at Risk was procured after the project had proceeded beyond the Preliminary phase, contrary to the requirement in the SOA procedures that the CM procurement be no later than the Schematic phase. However, in the majority of these cases, the procuring entities are exempted from the requirement to follow the SOA procedures by the VPPA.

Recommendations for Improvement:

The data indicates that the majority of projects utilizing Design-Build and Construction Management at Risk are being procured in a manner consistent with the VPPA and the Secretary of Administration's Procedures. In addition, in accordance with §4-4.01.y.1 of Chapter 780, Acts of the Assembly, those higher education institutions who have been granted independent authority to select the method of procurement have established and documented a process for determining the selection procurement method. However, to address the issues that have been identified, the following are proposed:

General:

DGS recommends a one year extension to the survey process required in 2015, and further recommends no additional changes be made by the General Assembly to the construction methods of procurement until the survey period is complete. This extension will allow:

- The effects of the changes to the Design Build and Construction Management procurement selection processes made by the General Assembly in the 2016 Act of Assembly, Chapter 780, Item 4-4.01 to be reflected in the data.
- 2. Consistent data to be collected for at least two years using the revised General Assembly directed processes.
- 3. The use of more comprehensive data in the analysis and recommendations due to the typical three year life cycle of most large projects from procurement method to project completion.

In addition, based upon the data received to date, DGS can make the following recommendations:

Design-Build:

Provide for uniform procedures to apply to all public bodies across the Commonwealth. These procedures could be modeled after the SOA Procedures.

Construction Management at Risk:

Provide for uniform procedures to apply to all public bodies across the Commonwealth. These procedures could be modeled after the SOA Procedures.
