Re: Progress Report on Implementation of Senate Bill 1411 (2015)

Dear Chairman Obenshain, Chairman Carrico, Chairman Albo, and Chairman Villanueva:

With the passage of SB 1411 in the 2015 legislative session, the Department of Motor Vehicles (DMV) and the Office of the Executive Secretary of the Supreme Court of Virginia (OES) entered into a partnership to assist in the development of technology that would allow DMV to receive payment in full of any delinquent court fines and costs. In accordance with the requirements of Senate Bill 1411 (2015) and Acts of Assembly Chapter 228 (2015), we submit to you this report of our progress.

The efforts of the last calendar year were devoted to using available resources most effectively. As of October 2016, OES, DMV, and Virginia Interactive (VI) successfully achieved full review, approval and execution of necessary contracts. VI will be responsible for providing the online payment platform and developing the system connections that will allow DMV to query information to determine the delinquent amount owed by customers who come to DMV

Customer Service Centers with a suspended license and delinquent court fines and fees. OES has worked with VI to identify, document, and begin development of the services needed to support this process. The services developed will be ready for integration planning with DMV systems in January of 2017. DMV has assigned IT resources for joint planning and all partners are prepared to begin documenting IT integration requirements later this month. We anticipate implementing the agreed solution by fall of 2017.
