Dear Co-Chairman Norment, Co-Chairman Hanger, and Chairman Jones:

Under the requirements of Item 489, Paragraph E of the Appropriation Act (2016 Virginia Acts of Assembly, Chapter 780), this letter serves as notification that, as of April 14, 2017, the following political subdivisions are more than 60 days in arrears in payment of its contributions to the Virginia Retirement System (VRS): City of Petersburg and City of Petersburg Schools (Teachers).

City of Petersburg member contributions have been paid for March. As of November 9, the City has agreed to a payment plan for LODA billing receivables, with payments due on the first of each month from December 2016 through June 2017. Applicable interest has been applied. The fifth and sixth payments were received on April 4, 2017. As of March 10, the City has also agreed to a payment plan for its outstanding retirement contributions, with payments due each month through the end of 2017. The second payment was received April 10, 2017.

The City of Petersburg Schools (Non-professionals) total contributions have been paid in full through March. As of March 28, 2017, the City of Petersburg Schools have agreed to a payment plan for its outstanding retirement contributions, with the balance paid in full by June 30, 2017.
