Under the requirements of Item 489, Paragraph E of the Appropriation Act (2016 Virginia Acts of Assembly, Chapter 780), this letter serves as notification that, as of May 10, 2017, the following political subdivisions are more than 60 days in arrears in payment of its contributions to the Virginia Retirement System (VRS): City of Petersburg and City of Petersburg Schools (Teachers).

As of March 10, the City has also agreed to a payment plan for its outstanding retirement contributions, with payments due each month through the end of 2017. The third payment was received May 10, 2017.

The City of Petersburg Schools (Nonprofessionals) total contributions have been paid in full through April. As of March 28, 2017, the City of Petersburg Schools (Teachers) have agreed to a payment plan for its outstanding retirement contributions, with the balance paid in full by June 30, 2017.
