SUBJECT: §23.1-310 Code of Virginia

I am writing in reference to language in §23.1-310 of the Code of Virginia, which directs the State Council of Higher Education for Virginia to annually assess the degree to which each institution of higher education has satisfied any goals or criteria developed by the Higher Education Advisory Committee. During the period of time for this annual assessment (October 2015 to October 2016), the Higher Education Advisory Committee did not establish any goals or criteria relative to this section of the Code. As a result, the State Council of Higher Education for Virginia reports that it has no assessment for the year.

In September 2016, the State Council of Higher Education for Virginia did certify that institutions met biennial education-related and financial and administrative management measures, consistent with §4-9.01 of Chapter 780 of the 2016 Virginia Act of Assembly and §23.1-206 of the Code of Virginia. A copy of the letter transmitting the Council's action on those measures is attached.
