	Introduction

1. Introduction

The National Flood Insurance Program (NFIP) is a voluntary program intended to provide affordable flood insurance to residents and encourage floodplain management. NFIP participating communities and their residents are eligible for NFIP flood insurance, certain federal grants and loans, and disaster assistance. The goals of the NFIP include:

- Decreasing the risk of flood losses;
- Reducing the costs and consequences of flooding;
- Reducing the demand for Federal assistance; and
- Preserving and restoring the natural and beneficial floodplain functions.

The Community Rating System (CRS) Program is part of the NFIP, and it awards points to participating communities for implementing flood protection policies and activities that go beyond the minimum NFIP requirements. There are 10 CRS classes; each class requires a number of activity points, and in turn provides a premium reduction for NFIP policyholders in and outside of the Special Flood Hazard Area (SFHA). Discounts range from 5% to 45% depending on the CRS class of that community.

To be eligible for CRS participation, the community must be participating in the NFIP. For an overview of the processes to join the NFIP and CRS Programs, please see <u>Appendix D</u>.

This report is intended to provide information related to NFIP and CRS participation in Virginia, as well as the costs and benefits association with CRS participation. While the Department of Conservation and Recreation's Floodplain Program did not have the resources necessary to conduct a detailed cost and benefit analysis of the CRS Program, a cost and benefit analysis of the CRS Program was previously conducted by Wetlands Watch, a non-profit based out of Norfolk, Virginia. This report will rely heavily on the findings of the Wetlands Watch report.

2. Participating Communities

In Virginia, 290 of the 323 communities participate in the NFIP. Only 25 of these communities participate in the CRS Program, which is about 9% of the NFIP communities in Virginia. This is above the national total of about 5%. Below is a breakdown of those 25 communities including their CRS class and insurance discounts. The highest class in Virginia is a Class 6. Nationally, there are 13 communities ranked above a Class 5; only one community is ranked as a Class 1 community.¹

3. Benefits and Costs to Localities

This report highlights the findings of the Wetlands Watch report titled *The Cost & Benefits of the CRS Program in Virginia*. Prior to the requirement established in §2.2-220.4 of the *Code of Virginia*, the Virginia Coastal Zone Management (CZM) Program awarded Wetlands Watch grant funds during Federal Fiscal Year 2016 (FFY16) to conduct a report on the costs and benefits of the CRS Program in Virginia. The CZM Program awarded additional grant funds to Wetlands Watch in Federal Fiscal Year 2017 (FFY17) to request additional input on the report and present findings at the 2018 National Conference of the Association of State Floodplain Managers. The report was completed in October 2017. While the report does not capture the full extent of costs or benefits of participating in the CRS Program, it does provide the most recent and thorough examination of the benefits of the Program.

CRS Benefits

The primary benefit a community receives from the CRS Program is the discount it provides for flood insurance policies within that community. Below is a breakdown of the CRS savings in Virginia.




Figure 1: CRS savings based on FEMA's October 1, 2018 CRS Community List and FEMA policy data current as of July 31, 2018.

In addition to flood insurance discounts, the Wetlands Watch report found that the most important secondary benefit of CRS to Virginia communities is improved public safety. Virginia CRS Coordinators also cited the following as secondary benefits of CRS:

- Better informed citizenry;
- Protection of property;
- Environmental protection; and
- Improved water quality.

Furthermore, the Wetlands Watch report includes information from other studies related to CRS benefit. Specifically, CRS communities across the country experience less flooding.

- CRS communities experienced about 38% less insured flood damage in the SFHA than non-CRS communities.
- CRS communities experienced about 36% less insured flood damage outside of the SFHA than non-CRS communities.

CRS Costs

There is no fee required to join the CRS Program. However, implementation of CRS activities and the administrative work to prepare for and maintain certification requires significant staff time and may incur additional costs for the community. This can vary by community, making it difficult to capture the actual cost of joining or participating in the Program. Additionally, the process to join the Program is dependent on review and approval by the Federal Emergency Management Agency (FEMA) and the Insurance Services Office, Inc. (ISO). Preparation to meet Program pre-requisites, scheduling the review, and participating in the process may take several years (see Appendix D).

Based on interviews with local floodplain administrators, Wetlands Watch also found that the CRS Coordinator's Manual does not accurately reflect the amount of effort it takes to join and stay in CRS. Time spent joining the program varies, but several of the local floodplain administrators suggested it took about 120 hours to join the Program.

Wetlands Watch found that the average estimated cost for maintaining CRS participation to Virginia localities is \$11,570 per community. Certain activities may require additional expenditures by the community, such as providing outreach, which may include costs for developing materials, postage, etc. Other activities, such as acquiring properties for open space, implementing flood warning and response systems, and providing mapping data to residents may also have additional costs.

CRS Benefit-Cost Analysis

The Wetlands Watch report created benefit-cost ratios for all CRS communities in Virginia by comparing the cost of staff time spent on CRS to the amount of savings received on insurance policies.

- The average benefit-cost ratio is 15:1.
- The highest benefit-cost ratio is 68:1.
- The median benefit-cost ration is 8:1.

When comparing the staff costs associated with CRS participation with the savings generated from flood insurance premium discounts, Wetlands Watch found that almost all of the individual communities experienced a positive benefit-cost ratio. Only two of the localities were reported to have negative benefit-cost ratios:

- One community declined permission for researchers to use the community's actual percentage of staff time when calculating the ratio, causing the researchers to use the average percentage across all communities in their calculations for the community instead.
- One community never reported an actual amount of staff time, causing the researchers to use the average percentage across all communities in their calculations for the community instead.

4. Recommendations

The Wetlands Watch report offers several suggestions for addressing some of the barriers identified related to CRS. It is our opinion that at this time, CRS participation should be encouraged, but not required. Additionally, communities should be encouraged to implement CRS eligible activities to reduce their flood risk, even if they do not participate in the Program.

Actions may be taken to make participation easier such as:

- Evaluating the *Code of Virginia* along with any other state-level regulations and policies to identify existing requirements that would be eligible for CRS points.
- Creating a CRS tool-kit to aid communities in joining the CRS program, including but not limited to, an outline of eligible activities localities are already required to implement, potential points for such activities, and example documentation to receive credits.
- Evaluating existing state programs to determine existing funding opportunities that could be used to implement CRS eligible activities.

APPENDIX D

Process to Join the NFIP

The process a community must follow to join the NFIP is dependent on whether or not that community has been mapped with a Special Flood Hazard Area (SFHA).

If a community has been studied by FEMA and determined it does not have any areas mapped with SFHAs, that community must adopt a resolution to join the Program and submit an application to FEMA to join. FEMA is responsible for reviewing and approving that resolution and application. A local floodplain ordinance is not required.

If a community has been studied by FEMA and determined it does have areas mapped with SFHAs, that community must adopt a resolution to join the Program, submit an application to FEMA to join, and adopt a local floodplain ordinance in compliance with the minimum standards identified in 44 CFR 60.3. FEMA is responsible for reviewing and approving that resolution, ordinance, and application. Communities have one year after their first Flood Insurance Rate Map (FIRM) to join the NFIP. If a community applies after that first year, a Community Assistance Visit is required to ensure that all post-FIRM development in the SFHA complies with NFIP minimums before the community may join the program.

Process to Join the CRS Program³

The process to apply for and actually join the CRS Program involves several steps and takes at least 8-12 months. A community may request a CRS classification at any time, but verification reports for approval are only sent to FEMA twice per year.

- 1. After a community meets all of the Class 9 prerequisites and has at least 500 credit points, a CRS classification can be requested by submitting:
 - a. A letter of interest, signed by the community's Chief Executive Officer (CEO), sent to the FEMA Regional Office.
 - i. Copies of the letter are also sent to the State NFIP Coordinator and the Insurance Services Office, Inc. (ISO)/CRS Specialist for the community's area.
 - b. Documentation showing that the community is implementing activities worth at least 500 credit points.
- 2. Once the request submittal is complete, the ISO/CRS Specialist will request approval from the FEMA Regional Office to conduct an initial verification visit, which commences the application process.

NOTE: One of the prerequisites is be in full compliance with the minimum requirements of the NFIP as determined by a Community Assistance Visit (CAV) conducted by FEMA within 6 months of the verification visit. If a community has not had a successful CAV within 6 months, this may delay the application process. The CRS Coordinator's Manual states that FEMA or the State NFIP Coordinator may conduct the CAV; however, FEMA Region 3's approach has been that FEMA must conduct the CAVs for CRS classification because the letter of approval must be issued by FEMA.

- 3. ISO/CRS Specialist schedules the initial verification visit to review the community's programs and activities and collects the needed materials from community staff.
- 4. After the verification visit is completed and all needed documentation has been received, the ISO/CRS Specialist produces a verification report.

NOTE: FEMA and ISO need several months to review, double check, and confirm the ISO/CRS Specialist's verification report. FEMA makes the final decision on the community's credit and classification.

- 5. After FEMA approves a community's classification, it must provide the insurance companies a four-month advance notice.
- 6. A community's classification will take effect on May 1 or October 1, about 8–12 months after the verification visit.

NOTE: Some communities in Virginia have had to wait longer than 1 year for the CRS verification process and approval. The ISO/CRS Specialist that is responsible for Virginia is also responsible for 4 other states, and FEMA Region 3 staff are responsible for 4 other states and Washington, D.C.

- 7. A community must recertify annually that it is continuing to meet the CRS program requirements.
 - a. If a community fails to recertify, it will retrograde to a Class 10.
 - b. If a community fails to recertify activities, it will lose those points, which could cause a class change.
 - c. Repetitive loss communities that fail to submit a copy of its annual outreach project or its annual progress report (as applicable) will retrograde to a Class 10.
- 8. A cycle verification visit are conducted every 3-5 years by the ISO/CRS Specialist to verify the community's classification with the CRS Coordinator's Manual in effect at that time.
- 9. If a community wants to modify its classification, it follows the same process as a cycle verification visit.
