SUBJECT: Report on the Transportation Partnership Opportunity Fund

Pursuant to Section §33.2-1529.1 of the <u>Code of Virginia</u>, the Governor is required to submit semiannual reports on the Transportation Partnership Opportunity Fund ("TPOF" or the "Fund"). This memorandum and the related attachment will constitute that report on behalf of Governor Northam for the period ending December 31, 2018.

During this reporting period of July 1 to December 31, 2018, the TPOF program experienced the following activity:

- Updates to the criteria and guidelines were presented to the Commonwealth Transportation Board ("CTB") and adopted at its July 18, 2018, meeting. The revisions expanded the eligibility requirements to allow state agency transportation services that provide non-highway transportation alternatives for the movement of freight that enhance economic development opportunities and regional connectivity within the Commonwealth to apply for funding. The TPOF Program's guidelines and criteria were last considered and approved by the CTB in February 2016.
- The County of Frederick submitted an application on October 26, 2017, totaling \$1,290,000 to provide safety and capacity improvements at Route 50 and Independent Drive in support of the Navy Federal Credit Union ("NFCU") expansion. NFCU expects to invest \$100 million and create 1,400 new jobs. The grant request was approved by the Advisory Panel on December 14, 2017, and approved by Governor McAuliffe on January 11, 2018. However, a grant agreement was not in place before Governor McAuliffe's term expired. Governor Northam approved the grant on August 1, 2018, and the grant agreement was entered into in October 2018.

- The City of Virginia Beach submitted an application on March 8, 2018, totaling \$2,989,000 to assist with Atlantic Avenue Economic Development Partnership and Shared-Mobility Improvements. The amount of the application was reduced to \$2,744,000 to account for monies the City provided to the project. The grant request was considered by the Advisory Panel on August 8, 2018. After review and significant discussion, the Panel did not recommend the Project for award.
- The Virginia Port Authority submitted an application on August 1, 2018, totaling \$5,000,000 to support expanded 64 Express Barge Service to the Richmond Marine Terminal. The barge service provides non-highway alternatives for the movement of freight and enhances economic development opportunities and regional connectivity within the Commonwealth. The current barge is operating at full capacity, making the second barge essential for meeting the needs of new businesses and existing businesses expanding shipments by barge. The additional service will allow container increases of thirty-three percent in the first year and at least twenty-seven percent each year thereafter. The grant request was approved by the Advisory Panel on August 8, 2018, and by Governor Northam on October 4, 2018. A grant agreement is pending.
- The Virginia Commercial Space Flight Authority (VCSFA) submitted an application on September 13, 2018, totaling \$5,000,000 to assist in building a Venture Class Launch Pad at the Mid-Atlantic Regional Spaceport. The planned Venture Class Launch Pad enabled VCSFA to secure an agreement with Rocket Lab, which will invest \$18 million and create 30 full-time positions. The grant request was approved by the panel on October 9, 2018, and by Governor Northam on November 13, 2018. A grant agreement was entered into in December 2018.

At the end of the previous reporting period, ending June 30, 2018, forty-two applications, representing thirty-two separate projects, had been submitted requesting a total of \$210,204,682 in assistance, with approved awards totaling \$98,053,148. There were three grants pending agreement with the Virginia Department of Transportation ("the Department"). With this adjustment, projects that have reached financial close total \$90,813,148.

With the actions described above, forty-four applications, representing thirty-four separate projects, have been submitted requesting a total of \$220,204,682 in TPOF assistance. The Governor has approved awards totaling \$108,053,148. There are three grants pending agreement with the Department. With this adjustment, projects that have reached financial close total \$97,103,148 (See attachment, Financial Close Total on page 2).

To date, capitalization for the Fund has come from the following:

- \$23,600,000 and \$26,400,000 from the Toll Facility Revolving Account and from the Highway Construction Fund, respectively, pursuant to Chapter 951 of the Acts of Assembly of 2005;
- \$305,000,000 pursuant to Chapter 847 of the Acts of Assembly of 2007 and Chapter 780 of the Acts of Assembly of 2016; and
- \$50,000,000 made available July 1, 2011, from the Commonwealth Transportation Fund pursuant to Item 452 H. of Chapter 890 of the Acts of Assembly of 2011.

House Bill 1887, effective July 1, 2015, provides the TPOF with one-third of all interest, dividends, and appreciation that may accrue to the Transportation Trust Fund and the Highway Maintenance and Operating Fund. The \$305,000,000, as outlined by Chapter 847 of the 2007 Acts of Assembly and Chapter 780 of the 2016 Acts of Assembly, is targeted for specific projects while the remaining \$100,000,000 may be used for any eligible applicant and project. The body of this report focuses on the use of the \$100,000,000 interest earnings to the fund and the dedicated revenue beginning in 2015. The attachment provides a brief summary and overview of the fund in its entirety as of December 31, 2018.

The Fund is one of many tools available to market the Commonwealth to prospective economic development partners. Please let me know if I can provide additional information regarding these projects or the use of the Fund.

Chapter 847 of the Acts of Assembly of 2007 and Chapter 780 of the Acts of Assembly of 2016 Item 449.10 and Item 453 G - \$305,000,000 Appropriation

Through Item 449.10 of Chapter 847 of the Acts of Assembly of 2007, \$305,000,000 was allotted to TPOF out of the \$500,000,000 for the 2007 Transportation Initiative (the "Initiative") projects.

In 2008, the General Assembly, through Item 462 of Chapter 879 of the Acts of Assembly of 2008, reappropriated \$180,000,000 of the \$500,000,000 back to the Commonwealth of Virginia's General Fund. To substitute for these monies, Item 459 H. of Chapter 879 of the Acts of Assembly of 2008 authorized the issuance of \$180,000,000 of Capital Projects Revenue bonds.

Item 453 G of Chapter 780 of the Acts of Assembly of 2016 dedicated the \$31,070,647 that was remaining from the previous allocation to Road Improvements at military installations and improvements at interestate rest areas throughout the Commonwealth.

Item 437 C and Item 4-1.03 of Chapter 836 of the Acts of Assembly of 2017 dedicated the any funds deposited pursuant to Item 453 G.2 of Chapter 836 of the Acts of Assembly of 2017 to fund additional facilities at Mid-Atlantic Regional Spaceport.
