DMAS is transitioning from the current information system to a new information system. As part of that transition, the summary encounter files are moving from an old platform to a data warehouse. Encounters are organized differently in the data warehouse than they are in the old platform. The original reports were created using an old encounter file platform while the new reports were created using the data warehouse. Going forward, DMAS will use the data warehouse to create these reports. The overall results do not vary but expenditures may shift from one period to another because the encounter files have different cut off periods than the data warehouse.
