In accordance with Va. Code § 19.2-386.14(F), attached is a report of Forfeited Asset Sharing Program funds distributed to law-enforcement agencies during fiscal year 2018. The report also includes forfeitures distributed to the State Literary Fund and proceeds received from federal asset forfeitures as reported to the Department of Criminal Justice Services (DCJS) from these law-enforcement agencies.

Participating agencies are required to submit an Annual Certification Report to DCJS by October 31st for the previous fiscal year. While most agencies have met the deadline, some have not yet submitted their reports. These agencies are noted by an "*" in the attached report.

During fiscal year 2018, DCJS asked agencies to include in their reports criminal conviction information at the time of the forfeiture. The responses, which are not required, are included in the report. Pursuant to amendments made to Va. Code § 19.2-386.14(F) during the 2018 Session at the General Assembly, law-enforcement agencies are required to report all criminal charges against the owner of a seized asset and the status of the charge at the time of the disposition. As such, DCJS will include this information on the Forfeited Asset Sharing Program's fiscal year 2019 report.
