#### Re: SFY2019 Mandated Benefits Report

Dear Mr. Johnston,

Aon was retained by the Commonwealth of Virginia's Department of Human Resource Management to review and evaluate the Mandated Benefits Reports as prepared by Anthem and Aetna for the Commonwealth's Health Benefits Plans. The Commonwealth specific reports for Anthem and Aetna for SFY2019 are attached.

The reports provide cost and utilization information for each of the mandated benefits and providers as required. We reviewed and compared the Anthem specific to the Commonwealth's plans alongside the reports submitted for SFY2015-SFY2018. However, SFY2019 was provided using a new reporting platform and may have differences in logic when compared to prior years. Prior to SFY2017, Aetna only provided book-of business data. For SFY2017 through SFY2019, Aetna did provide COVA specific data. However, there are some concerns about the accuracy of the data for SFY2017 given that Virginia's State Corporation Commission (SCC) had not yet released updated instructions using ICD-10 diagnoses codes at the time of the reporting. Aetna compiled this data with assistance from HDMS utilizing the instructions for ICD-9 diagnosis codes and made some assumptions. We expect SFY2018 and SFY2019 data to be more accurate because instructions are now available. While not necessarily an appropriate comparison, we have compared SFY2017-SFY2019 to Aetna's reported book-of business data for SFY2015-SFY2016. Note that the Virginia Business of Insurance shortened the reporting period for 2015 because the ICD-10 codes were not available. Therefore, the SFY2016 data shown in the comparison may seem low compared to other years.

We have a rolling 5 year period of Anthem data to compare, which allows us to draw some general conclusions on cost and utilization patterns related to the mandated benefit provisions. However, to itemize and fully comment on any material impact of the mandates and project future mandate related trends, Aon would need to incorporate data beyond the scope of the reporting requirements of the Mandated Benefits Reports. The Mandated Benefit Reports capture the total claims cost and visits for each mandate and do not contain any information on the cost and utilization patterns related to the specific populations covered by each of the mandated benefits and providers. An independent study would need to be developed to determine reporting metrics that would be appropriate to measure and report on cost, utilization, and health outcomes being driven by the mandates.



Aon did compare overall trends across **Part A: Claim Information - Benefits**, **Part B: Claim Information - Providers** and **Part D: Utilization and Expenditures for Selected Procedures by Provider Type** as per the Anthem reports for SFY2015 through SFY2019. With the exception of SFY2016 (because of the missing data), we observed reasonable trends in total claims paid, claim cost per contract, and visits per contract, a metric we calculated to measure change in utilization volume year over year.


While we do not have COVA specific data prior to SFY2017 on the Aetna HealthAware population, Anthem covers approximately 91% of the contracts for the Commonwealth. Therefore, we can still make reasonable observations about trend from the Anthem data. Note, however, that the SFY2016 and SFY2017 trends for Part A may be misleading as they reflect partial year data for SFY2016.

Anthem Part A total claims per contract decreased at an annual rate of 0.9% and claims cost per visit increased at an annual rate of 0.9% from SFY2015 to SFY2019. In addition, reporting for handicapped dependents has been enhanced to provide a more complete synopsis of information for that category. Total utilization, measured by "visits per contract", has decreased at an annual rate of 1.8% in the same time period. The rate of change in visits per contract from SFY2018 to SFY2019 increased 15.8% following a slight increase last year. Aetna Part A total claims per contract increased 13.2% from SFY2018 to SFY2019.

In addition, we compared the trends for some of the preventive mandated benefits. Specifically, we looked at the change in "visits per contract" to measure change in volume of these procedures year over year for SFY2019, SFY2018, SFY2017, SFY2016, and SFY2015. The "number of contracts" reported for each measure below represents the entire COVA population and "visits per contract" is defined over the entire COVA population. Generally, industry standard methodology used to report preventive procedure rates involves looking at only the subset of the enrolled population applicable for each measure. Please note that an independent analysis would need to be done to report preventative procedure rates for the measures we reviewed. The results are shown in the tables listed in Exhibit A accompanying this letter.

Anthem Part B total claims paid per contract increased at an annual rate of 20.1% and claims cost per visit increased at an annual rate of 8.1% from SFY2015 to SFY2019. Total utilization, measured by "visits per contract", increased at an annual rate of 11.1%. Aetna Part B total claims paid per contract increased 13.3%, claims cost per visit increased 10.6%, and visits per contract increased 2.4% from SFY2018 to SFY2019.

Anthem Part D total claims payments for the selected procedures increased at an annual rate of 5.0% and claims cost per visit increased at an annual rate of 3.0% over the five year period. Aetna Part D total claims payments increased 15.9% and claims cost per visit increased 8.1% from SFY2018 to SFY2019. The majority of cost and visits reported for Part B and Part D are for Physical Therapists, Ophthalmologists, and Chiropractors.





As stated, Aetna started providing the Commonwealth specific population data for SFY2017. Prior years' data (i.e., 2014 through 2016) was provided for informational purposes. However, the SFY2017 and SFY2018 trends are not that meaningful, as the logic Aetna used to compile the data was different. SFY2017 trends also compare two different populations. SFY2019 trends are more reliable as the same logic was used to compile the data and while the HealthAware population is growing, the data that Aetna used for both SFY2018 and SFY2019 is specific to the Commonwealth.

We will continue to monitor the reports, and will continue to provide a general comparison of year over year results as additional results become available. However, it is important to note that our ability to analyze and isolate the impact of the mandated benefits will be limited using the current format of the Mandated Benefit Report, which does not identify the specific population covered by each mandate. We are available to discuss these limitations and what reporting requirements are necessary to accomplish this segmentation.
