Dear Governor Northam,

We are pleased to submit to you and the General Assembly the 2019 Annual Report of the Virginia Coalfield Economic Development Authority (VCEDA).

Fifty new projects and expansions were announced in 2019, the highest number in VCEDA's history, including the location of a Canadian manufacturer establishing its first U.S. manufacturing facility in Russell County, an existing business expansion into two shell buildings in Buchanan and Lee counties, a new R&D facility in Wise County leading the way in graphene research, and 35 new small businesses throughout the region supported by the VCEDA Seed Capital Matching Fund. These 50 projects are projected to create 575 full-time and part-time jobs and more than \$29 million in private investment.

VCEDA approved 57 loans and grants totaling more than \$18.8 million in 2019, and closed 53 loans and grants during the year, the highest number in VCEDA's history. During this historic year, projects were announced and funding was approved in all eight localities in the VCEDA region.

VCEDA remains committed to its mission of helping to enhance and diversify the economy of the coalfield region of Virginia. We look forward to working with the Governor's Office and the General Assembly to help our region continue to diversify and grow.

Mission of the Virginia Coalfield Economic Development Authority

The primary purpose of the Authority is to enhance the economic base for the seven county and one city coalfield region of Virginia (Lee, Wise, Scott, Buchanan, Russell, Tazewell and Dickenson Counties and the City of Norton). The Authority shall provide financial support for the purchase of real estate, construction of buildings for sale or lease, installation of utilities, direct loans and grants to private for-profit basic employers; may apply for matching funds from the state or federal government, or the private sector; and any other support improvements it deems necessary.

Executive Director's Report

This year was another historic year for the Virginia Coalfield Economic Development Authority (VCEDA). Not only did VCEDA set records in 2019 for the number of loan and grant approvals and loan and grant closings, but also for the number of marketing events and prospect visits in which VCEDA was involved, making 2019 the most active year in the history of VCEDA.

There were 50 new projects and expansions in 2019, the highest number in VCEDA's history. These 50 projects are projected to create 575 full-time and part-time jobs and more than \$29 million in private investment. Some of the new projects announced during the year include Polycap, a Canadian-owned injection molding company which located to the Russell County Shell Building in Lebanon, Virginia, with plans to create at least 65 new full-time jobs; Better Living Home Care LLC, a new start-up in Lee County with plans to employ 22; and Carbon Research and Development Co., which is leading the way in graphene research and development at the Graphene Research Center in Wise County with 35 full-time jobs projected.

Several important expansion projects by companies within the region also were announced in 2019, including the back-to-back announcements by Paul's Fan Company of expansion projects in Buchanan County and Lee County projected to create a total of 55 new full-time jobs. Lawrence Brothers, Inc., an existing manufacturer in Tazewell County, also expanded with plans to add 28 new full-time jobs, and Sykes Wise Intuit is adding more than 150 jobs in Wise County.

In terms of funding activities, VCEDA approved 9 loans and 48 grants in 2019, the highest quantity in VCEDA's history. These 57 loans and grants total more than \$18.8 million in new approved VCEDA funding. Thirty-six of the grants approved were to assist new business start-ups in the region through VCEDA's extremely popular Seed Capital Matching Fund. VCEDA also closed 53 loans and grants during the year, the highest number in VCEDA's history. Projects were announced and funding was approved in all eight localities in the VCEDA region during 2019.

It was also a very active year for marketing and business development. During the year, VCEDA participated in 35 marketing and business development events, the most in VCEDA's history. Several of these were done in conjunction with the Virginia Economic Development Partnership. VCEDA also was involved in 70 prospect visits during the year, the most ever recorded by VCEDA.

In conclusion, 2019 was a very active and productive year for VCEDA. Although the region's average unemployment rate of less than 4 percent is the lowest in more than 12

years, considerable work remains in diversifying the economy of the region. It is through a team effort that the region will continue to address this challenge.

POLYCAP LLC | RUSSELL COUNTY | \$3.37 MILLION LOAN

A Canadian-based manufacturer of specialty plastic caps and closures established its first U.S. manufacturing facility in Russell County planning to create 48 new jobs within three years and 65 new jobs within five years at the Russell County Shell Building in Lebanon, Va. The Canadian company rebranded its trade name to Polycap LLC while continuing under the same corporate structure. VCEDA approved an up to \$3,373,287 loan to the Russell County Industrial Development Authority to build out the 76,144-sq.-ft. shell building. VCEDA also previously provided a \$1,544,087 loan to the Russell County IDA for the original construction of the shell building. VCEDA worked with the Russell County IDA, Russell County Board of Supervisors, Town of Lebanon, and the Virginia Economic Development Partnership to secure the project for Lebanon.



PAUL'S FAN COMPANY/SOUTHERN GAP INDUSTRIAL PARK SHELL BUILDING | BUCHANAN COUNTY | \$5.6 MILLION LOAN

Paul's Fan Company, an established Buchanan County business, is expanding and will be the first tenant for the under construction Southern Gap Industrial Park shell building. VCEDA approved an up to \$5.6 million loan to the Industrial Development Authority of Buchanan County, and the VCEDA funds will be used for the buildout and completion of the 80,000-sq.-ft. shell building, construction of an adjacent 29,000-sq.-ft. shop building, the purchase of equipment, machinery and tools, and other improvements. The company will invest \$1.32 million in new equipment in addition to moving equipment from its current location. In addition to retaining 42 full-time and 1 part-time jobs, an additional 25 full-time and 3 part-time jobs are projected within 5 years, and a total of 40 new full-time jobs in 10 years.

PAUL'S FAN COMPANY/CONSTITUTIONAL OAKS SHELL BUILDING | LEE COUNTY | \$1.025 MILLION LOAN

Paul's Fan Company, an existing business in Buchanan County, plans a new division - Paul's Automation and Controls - to be located in the industrial shell building at the Constitutional Oaks Industrial Park in Lee County, Va. Up to 15 full-time jobs will be created as the project matures. VCEDA approved an up to \$1.025 million loan to Paul's Fan Company for the project, and the company plans to invest another \$2.41 million. The loan will be used to purchase the 60,000-sq.-ft. shell building and land from the Lee County Economic Development Authority and to assist with the build-out of the shell building, and purchase of equipment, machinery and tools. The Lee County site of Paul's Fan Company also will be utilized as a service and repair facility.



CARBON RESEARCH AND DEVELOPMENT CO. | WISE COUNTY \$1,500,000 LOAN

VCEDA approved an up to \$1.5 million loan to the Wise County Industrial Development Authority for the Carbon Research and Development Co. project at the Graphene Research Center at the Lonesome Pine Regional Business and Technology Park in Wise, Va. The funds will be used to finance equipment and other improvements at the Graphene Research Center, a 24,000-sq.-ft. facility, formerly known as the Appalachia America Energy Research Center. Described as a "wonder material" of this century, graphene may be produced from any carbon-based material, but unlike other graphene producers who use graphite as the source feedstock, the process used at the center will convert coal and/or wood chips into graphene. Thirty-five new jobs are projected with the project.



SOUTHERN GAP INDUSTRIAL PARK | BUCHANAN COUNTY \$2,154,240 GRANT

VCEDA approved an up to \$2,154,240 grant to the Buchanan County Industrial Development Authority to be used for infrastructure needs at the county's Southern Gap Industrial Park. The funds will be used to finance site grading, site development, road construction, paving, parking lot construction, fiber optics, storm drainage improvements and create two additional project-ready graded sites. Grant funds also will be used to develop a paved access road from State Rt. 744 to the shell building now under construction at Southern Gap and to extend the access road to connect to the future Greenbrier Road extension. VCEDA also approved a grant for \$88,118 to the Buchanan County IDA for a master plan update for Southern Gap.

RIVERSIDE DEVELOPMENT | SCOTT COUNTY \$300,000 LOAN

VCEDA closed an up to \$300,000 loan to the Scott County Economic Development Authority to develop a new site in the southern end of Scott County. The funds will be used for site grading, site development, engineering and permitting fees needed to develop an approximately 10-acre site at the Riverside Development in Weber City, Va., Scott County's newest business/industrial park. The Riverside development is located on an approximately 90-acre tract of land. One site at the park was taken for the TTEC call center project which opened a customer experience center in 2016, leaving no graded sites to market at the park. The new site also will add to VCEDA's inventory of business-ready sites in Southwest Virginia's e-Region.



BACK OF THE DRAGON WELCOME CENTER | TAZEWELL COUNTY | \$150,000 LOAN

VCEDA awarded a \$150,000 loan from the VCEDA Tourism Capital Improvement Matching Fund for the Back of the Dragon Welcome Center located at 592 Main Street in Tazewell, Va. The Back of the Dragon is a successful marketing campaign aimed at motorcycle and sports car enthusiasts to promote the winding 32-mile stretch of Highway 16 from Tazewell to Marion, Va. The welcome center will add to the experience and is also projected to create four full-time and two part-time jobs within a year.





UVA-WISE FOUNDATION/CLINCH RIVER ECOLOGICAL EDUCATION CENTER | WISE COUNTY | \$486,994 GRANT

Development of a workforce development and training space for the new Clinch River Ecological Education Center (CREEC) will be made possible in part by an up to \$486,994 grant from VCEDA to the University of Virginia's College at Wise Foundation. The funds will be used by the college foundation to develop the Clinch River Ecological Education Center at the Oxbow Center in St. Paul, Va. The center will serve as a field station for workforce development and environmental education for students from higher education institutions throughout Central Appalachia and the Mid-Atlantic region, K-12 students, as well as employers and entrepreneurs in the outdoor recreation/adventure industry sector.

LAWRENCE BROTHERS, INC. | TAZEWELL COUNTY \$600,000 LOAN

VCEDA approved an up to \$600,000 loan to be used to finance the purchase of equipment, machinery and tools to assist with an expansion of Lawrence Brothers, Inc., which could add as many as 28 new jobs to the Bluefield, Va., company within five years. Lawrence Brothers, Inc., a manufacturing company located in Tazewell County, does heavy metal fabrication and custom metal applications for various industries, including underground mining, energy and electrical, automotive, material handling, airline and the general metal industrial goods industry. Lawrence Brothers, Inc. has its origins in a welding business started in 1974, and today, the company has grown to more than 80,000 sq. ft. of building space and more than 40 employees.



BREAKS INTERSTATE PARK | BUCHANAN AND DICKENSON COUNTIES | \$554,900 GRANTS

During the year VCEDA approved three grants to the Breaks Interstate Park from the VCEDA Civil Penalties Fund. By statute, 50 percent of the civil penalties collected by the Virginia Department of Mines, Minerals and Energy are transferred quarterly to VCEDA for the development of infrastructure and improvements at the Breaks Interstate Park. The grants will enable the park to make several improvements and expand its adventure tourism offerings including the construction of an approximately 725-foot pedestrian swinging bridge across the Russell Fork gorge from the Virginia side of the park to the Kentucky side of the park. The bridge will be the longest pedestrian swinging bridge in North America, according to park officials.






SOUTHWEST VIRGINIA COMMUNITY COLLEGE EDUCATIONAL FOUNDATION | \$265,565 GRANT

VCEDA approved an up to \$265,565.43 grant to the Southwest Virginia Community College Educational Foundation, Inc. to be used for workforce development and training for the Southwest Virginia Community College Center for Education and Training located at the Russell County Governmental Center in Lebanon, Va. The grant funds, which come from the VCEDA Coalfield Workforce Development and Training Fund, will be used for costs and expenses associated with training equipment, including laboratory equipment, microscopes and casework, as well as costs associated with delivery and installation.

RUSSELL THEATER | TOWN OF LEBANON | \$150,000 GRANT

VCEDA approved a \$150,000 grant to the Town of Lebanon to be used to finance the renovation and rehabilitation of the historic Russell Theater in downtown Lebanon, Va. The funds are from the VCEDA Tourism Capital Improvement Matching Fund and may also be used in part for architectural and engineering expenses associated with the renovation. The renovation of the 3,232 square-foot theater is part of the Town of Lebanon's downtown Main Street revitalization efforts and includes plans to renovate the building into a multi-use facility which could become a hub for a variety of events. Assisting the growth and creation of jobs through matching funding for capital improvements at strategic tourism venues is one facet of VCEDA's overall investment program.



SOUTHWEST REGIONAL RECREATION AUTHORITY SPORTSMAN'S COMPLEX | DICKENSON COUNTY \$149,945 GRANT

VCEDA approved an up to \$149,945 grant from the VCEDA Tourism Capital Improvement Matching Fund to the Southwest Regional Recreation Authority (SRRA) to be used to construct the first phase of a sportsman's complex in Dickenson County. The first phase will focus on construction of an archery complex. Best known for its development of the Spearhead Trails' ATV and multi-use trails in the region, SRRA believes it was created to fulfill a broader mission which encompasses all outdoor recreation and has launched a new non-motorized division including a plan for a new sportsman's complex to include an archery center, rifle/pistol ranges and shotgun ranges.



TAZEWELL CINEMA & ENTERTAINMENT, LLC TAZEWELL COUNTY | \$150,000 LOAN

VCEDA closed an up to a \$150,000 loan from the VCEDA Tourism Capital Improvement Matching Fund for Tazewell Cinema & Entertainment, LLC to assist with the reopening and renovation of the old theater building in North Tazewell. The business is owned by Sharon McReynolds Thomas and John Thomas, who have plans to turn the old theater building into a full entertainment venue offering movies, theater space for live performances through a partnership with the Barter Theatre, a trampoline park and video arcade. The venue also plans to livestream major sporting or cultural arts events. The business projects three full-time and seven part-time employees within one year of its opening and four full-time and 15 part-time employees within five years of opening.

HAYSI KIWANIS MOUNTAINTOP CAMPGROUND DICKENSON COUNTY | \$35,000 GRANT

VCEDA approved an up to \$35,000 grant to be used to finance the installation of a water line and water hook-ups for the Haysi Kiwanis Club Mountaintop Campground. The Haysi Kiwanis Club, a 501(c) (4) non-profit Virginia corporation, is in the process of establishing a campground for ATV and horseback riders who utilize Spearhead Trails' Ridgeview Trail system and the non-motorized Russell Fork Trail, also part of the Southwest Regional Recreation Authority's (SRRA) Spearhead Trail System. VCEDA previously approved funding to the SRRA to help construct the Ridgeview Trail. A total of 18 campground sites are being established, which will now provide campground lodging at the Ridgeview trailhead. One full-time and 2 part-time jobs are projected.



HISTORIC CRAB ORCHARD MUSEUM AND PIONEER PARK TAZEWELL COUNTY | \$50,000 GRANT INCREASE

Last year, VCEDA approved a \$60,000 grant to the Historic Crab Orchard Museum and Pioneer Park for renovations to the Pisgah Store and other improvements. In 2019, VCEDA approved a \$50,000 grant increase for the renovation project after the museum requested the additional funding due to unforeseen additional work in the renovation process. The grant funding is being used to make an addition to the building as well as other improvements and repairs to the space which is occupied by Fisher & Company Restaurant, just off Rt. 19 across from the museum on the museum property.





CLINCH MOUNTAIN MOTORWORKS, LLC | TAZEWELL COUNTY \$155.500 LOAN APPROVAL

Clinch Mountain Motorworks, LLC, a custom motorcycle company specializing in the manufacture and distribution of small displacement motorcycles, was approved for an up to \$155,500 loan from VCEDA. VCEDA also worked with the new business as it decided on locating in the building space in which the motorcycle shop is now housed on Main Street in Tazewell, Va. While the business has decided not to utilize the loan at this time, it celebrated its opening in July with a ribbon cutting which VCEDA attended along with local officials, Back of the Dragon representatives and members of the community. In its application to VCEDA, Clinch Mountain Motorworks projected six full-time jobs within five years of opening.

SOUTHWEST VIRGINIA COMMUNITY COLLEGE EDUCATIONAL FOUNDATION/EVENTS CENTER STUDY | TAZEWELL AND RUSSELL COUNTIES | \$77,000 GRANT

VCEDA approved an up to \$77,000 grant requested by the Southwest Virginia Community College Educational Foundation to be used to conduct a feasibility study for a proposed regional education and events center. As part of the feasibility study, a market analysis, program planning, conceptual layout planning, cost estimate and economic/fiscal impact studies are planned. All of these will help to determine the viability and potential impact of the proposed project.



SOUTHERN GAP VISITORS CENTER GRAND OPENING BUCHANAN COUNTY

Buchanan County and regional officials held a grand opening for the new Southern Gap Visitors Center in Buchanan County on July 11. VCEDA approved a \$500,000 loan and a \$250,000 grant for this project.



ENGLAND, INC. I LEE COUNTY

On March 8, VCEDA participated in an open house held at the England, Inc. furniture manufacturing facility at Dryden in Lee County. VCEDA approved up to a \$515,000 loan to the Lee County Industrial Development Authority (now known as the Lee County Economic Development Authority) to help land the project. This loan was increased to \$535,000 in 2019 in order to complete additional renovations. The company is well ahead of hiring targets, with 64 employees already at the facility.

DANIEL BOONE WILDERNESS TRAIL INTERPRETIVE CENTER SCOTT COUNTY

VCEDA attended the grand opening and ribbon-cutting on the Daniel Boone Wilderness Trail Interpretive Center in Scott County on April 26. VCEDA provided a \$200,000 grant to the Scott County Economic Development Authority for this project.



VCEDA SEED CAPITAL MATCHING FUND

Recognizing that small businesses play a significant role in the growth and stability of the economy, VCEDA established the VCEDA Seed Capital Matching Fund in 2017. The goal of the Seed Capital Matching Fund is to help VCEDA meet the purposes for which it was created by providing a source of matching grant funds to assist new, start-up, and emerging small businesses located within the region, and to attract such small businesses from outside the region to locate within the region. For-profit businesses, no older than one year from the date of the application, with less than 10 full-time employees, with matching funds from one or more other sources, may apply for the VCEDA seed capital funds.

DISMAL RIVER TRUCKING, LLC | BUCHANAN COUNTY \$10,000 SEED CAPITAL MATCHING GRANT

Tyler Justus grew up around trucks as his father owned a trucking business. Owning his own trucking business just seemed to be a natural next step and last summer, Justus took it, opening Dismal River Trucking, LLC. He bought his first truck – a Mack — and hired a driver to run it while he continues to teach at Hurley Elementary-Middle School. The trucking company hauls and delivers various products to select areas. Currently, it is being used to haul coal, but additional products may be hauled in the future, including gravel, rock and asphalt. While he has a driver for the truck, he also drives the truck himself as needed. Plans call for the purchase of a second truck within a year. The business projects two full-time jobs.

FIRED UP POTTERY | BUCHANAN COUNTY \$10,000 SEED CAPITAL MATCHING GRANT






In terms of marketing events, prospect visits, new projects, loan and grant approvals, and loan and grant closings, 2019 was the most active year in the history of VCEDA. Topping last year's record of highest number of prospect visits to the region in VCEDA's history, 2019 became the most active year with 70 prospect visits and participation in 35 marketing outreach and business development events. VCEDA also recorded an all-time high of 50 new projects and expansions in 2019.

Aggressive marketing to site consultants, target industries and trade show audiences using lead generation firms, the VCEDA website, social media, news briefs, media relations, face-to-face meetings and other communication tools, helps VCEDA create interest and invitations to visit and see what Southwest Virginia's e-Region has to offer businesses. In 2019 VCEDA had 174 inquiries about the Southwest Virginia's e-Region that includes Buchanan, Dickenson, Lee, Russell, Scott, Tazewell and Wise counties and the City of Norton.

In conjunction with the Virginia Economic Development Partnership, VCEDA hosted an IT media tour and a site consultant tour in the region, attended two speed networking events with site consultants in Dallas and Chicago, and attended several trade shows and marketing mission trips in places such as West Virginia and Phoenix, AZ. VCEDA exhibited and met with companies at several trade shows throughout the year including Data Center World in Phoenix, FABTECH in Chicago, and SelectUSA in Washington, D.C.

Another member was added to the marketing team in 2019, joining Charlotte Mullins, Cathy St. Clair and Mary Rae Carter as VCEDA Marketing Ambassadors. David Denny of Sanford Holshouser Economic Development Consultants joined the team as a marketing ambassador.

Report on the Financial Statements

We have audited the statement of cash receipts and disbursements of Virginia Coalfield Economic Development Authority for the year ended December 31, 2019 and the related notes to the financial statements.

Management's Responsibility for the Financial Statements

Accordingly, the accompanying financial statements are not intended to present the financial position and changes in fund balances in accordance with generally accepted accounting principles. Our opinion is not modified with respect to this matter.

Other Reporting Required by Government Auditing Standards

In accordance with Government Auditing Standards, we have also issued our report dated February 28, 2020, on our consideration of Virginia Coalfield Economic Development Authority's internal control over financial reporting and on our tests of its compliance with certain provisions of laws, regulations, contracts, and grant agreements and other matters. NOTE 1 - NATURE OF ACTIVITIES AND SIGNIFICANT ACCOUNTING POLICIES

Financial Reporting Entity - Virginia Coalfield Economic Development Authority accounts for all funds received from tax and grant receipts, investment earnings, loan collections and related expenditures for the eight participating localities.

Cash basis of accounting - As is the case of many funds of this type, the accounts are maintained, and the statements are presented, on a cash basis, reflecting only recorded cash receipts and cash disbursements. Therefore, cash collected and not recorded in the general ledger, receivables, and payables, inventories, accrued revenue and expenditures, and equipment and depreciation, which may be material in amount, are not reflected, and these statements are not intended to present the overall financial position or results of operations in conformity with

Cash and cash equivalents - For purposes of reporting cash, the Authority considers all certificates of deposit, savings accounts, and money market funds with an original maturity of three months or less to be cash equivalents

Deposits with banks are covered by the Federal Deposit Insurance Corporation (FDIC) and collateralized in accordance with the Virginia Security for Public Deposits Act (the "Act") Section 2.2-4400 et. Seq. of the Code of Virginia. Under the Act, banks and savings institutions holding public deposits in excess of the amount insured by the FDIC must pledge collateral to the Commonwealth of Virginia Treasury Board. Financial Institutions may choose between two collateralization methodologies and depending upon that choice, will pledge collateral that ranges in the amounts from 50% to 130% of excess deposits. Accordingly, all deposits are considered fully collateralized.
