During fiscal year 2020, 7,546 requests for waivers of statutory fee caps were submitted seeking a total of \$ 5,382,607, and 7,172 requests for waivers were approved for a total of \$ 4,658,486 paid to court-appointed attorneys above the initial statutory fee cap.
