REPORT ON THE ACTUAL EXPENDITURES AND PERFORMANCE RESULTS ACHIEVED BY THE SOUTHERN VIRGINIA INTERNET CRIMES AGAINST CHILDREN TASK FORCE DURING THE 2019-2020 YEAR

OVERVIEW OF THE TASK FORCE

The Southern Virginia Internet Crimes Against Children Task Force, otherwise known as SOVA-ICAC, was founded in 1998 with funding from Department of Justice through the Office of Juvenile Justice Delinquency Prevention. Originally the task force name was Operation Blue Ridge Thunder. The task force designation is through the Bedford County Sheriff's Office. Initial investigative responsibilities were investigating child sexual exploitation crimes perpetrated against children through the use of the Internet but was later changed to include most all child sexual exploitation crimes perpetrated against children to include, but not limited to, child trafficking and child prostitution.

The SOVA-ICAC is comprised of 158 affiliate agencies from all areas of Law Enforcement, the private sector and Non-Government Organizations. Law Enforcement support comes from Federal, State, County City/Local, Tribal and Military agencies. An (*) denotes an agency that joined the Task Force this past year.

Overages shown in spending for equipment and supplies is due to a focused effort in spending down previously unobligated funding that was carried over, that had been accrued due to vacancy savings. This included funding from the 2018-2019 awards that had been carried over due to vacancy savings in prior years as well. We are continuing to spend down the remaining 2019-2020 funds.

PERSONNEL

Funding in the Personnel category was allocated to pay salaries and benefits of core SOVA-ICAC personnel. Core SOVA-ICAC personnel operate out of the SOVA-ICAC office in Forest, Virginia, located within the confines of Bedford County, Virginia. ICAC personnel are employed by the Bedford County Sheriff's Office, or affiliates who have assigned investigators to work full-time out of the SOVA-ICAC main office. The staff is comprised of a Task Force Commander, Sergeants, Analysts, a Cyber Tip Manager, Investigators, and a LAN Manager.. The investigative team is composed of two units, criminal investigations and forensic examiners. In the investigations unit, there is currently one sergeant, and five investigators, one being a K9 handler. An investigator who had been trained and certified as a polygrapher, resigned from the Sheriff's Office, and was subsequently no longer assigned to the task force. We have one open investigator position reserved for affiliate agencies to assign an investigator to the main SOVA ICAC HQ office (with funding for this position allocated out of affiliate funding). In the forensic examiner unit, there is currently one sergeant, and three forensic investigators. We are still currently in the hiring process for the LAN Manager position, as applicants to date did not meet minimum requirements, or withdrew their applications.

Funding for affiliates is used for the purpose of Personnel, Travel/Training and Equipment expenditures. As with funding for the SOVA ICAC Task Force, that was previously mentioned, published overages are due to focused spending of funds from previous awards that were not spent or obligated by affiliates. These included funds from the 2018-2019 award, with the continued spending down of 2019-2020 funds at this time.

PERSONNEL

Funds were allocated to reimburse for time worked by SOVA-ICAC affiliates. The 158 affiliated agencies with SOVA-ICAC employ these staff members, and funds are used to reimburse them for overtime work performed for ICAC investigations. Funding for one affiliate position for full-time assignment to the SOVA-ICAC main task force office comes out of this funding as well. This position is currently vacant, and resulting in vacancy savings. In addition, funding for the salary of financial analyst who supports and manages all funding for the entire task force is also supported with affiliate funding.

TRAVEL/TRAINING

Funding in the travel category is used to train and educate the members of our 158 affiliates and equip them to continue their investigations to locate those individuals who prey upon and exploit our children and secure the evidence needed to bring them to trial. Due to the pandemic, several scheduled trainings and conferences have been canceled or postponed, resulting in a reduction in spending of funds in this category. Training consisted of the following:

Over the past 12 months the SOVA-ICAC has continued to work with DCJS on spending down funds for affiliate agencies. We were on track to spend down funding that had accrued, but due to the Covid-19 pandemic that hit in March, a significant portion of the spending, especially in the travel/training/conference spending, was significantly curtailed.

A few cases of interest during this reporting period include the following:

James City County and Newport News, VA

Ronald Morehouse and his fiancée Sarah Johnson, were both arrested for sex crimes against children. James City County police originally began an investigation into Morehouse, when the biological father of a 12 year old girl, discovered sexually explicit conversation between his daughter and Morehouse, on Snapchat. The 12 year old's biological mother is Johnson. After Morehouse was arrested, the 15 year old sister of the original 12 year old victim, disclosed that Morehouse had sexually abused her while she had previously been living in Newport News, starting in 2017.

The investigation led investigators to discover that the mother, Johnson, knew about and allowed Morehouse to sexually abuse her older daughter, and had been present during some of the abuse, and told the daughter there would be consequences if she did not submit to the abuse. It was also discovered that Morehouse had recorded the abuse, through digital images and videos, and appeared to be preparing to distribute the files, if he had not already done so.

Morehouse entered an Alford plea to the charges in James City County, involving the 12 year old victim, and received a 70 year sentence, with 45 years suspended, and 25 years to serve. Since

the abuse of the 15 year old occurred in Newport News, he was charged and ultimately pled guilty to multiple sex offenses and production of the sexually explicit images and videos, and received 7 life sentences plus 22 years.

Johnson, is currently awaiting trial for her role in the abuse of her daughter.

Pulaski County, VA

Based on a Cybertip referral involving the app MeWe, Pulaski Sheriff's office investigators arrested Travis Doerzaph for possession and distribution of sexually explicit images of children. Doerzaph was an engineer at Virginia Tech, and had been using the app at both home and on campus to commit his crimes. A forensic analysis of his phone also revealed an encrypted app that contained additional files depicting sexually explicit images of children. Doerzaph is currently scheduled to enter guilty pleas to his charges.

Albemarle County, VA:

In December 2019, as part of a proactive UC sting, Investigators with the Albemarle County Police Department arrested Raymond Kemp of Charlottesville, when he solicited an undercover officer posing as a minor male. Kemp is a previously convicted sex offender, who was convicted of sexual battery against a minor, and who also has multiple convictions for failure to register as a sex offender.

Powhatan County, VA:

Investigators with Powhatan County Sheriff's Office, arrested Eric Logan Hockaday for possession of child pornography and using a communications device to solicit a minor. Hockaday had been identified, after the *National Center for Missing and Exploited Children* received a complaint from the parent or guardian of a 14 year old male victim, alleging Hockaday was having an inappropriate relationship the victim. Hockaday was a substitute teacher at Powhatan High School at the time of his arrest.

Amherst County, VA:

Joel Wooldridge, of Monroe, VA, was arrested in April, by investigators with the Amherst County Sheriff's Office. Wooldridge was identified as a suspect as the result of a Cybertip investigation, involving child pornography possession and soliciting a minor. Wooldridge has previous convictions in multiple jurisdictions including burglary, indecent exposure, trespassing, child abuse, and eluding police.

Pulaski County, VA

Based on a Cybertip referral involving the app Kik, Pulaski Sheriff's office arrested Jon-Michael Lynch for possession and distribution of sexually explicit images of children. During the initial investigation, Lynch confessed to distributing the images reported in the Cybertip. When they attempted to search his phone, they discovered it had been wiped. A subsequent search warrant that was executed at his home, produced a computer that had at least another 50 images of sexually explicit images of children. These images depicted the sexual assault of infants, children being raped to the point of ripping the perineum, as well as nude images of deceased children.

Greene County, VA:

In June 2020, investigators with the Greene County Sheriff's Office, arrested Patrick Adam Lawrence, 61, of Canada. For approximately a month, Lawrence had communicated with what he thought to be a juvenile, and proposed sex acts with the juvenile. Lawrence was a truck driver and had been working in the United States. He was subsequently arrested in Buffalo, NY, while attempting to return to Canada. He was extradited back to Green County and is being held at the Central Virginia Regional Jail.

Albemarle County, VA:

Albemarle County Police investigators assumed the online identity of a 12 year old girl, who was being solicited for sex by an adult male she met at a church. Gary Rimmer, of Ruckersville, was subsequently arrested for soliciting a minor online, in September 2019. Rimmer is a registered sex offender, who had been convicted on federal child pornography charges in 2010, and who had been released in November 2014.

Norfolk, VA:

Acting on a Cybertip received from NCMEC via the SOVA ICAC Task Force, investigators with Norfolk Police Department, an affiliate agency on the SOVA ICAC Task Force, arrested Brett Marker, a 34 year old living in Norfolk, on 5 charges of possessing child pornography. At the time of his arrest, Marker was a fifth grade teacher at Norfolk Christian Schools.

James City County, VA:

As a result of four Cybertips received from NCMEC, via the SOVA ICAC Task Force, James City County Police, along with the Gloucester County Sheriff's Office, announced the arrest of William Gibbs on 10 counts of possessing child pornography. Gloucester County Sheriff's Office was asked to take over the investigation by James City County Police, as when they received the Cybertips and identified the suspect as Gibbs, he was currently employed by the James City County Police as an investigator. Gibbs had previously been assigned to work ICAC related cases for James City County Police, from 2008-2015. The charges covered offenses that spanned from January 2015 through September 2019.

Rockbridge County, VA:

While working on an unrelated ICAC case, investigators with the Rockbridge County Sheriff's Office identified another subject using Facebook who was soliciting an underage female. As a result of that investigation, Christian Ray Young was arrested on 3 counts of rape (consensual sex with a 12yo minor), as well as 3 counts of indecent liberties with a child, and 3 counts of soliciting a minor. During this investigation, a search warrant to Snapchat revealed videos of Young having sex with a minor female. He was subsequently charged again in July 2019, with 15 counts of producing child pornography.

Bedford County, VA:

Investigators with the Bedford County Sheriff's Office arrested Warren Norris, 71, in November 2019, on a violation of a protective order. Subsequent investigation led to 10 charges involving production of child pornography, involving an underage female. It was also discovered via recorded jail phone calls, that Norris had been staying at a short term rental property for about a week, after his wife had kicked him out of the house. He was asking an out of state relative to come to the short term rental to recover a laptop and thumb drive, before law enforcement found them. Bedford investigators executed a search warrant approximately 2 hours prior to the relative arriving from out of state, and were able to recover additional pieces of evidence, including written plans on how to leave the country and start a new life.

Covington, VA:

Justin Hipps, was arrested for possession of sexually explicit images of children. Bedford County Sheriff's Office began an investigation into a Cybertip referral, involving an unidentified subject distributing sexually explicit images of children via the internet. After identifying and determining the appropriate jurisdiction, the case was referred to the Covington Police

Department. Investigators with the police department recognized the suspect as being a Virginia State Trooper. Covington Police notified and further referred the case to the Virginia State Police, who subsequently arrested Hipps.

Christiansburg, VA:

Bedford County Sheriff's Office investigators began an investigation into a subject that was reported in a Cybertip referral, and who had been using Twitter to distribute sexually explicit images of children. Further investigation determined that Ethan Havens, of Christiansburg was the suspect. Havens was a police officer for Christiansburg Police at the time. Christiansburg Police supervisors were notified, and requested the case be referred to the Virginia State Police.
