## **Background**

Currently, DBHDS requires reporting from licensed inpatient and residential providers regarding the number of available beds for children and adolescents under the age of 18. However, there are no requirements for licensed providers to report on their staffed beds or on beds by age group (under 14 and 14-17). Neither do Community Services Boards, the Behavioral Health Authority, or community policy and management teams collect or report this level of data. Finally, DBHDS-licensed providers do not generally categorize beds by under 14 or 14-17 but rather as child and adolescent, or adult. Specific criteria for each bed may change as frequently as daily as the provider balances its milieu. Most providers do not categorize their beds in this manner.

Securing these additional levels of data requires manual outreach and reporting via phone or fax from licensed providers. This process is time-consuming and burdensome for both agency staff as well as provider staff. Additionally, there is little to no benefit of this data to DBHDS or the system at large as children and adolescents are not placed in inpatient or residential settings based on being under or over 14 but based on the unique bed criteria and staffing availability of a provider on a particular day or at a particular time.

Recently, the COVID-19 pandemic has placed tremendous pressure on licensed providers – including increased costs related to infection control and staffing shortages. Given these constraints, as well as the minimal benefit of this data, requesting that providers report on staffed beds and beds by child or adolescent age is not feasible.

As such, the following details licensed beds for children and adolescents at inpatient as well as residential facilities throughout the Commonwealth. The DBHDS Office of Licensing is available to answer any questions regarding this report.
