## George Mason University Board of Visitors 2020 Executive Summary of Interim Activities

The Board of Visitors continues to operate in a transparent manner, to the extent required by law, in all Board actions. All meetings were open to the public, and notice was provided pursuant to Virginia Code §2.2-3707.
