Re: June 2021 Lottery Results

Dear Governor Northam:

I am very pleased to provide our report of monthly activities and financial update for the month of June 2021, and preview our preliminary FY21 results, as required in §58.1-4006 of the *Code of Virginia*.

June sales totaled \$276.3 million, up \$77.2 million (38.8%) compared to the same month last year. June profits of \$57.4 million were \$7.7 million (15.6%) higher than June 2020. The strong sales and profits recorded in June 2021 continue to be supported by Virginia's overall strong economy, as evidenced by significant sales gains for traditional lottery products sold at retail, as well as our agency's continued success with iLottery online play introduced at the beginning of FY21.

For the fiscal year to date, Lottery sales totaled \$3.259 billion, an increase of \$1.110 billion (51.7%) compared to last year. Profits for FY21 through June totaled \$766.7 million, or \$171.4 million (28.8%) higher than last year. On June 17th, our final profit transfer of the year was initiated to meet the FY21 budget estimate of \$708.2 million to the Lottery Proceeds Fund. The difference between the estimated FY21 profits included in the enacted budget and actual profits from FY21 sales activity will be transferred to the Lottery Proceeds Fund after the statutorily required certification from the Auditor of Public Accounts, expected no later than August 15, 2021. This residual transfer will be included in the revised budget for available Lottery Proceeds Fund transfers during the forecasting process this fall.

In addition to these transfers to the Lottery Proceeds Fund, the Lottery made debt setoff collection payments to the Department of Taxation totaling \$4,849,585, and unclaimed prizes totaling \$10,323,580 were transferred to the Literary Fund in FY21.
