ANNUAL EXECUTIVE SUMMARY FOR THE WILLIAM & MARY BOARD OF VISITORS

2020

The Board of Visitors is the governing authority of William & Mary (W&M), including the Virginia Institute of Marine Science (VIMS) and Richard Bland College (RBC). The Board has taken multiple actions to ensure compliance with the provisions of the *Code of Virginia §23.1-1303*, which require the Boards of Visitors of each public institution of higher education to submit to the General Assembly and the Governor an annual executive summary no later than the first day of each regular session of the General Assembly.

During 2020, the W&M Board of Visitors held regular meetings on February 5-7, May 12 (annual meeting), September 24-25 and November 19-20, and a Board Retreat on August 3. The Richard Bland College Committee held regularly scheduled meetings September 22 and November 17. A called meeting of the Board of Visitors was held on July 16 and August 25 to discuss reopening campus and receive an update on the university's financial outlook. Multiple other committee meetings were also called. See the Table 1 below for details.
