Re: Annual report on the Virginia Military Spouse Liaison

Dear Governor Northam, Acting Secretary Jabs, Delegate Filler-Corn, and Senator Lucas:

The Virginia Department of Veterans Services (VDVS) Virginia Military Spouse Liaison (MSL) serves as the Commonwealth's military spouse advocate in accordance with §2.2-2002.2 of the Code of Virginia. In this role, the MSL collaborates with key stakeholders within federal, state, local government, military installations, and the private sector to develop and implement a resource system to provide access to employment, childcare, licensure, and community resources. The MSL is also responsible for outreach and provides advocacy for military families. The Military Spouse Liaison gives a voice to military spouses within the Commonwealth to make Virginia the most veteran and military spouse state.


In accordance with §2.2-2002.2(B), the MSL developed a common referral form with the Virginia Employment Commission (VEC) for military spouses, highlighting specific skills, education, and training to help the spouse find meaningful employment quickly in relevant economic sectors. The MSL created and maintains the VDVS *Military Spouse Support* webpage to provide updated legislation, employment, licensure/credentialing, and childcare information. The childcare resources include military installations, Department of Education, Department of Defense fee assistance program, federal child tax credit, and other childcare options. Finally, the MSL invested in establishing key relationships that will benefit military spouses.

The table below details the initiative's metrics from September 10, 2021 (onboard date for the MSL) through November 30, 2021.
