Reporting Requirement – Special Session I, 2021 Virginia Acts of Assembly,
Chapter 522, Item 413 A.1.

The Virginia Department of Emergency Management requests the following actions for emergencies and disasters that the Governor authorized sum sufficient funding. The continuation of the following disasters will allow the Commonwealth to fulfill its obligations to its partners for their disaster response and recovery activities:
