Dear Sir and Madam:

I am pleased to submit the enclosed report in an Excel workbook that summarizes the Virginia Preschool Initiative's (VPI) and Virginia Early Childhood Foundation's Mixed-Delivery Preschool Initiative's enrollment and funding for 2021-2022 as of October 2021. Chapter 552 of the 2021 Acts of Assembly, Item 145.C.14.l directs the Virginia Department of Education (VDOE) to submit a comprehensive report detailing calculated slots, filled slots, wait lists slots, and number of students served from families meeting the various federal poverty levels. Due to continued impacts of COVID-19, programs have been permitted to request filling slots through a late enrollment process. Final enrollment numbers will be known by January 28, 2022. For information on final enrollments, please contact Tiffanie Meehling, Early Childhood Specialist, at Tiffanie.Meehling@doe.virginia.gov.

The VDOE was instructed to include in the report VPI's progress towards the newly established target inclusion rate, such that 10 percent of all children enrolled in each VPI program are children with disabilities. VPI program leaders have been provided with detailed guidance and technical assistance on the inclusion target and a data collection process has been established. Results will be available to the VDOE in spring 2022. VPI programs falling below the 10 percent inclusion target will be required to provide reasons why the target was not achieved and future actions to increase the inclusion rate.
