## **Dear Madams and Sirs:**

The 2021 Special Session II of the General Assembly appropriated \$250,000,000 in American Rescue Plan Act Coronavirus State and Local Fiscal Recovery Funds (CSLFRF) to support qualifying ventilation replacement and improvement projects in public school facilities. As required, these funds were allocated to school divisions based on fiscal year 2022 projected March 31 average daily membership with a minimum allocation of \$200,000 per division. The Department of Education (DOE) will pay school divisions their awarded grant funds on a reimbursement basis under this program. Localities are required to provide a match for these funds from any available fund sources equal to 100 percent of the awarded grant amount. School divisions could elect to accept a grant amount less than their formula allocation.

Through an application process conducted last fall, school divisions were required to provide DOE a description of each of the ventilation projects to be completed with these funds, including estimated costs and date of completion, and certify to DOE no later than November 15, 2021, that these funds would be used to improve ventilation systems in public facilities in

accordance with guidelines issued by the U.S. Department of the Treasury for the American Rescue Plan Act Coronavirus State and Local Fiscal Recovery Funds.

The DOE has reviewed all school division applications received by the November 15, 2021, deadline and has awarded the grant amounts for which school divisions applied and were approved. I am reporting on the grant award amount for each school division that applied for this grant, and the attached report lists the approved grant amount awarded to each division. As shown in the attachment, a total of \$218,720,808.53 was awarded to school divisions, leaving a balance of \$31,279,191.47 in the original \$250,000,000 appropriation.
