## **Executive Summary**

Effective January 1, 2021, §§ 38.2-3445 through 38.2-3445.2 of Article 6, Chapter 34 of Title 38.2 of the Code of Virginia (collectively, "Balance Billing Law") prohibits the balance billing of enrollees by out-of-network health care providers for emergency services, and by out-of-network providers of surgical or ancillary services at in-network facilities for nonemergency services, for any amount other than the enrollee's applicable health plan cost-sharing requirements.

Under the Balance Billing Law, if a health care provider disputes the amount to be paid by the health carrier<sup>1</sup> for services rendered to an enrollee, the provider and the health carrier shall make a good faith effort to reach a resolution on the amount of the reimbursement. If the health carrier and the provider do not reach a resolution, either party may initiate arbitration to determine a commercially reasonable payment amount.

The Balance Billing Law, among other things, directs the State Corporation Commission ("Commission") to establish a framework for arbitration of such disputes to include: (i) a timeline for the proceedings; (ii) a method for choosing an arbitrator; (iii) a fixed fee schedule for the costs of arbitration; (iv) required and optional factors for the arbitrator to consider; (v) non-disclosure agreements; (vi) reporting requirements; and (vii) a process for appeals based on specified criteria, including abuse of arbitration proceedings. The Commission did so, and these regulations are now located at 14VAC5-405-10 *et seq*.

The Commission is required to prepare an annual report summarizing the dispute resolution information provided by arbitrators. The Commission is to post this report on the Bureau of Insurance ("Bureau") website and submit the report to the Chairs of the House Committees on Labor and Commerce (now the Committee on Commerce and Energy) and Appropriations, and the Senate Committees on Commerce and Labor and Finance and Appropriations by July 1. This report provides a summary and information for arbitrations that were decided between June 1, 2021, and May 31, 2022 ("Reporting Period").

### During the Reporting Period:

- The Commission received 709 arbitrators' decisions.
- The 709 arbitration decisions were rendered on behalf of six provider practices.
- Eleven carriers in six groups were named in the decisions.
- Of the 709 decisions, 445 (62.8%) were decided in favor of the health carrier and 264 (37.2%) were decided in favor of the provider.
- The number of practitioners represented in the decisions ranged from one decision for 84 different practitioners to 31 decisions for one practitioner.
- Three practice specialties were represented in the decisions, with Emergency Medicine in 60.9% of the decisions, Anesthesia in 36.8%, and Plastic or Reconstructive Surgery in 2.3%.
- The average health carrier offer prior to arbitration per decision was \$362.51, the average provider offer prior to arbitration per decision was \$1,736.14, and the



average amount awarded was \$918.93.

• Medical doctors represented 81% of the rendered decisions, with certified registered nurse anesthetists representing 15.5%.

#### **Arbitration Resolution Information**

Arbitrators rendered 709 total decisions in the Reporting Period. The counts by the date the request was accepted by the Bureau of Insurance (acceptance date) are shown below:




The drop-off in the counts of accepted requests starting in November 2021 is the result of a Bureau decision to limit the number of submitted arbitrations to one request per provider practice per week. This action was taken after one or more providers began inundating the arbitration system with many requests for arbitration every week. The Bureau determined that continuing to request so many arbitrations weekly would run afoul of § 38.2-3445.05 D of the Code of Virginia, which reads, "No carrier or provider shall initiate arbitration pursuant to § 38.2-3445.02 with such frequency as to indicate a general business practice." See Administrative Letter 2021-04.



The 709 decisions were rendered for six different practice managers<sup>2</sup> as shown:




A single provider received 31 decisions, 84 different providers each received one decision:

A practice manager may be an employee within a practice or a contracted outside entity that performs administrative services for multiple provider groups.


One carrier group received 388 (55%) of the arbitration decisions. The next carrier group received 190 (27%). A third received 98 (14%).



## Overview of the Balance Billing Law

Effective January 1, 2021, §§ 38.2-3445 through 38.2-3445.2 of Article 6, Chapter 34 of Title 38.2 of the Code of Virginia prohibit the balance billing of enrollees by out-of-network health care providers for emergency services, and by out-of-network providers of surgical or ancillary services at in-network facilities for nonemergency services, for any amount other than the enrollee's applicable health plan cost-sharing requirements.

The Balance Billing Law provides, among other things, that when an enrollee receives emergency services from an out-of-network health care provider or receives nonemergency surgical or ancillary services from an out-of-network provider at an in-network facility, the enrollee is not required to pay the out-of-network provider any amount other than the applicable health plan cost-sharing requirement. Additionally, such cost-sharing requirement cannot exceed the cost-sharing requirement that would apply if the services were provided in-network.

A health carrier's required payment to the out-of-network provider for the services rendered to an enrollee shall be a commercially reasonable amount based on payments for the same or similar services provided in a similar geographic area. If, however, the provider disputes the amount to be paid by the health carrier, the provider and the health carrier are required to make a good faith effort to reach a resolution on the amount of the reimbursement. Should the health carrier and the provider not agree to a commercially reasonable payment and either party wants to take further action to resolve the dispute, the dispute will be resolved by arbitration.

The Balance Billing Law directs the Commission to establish a framework for arbitration of such disputes to include: (i) a timeline for the proceedings; (ii) a method for choosing an arbitrator; (iii) a fixed fee schedule for the costs of arbitration; (iv) required and optional factors for the arbitrator to consider; (v) non-disclosure agreements; (vi) reporting requirements; and (vii) a process for appeals based on specified criteria, including abuse of arbitration proceedings. Pursuant to Code § 38.2-3445.07, the Commission established this framework by regulations that are now located at 14VAC5-405-10 *et seq*.

The Balance Billing Law further directs the Commission to undertake additional responsibilities related to the new balance billing provisions. Pursuant to Code § 38.2-3445.03, the Commission contracted with the nonprofit data services organization known as Virginia Health Information ("VHI") to establish a data set and business protocols to provide health carriers, providers, and arbitrators with data to assist in determining commercially reasonable payments and resolving disputes. In accordance with Code § 38.2-3445.04, in consultation with health carriers, providers, and consumers, the Commission developed standard language for a notice of consumer rights regarding balance billing.

The Balance Billing Law also provides an enforcement mechanism. The Commission, the Board of Medicine, and the Commissioner of Health are authorized to levy fines and take action against a health carrier, health care practitioner, or medical care facility for a pattern of violations of the prohibition against balance billing. The Balance Billing Law also prohibits

carriers or providers from initiating arbitration with such frequency as to indicate a general business practice.

Code § 38.2-3445.06 generally exempts an entity that provides or administers self-insured or self-funded plans from Code §§ 38.2-3445 through 38.2-3445.05; however, such an entity may elect to be subject to such provisions.

The Balance Billing Law directs the Commission to prepare an annual report summarizing the dispute resolution information provided by arbitrators, including information related to the matters decided through arbitration, and information about the parties and types of services for each dispute resolved through arbitration. The Commission posts the report on the Bureau's website and submits it to the Chairs of the House Committee on Labor and Commerce (now, the Committee on Commerce and Energy) and Committee on Appropriations and the Senate Committee on Commerce and Labor and Committee on Finance and Appropriations annually by July 1. The provisions of this subsection expire on July 1, 2025.
