REPORT ON THE ACTUAL EXPENDITURES AND PERFORMANCE RESULTS ACHIEVED BY THE SOUTHERN VIRGINIA INTERNET CRIMES AGAINST CHILDREN TASK FORCE DURING THE 2021-2022 YEAR

OVERVIEW OF THE TASK FORCE

The Southern Virginia Internet Crimes Against Children Task Force, otherwise known as SOVA-ICAC, was founded in 1998 with funding from Department of Justice through the Office of Juvenile Justice Delinquency Prevention. Originally the task force name was Operation Blue Ridge Thunder. The task force designation is through the Bedford County Sheriff's Office. Initial investigative responsibilities were investigating child sexual exploitation crimes perpetrated against children through the use of the Internet, but was later changed to include most all child sexual exploitation crimes perpetrated against children to include, but not limited to, child trafficking and child prostitution.

The SOVA-ICAC is comprised of 166 affiliate agencies from all areas of Law Enforcement, the private sector and Non-Government Organizations. Law Enforcement support comes from Federal, State, County City/Local, Tribal and Military agencies. An (*) denotes an agency that joined the Task Force this past year.

The start of the fiscal year in July 2021 is when we became aware that the fee fund was not generating enough fees to cover the full amount allocated to the SOVA-ICAC Task Force, as provided for in the annual budget, and which had been the figures we were budgeting our operations and salary needs from. This shortfall was magnified due to the statewide pandemic lockdowns, which resulted in closed courts; reduced pro-active policing and arrests due to attempts mitigate officer exposure to Covid; and reduced fees due to reduced arrests from changes the General Assembly made removing various traffic offenses and decriminalizing certain acts, which also reduced arrests being made with resulting reduction in fees collected from convictions and guilty pleas. The General Assembly, as part of the budget passed in 2022, provided supplementary funding from the general fund for the fiscal year ending June 2022, to help cover the shortage in funding. Other savings in this area were realized by not filling open positions, due to salary costs. Overages in Equipment expenditures were offset by vacancy savings in the Personnel category.

PERSONNEL

Funding in the Personnel category was allocated to pay salaries and benefits of core SOVA-ICAC personnel. Core SOVA-ICAC personnel operate out of the SOVA-ICAC office in Forest, Virginia, located within the confines of Bedford County, Virginia. ICAC personnel are employed by the Bedford County Sheriff's Office, or affiliates who have assigned investigators to work full-time out of the SOVA-ICAC main office. The staff is comprised of a Task Force Commander, a Lieutenant, Sergeants, Analysts, a Cyber Tip Manager, Investigators, and a LAN Manager. The investigative team is composed of two units, criminal investigations and forensic examiners. In the investigations unit, there is currently one sergeant, and five investigators, one being a K9 handler. We have one open investigator position reserved for affiliate agencies to assign an investigator to the main SOVA ICAC HQ office (with funding for this position allocated out of affiliate funding). In the forensic examiner unit, there is currently one sergeant, and four forensic investigators. To date, we still have bene unable to hire a LAN Manager. Also, our Cybertip Manager and Analyst positions remain unfilled, as does one criminal investigator position, and the Lieutenant and Sergeant positions.

EQUIPMENT

Funding in the equipment category is used to purchase equipment used solely by ICAC personnel to investigate child sexual exploitation cases and prevent and or educate on child sexual exploitation to include the following:

Funding for affiliates was used for the purpose of Personnel (\$125,937.89), Travel/Training (\$95,881.40) and Equipment (\$63,474.43) expenditures.

PERSONNEL

Funds were allocated to reimburse for time worked by SOVA-ICAC affiliates. The 166 affiliated agencies with SOVA-ICAC employ these staff members, and funds are used to reimburse them for overtime work performed for ICAC investigations. Funding for one affiliate position for full-time assignment to the SOVA-ICAC main task force office comes out of this funding as well. This position is currently filled by an investigator from the Campbell County Sheriff's Office. In addition, funding for the salary of financial analyst who supports and manages all funding for the entire task force is also supported with affiliate funding.

TRAVEL/TRAINING

Funding in the travel category is used to train and educate the members of our 166 affiliates, and equip them to continue their investigations to locate those individuals who prey upon and exploit our children and secure the evidence needed to bring them to trial. In person trainings began to be held again, so we were able to start sending affiliates to in person training. Training consisted of the following:

A few cases of interest during this reporting period include the following:

New Kent, VA:

In February 2022, Jose Joan Martinez Marmolejo was arrested for multiple offenses involving the sexual exploitation of an 11 year old female. The victim had been reported missing by her parents earlier that day, and social media posts indicated she may be in the company of an unidentified adult male. Using cell phone pings, along with a tracking K9 and a scent article of the victim, they located her in a motel room. Marmolejo admitted to meeting the victim on Instagram and had communicated online for about a month. He had paid her for sexually explicit images and videos of herself. He then admitted totraveling from North Carolina to New Kent to meet the victim, and subsequently admitted that they had had sex multiple times that day, and had also filmed the sexual activity between them, and then forwarded the videos to the victim's phone.

Virginia Beach, VA

In March 2022, detectives with the VA Beach Police Department arrested Dylan Seader as part of an online undercover investigation. Seader drove to Virginia Beach to meet what he believed was a minor, for sex. This case referred and adopted for federal prosecution for solicitation and traveling to meet a minor for sex, and for production of child pornography. During forensic exam of seized devices, they located child pornography on his phone, including child pornography involving bestiality. He also possessed videos of himself raping his then 18 month old niece.

Powhatan and Cumberland Counties, VA:

In March 2022, Joseph Richard Nowak III, was arrested as part of a joint investigation by the Powhatan and Cumberland County Sheriff's Offices. As a result of the investigation, Nowak was charged with contributing to the delinquency of a minor in Powhatan, and with possession of child pornography in Cumberland County. During the investigation, his phone was seized in Cumberland County, where the child pornography was later found. Nowak was an elementary school teacher in Cumberland County.

Richmond, VA:

In May 2022, Richmond Police Department arrested Matiko Pierce on charges of aggravated sexual battery and producing child pornography. Charges were related to his work as a teacher at a local child care center.

Newport News, VA:

In June, 2022, The FBI arrested Michael Covey of Newport News on charges related to 18 USC 2251(a) in relation to sexual exploitation of children. Covey was a police officer with Newport News PD at the time of his arrest.

This case started in Ohio, with the arrest of a suspect there. During review by the FBI, that suspect had files that had geolocation data putting the creation of those files in Newport News, VA. The Southern Virginia ICAC received a request from the National Center for Missing and Exploited Children for assistance in trying to locate and identify the victim in the files. The case was then forwarded to the Newport News Police Department and the FBI who handle cases in that area. The FBI was able to identify both the victim and a suspect, who was ultimately arrested. Since then, the FBI has identified a second child that was victimized by Covey. Trial is scheduled for October 2022.

New Kent, VA:

In June 2022, Cristopher Paul Perry was arrested by the New Kent County Sheriff's Office, on charges related to possessing child pornography. This investigation was initiated by a Cybertip from an online cloud storage company, that reported a user had been storing known or suspected child pornography through their service. During the investigation, the New Kent County Sheriff's Office was made aware of an additional investigation being conducted by VA State Police out of Harrisonburg, VA, investigating an online solicitation investigation. It was determined through additional evidence that Perry was also the suspect I that investigation. Additional charges for those offenses are pending in Harrisonburg.

Patrick County, VA:

In April 2022, Patrick County Sheriff's Office investigators arrested Erich Alwine as part of a child pornography investigation that began as a Cybertip. It was discovered that Alwine was wanted out of North Carolina for the rape of a 14 year old victim.

Isle of Wight, VA:

In November 2021, investigators with the Isle of Wight Sheriff's Office arrested Hunter Reseigne, 22, of Norfolk, for distribution of child pornography. During an undercover investigation, an investigator received child pornography from a subject later identified as Reseigne.

Investigators determined Reseigne was an active-duty member of the US Navy. They coordinated with the Naval Criminal Investigative Service in making the arrest.

Reseigne was held without bond.

Hanover County, VA:

On December 13, 2021, Hanover County Sheriff's Office Investigators executed a search warrant, and subsequently arrested Derek lee Short, 47, of Mechanicsville, for charges related to possession of child pornography. Short is currently a registered sex offender, convicted in 2019 of production of child pornography. The 2019 case was the result of a Cybertip from the National Center for Missing and exploted Children.

Hanover County, VA:

In October 2021, Hanover Sheriff's Office Investigators arrested Robert Whittemore of Mechanicsville, VA, for possession of child pornography, and indecent liberties with a minor female, that was personally known to him. At the time of his arrest, Whittemore was a high level IT Specialist with the Virginia Department of Corrections.

Suffolk, VA:

In December 2021, Jordan Willoughby, 29, was arrested for production of child pornography and online enticement of a minor. Willoughby had been using platforms such as Kik and Snapchat to communicate with underage females, while posing as a 15-year-old boy. He used images of a local 19-year-old male to send to the underage females he was communicating with online. One reported conversation through Snapchat, involved an alleged 13-year-old female that Willoughby paid via CashApp, for images of herself.

Charlottesville, VA / Albemarle County, VA:

In July 2021, Dr. David Lapides, 37, of Charlottesville was arrested on charges related to possession of child pornography. Lapides was a neurologist with the University of Virginia. This was a Cybertip case from the National Center for Missing and Exploited Children, and was worked by Albemarle County Police Department, who then assisted the Charlottesville Police Department in completing the investigation. Lapides pled guilty to two counts of possession of child pornography, and will be sentenced in May, 2022.
