The Virginia Workers' Compensation Commission (VWC) was established in 1918. The Commission is an independent judicial and administrative state agency that oversees the workers' compensation system for the Commonwealth. The Commission is headed by three Commissioners who are chosen by the General Assembly and serve six-year terms. Honorable R. Ferrell Newman, Honorable Wesley G. Marshall and Honorable Robert A. Rapaport are the current Commissioners, with Rapaport serving as Chairman. Ms. Evelyn McGill is the Executive Director and Honorable James J. Szablewicz is the Chief Deputy Commissioner.

ABOUT VIRGINIA VICTIMS FUND

the Commonwealth's responsibility to provide financial assistance to victims of crime, the Criminal Injuries Compensation Fund, working as the Virginia Victims Fund (the Fund), was established by the Virginia General Assembly in 1977, to pay unreimbursed expenses of innocent victims of crime who suffered physical or emotional injury or death (§ 19.2-368.1, Code of Virginia). The Fund is administered by the Virginia Workers' Compensation Commission.

For 45 years, the Fund has assisted victims of crime and their families by easing the financial burden that crime often creates, providing relief in the form of reimbursement for medical expenses, lost wages, funeral expenses. relocation, counseling and other expenditures incurred as a result of the crime. Since transitioning to its current claims system, the Fund has processed over 80,000 claims.

The Fund is resourced by fines and fees, assessments on offenders and restitution. The monies awarded to victims of crime in conjunction with compensation claims are not funded through state tax dollars. Additionally, the Fund receives federal grant funds from the Victims of Crime Act (VOCA). VOCA funds are generated by court fines at the federal level.







WHO CAN FILE A CLAIM

VIRGINIA VICTIMS FUND

In order for a crime victim to meet the Fund's eligibility requirements for compensation, the following must be met:

- The crime must occur in Virginia or against a Virginia resident in a state, country or territory that does not have compensation program;
- The crime must be reported to law enforcement within 120 hours, unless good cause for the delay can be shown;
- A claim must be filed with the Fund within one year of the occurrence of the crime, unless good cause exists for not doing so;
- A claim must be a minimum value of \$100;
- The victim must fully cooperate with law enforcement and must not be criminally responsible for the crime upon which the claim is based, or be an accomplice or accessory to the crime.



SEXUAL ASSAULT FORENSIC EXAM (SAFE)

About Safe


The SAFE Payment Program offers evidence collection at no cost to victims of rape or sexual assault. Healthcare providers bill the SAFE Payment Program directly.

Evidence is collected through a Physical Evidence Recovery Kit (PERK) and does not require the filing of a police report if the PERK is completed within 120 hours of the incident. The SAFE Payment Program receives General Fund monies via dollars designated to the Supreme Court of Virginia to reimburse for sexual assault evidence collection expenses.

Total paid by SAFE for forensic evidence collection and associated expenses






Perk Reimbursement Rate Increase for FY22

Sustainable Funding for SAFE

The Fund has worked for the past two years to demonstrate the need and substantiate the request for additional funds to increase reimbursement rates to providers of PERK exams.

These efforts, along with contributions from the field of forensic nursing, resulted in an increase of the program's appropriation amount from nearly \$1.8 million to approximately \$6.6 million. The funding increase includes language that allows the Fund to reimburse providers of acute exams at 60% of their billed costs, as well as expand existing forensic nursing programs and develop new ones in under-served communities.

The Fund looks forward to partnering with forensic nurse providers to expand and increase access to exams, building a safer and healthier future.



UNCLAIMED RESTITUTION

The Virginia Victims Fund receives from the Courts of the Commonwealth of Virginia, any restitution that has been designated as unclaimed for more than one year pursuant to the Code of Virginia § 19.2-305.1.

To enhance unclaimed restitution efforts, the Fund has added two (2) additional Unclaimed Restitution Specialists, one (1) Client Services Specialist and has implemented a technology-focused approach in order to maximize resources available to victims of crimes and external stakeholders.

Victim Compensation Assessment Grant

The Fund is nearing the completion of Phase I of the Compensation Assessment Project. This three-year competitive grant partners VVF with experienced consultants from ICF, LLC. to closely examine compensation in Virginia. The analysis will not only identify and address service gaps, but also assess policies, legislation impact and inter-agency collaboration.

The project will culminate with implementation of enhancements to the compensation program and furthering access to victims of crime. This project will position Virginia's Fund as a model compensation program in the U.S.
