

Retired Recall Judge Workgroup

Item 1, Paragraph Z, of the 2021 Appropriation Act (Chapter 552, 2021 Reconvened Special Session I) requires the Chair of the Senate Committee on the Judiciary to "convene a workgroup to review the process by which non-elected judges, including retired judges, are utilized by the Circuit Courts to make legally binding decisions. The workgroup shall include in its review the frequency of such use of non-elected judges, any issues that arise from the use of non-elected judges, and the process by which non-elected judges are evaluated. The workgroup shall prepare and deliver a report for review by the Senate Committee on the Judiciary by the first day of the 2022 Regular General Assembly Session."

The Retired Recall Judge Workgroup (the Workgroup) met electronically on Wednesday, December 15, 2021, with Senator J. Chapman Petersen, designated by Senator John S. Edwards as chair, presiding. Senator Edwards, Senator Richard H. Stuart, and Senator Scott A. Surovell were present. Following opening remarks, the Workgroup reviewed and discussed the report titled "Annual Report on the Evaluation of the Number and Types of Circuit Court Cases that are Overseen by/Referred to Retired Judges" and prepared by the Office of the Executive Secretary of the Supreme Court of Virginia (OES). Item 39, Paragraph P, of the 2021 Appropriation Act (Chapter 552, 2021 Reconvened Special Session I) requires OES to "prepare and distribute evaluation forms in all Circuit Court cases that are overseen by a retired judge for the purpose of collecting information on the number and types of cases referred to retired judges, and use such information to prepare and annually publish a report to be distributed to the members of the House Committee on Courts of Justice and the Senate Committee on the Judiciary, on or about January 1, each year."

Mr. Macon participated in the Workgroup as a representative of OES, explained the evaluation process and report findings, and answered questions regarding the report.

- Evaluation Process:
- 1. OES prepared an evaluation form for all active retired circuit court judges sitting in recall using the SurveyMonkey online tool and sent the link to all active members of the Virginia State Bar.
- 2. Lawyers who had appeared before or observed a listed retired judge were asked to complete the anonymous form and only evaluate once each judge they had appeared before based on personal experience.
- 3. The survey was open from October 1, 2021, to October 31, 2021, at 11:59 pm, and evaluated retired judges over an 18-month period based on the frequency of various

- attributes observed, including respect, timeliness, attentiveness, knowledgeability, and communication.
- 4. Attorneys who completed the survey indicated what type of case they appeared on or observed before each retired judge (criminal or civil) and the number of times they had appeared before each judge during the evaluation period. If they appeared in a civil matter, attorneys also selected the category of civil case (domestic relations, tort, contract, or other civil).

The evaluation process included 104 retired circuit court recall judges. During the 18-month period, retired circuit court judges served for 5,035.5 days. The survey garnered responses from 2,154 attorneys, 133 of whom had each appeared before or observed a particular judge over 10 times. Criminal cases accounted for 45.5% of the cases in which survey respondents appeared before or observed a retired judge, and 54.5% of the cases were civil in nature. In about 15% of responses, respondents indicated that retired judges "rarely/never" or "about half the time" exhibited fairness, patience, and knowledge of the law. Respondents selected "frequently/always" for 83%-93% of responses across all evaluation questions. Responses indicate that retired circuit court judges serving in recall generally convene court with undue delay, are prompt in rendering clear decisions, and use courtroom time efficiently.

Mr. Macon advised the Workgroup that retired circuit court judges are sitting in recall more frequently to assist courts facing backlogs in cases due to the COVID-19 pandemic. The frequency at which retired circuit court judges sit in recall varies widely from judge to judge and, as a result, some judges included in the report received zero or few evaluations, while others had a large number of responses in comparison.

Recommendations to the Senate Committee on the Judiciary

The Workgroup recommended expanding the authority of the Senate Committee on the Judiciary and House Committee for Courts of Justice to include certification of retired general district and juvenile and domestic relations district court judges in addition to circuit court judges. Further, the Workgroup recommended that retired circuit and district court judges subject to recall be evaluated every three years using an evaluation form prepared and distributed by OES. Finally, the Workgroup recommended that, following receipt of the evaluations and prior to certification of retired circuit and district court judges, members of the Senate Committee on the Judiciary and House Committee for Courts of Justice be permitted to remove the name of any retired judge from the block. Judges removed from the block should be invited to speak before the Senate Committee on the Judiciary and House Committee for Courts of Justice, they said, and these hearings would be open to the public and may include public testimony.

Item 39, Paragraph P, of the 2021 Appropriation Act, Chapter 552, 2021 Reconvened Special Session I, requires the Office of the Executive Secretary (OES) to "prepare and distribute evaluation forms in all circuit court cases that are overseen by a retired judge for the purpose of collecting information on the number and types of cases referred to retired judges and use such information to prepare and annually publish a report to be distributed to the members of the House Committee on Courts of Justice and the Senate Committee on the Judiciary, on or about January 1, each year."

On October 1, 2021, OES sent a survey for the purpose of evaluating retired recalled judges to all active members of the Virginia State Bar using the Survey Monkey online survey tool. Eligible members were asked to complete the anonymous 5-minute survey using the link to the Survey Monkey evaluation tool. Those lawyers who were ineligible (i.e., had not appeared before a listed retired judge) were instructed to disregard the survey. The survey closed on October 31, 2021, at 11:59pm. The survey measured the frequency (i.e., rarely/never, about half the time, etc.) of various attributes of retired judges observed over an eighteen-month period, including timeliness, respect, attentiveness, communication, and knowledgeability. Upon completion of the survey, lawyers certified that they had not completed more than one survey response for a particular judge and that the responses were based on their personal experience with the judge. Also included on the survey was a question asking the case type(s) in which the attorney appeared before or observed the retired judge. This process was not part of the Judicial Performance Evaluation (JPE) Program, which is established in Virginia Code § 17.1-100 and the Rules of the Supreme Court of Virginia.

There were 2,154 respondents to the survey, 133 of whom had appeared before or observed a particular judge more than 10 times. Overall, "frequently/always" was entered for 83% - 93% of responses across all the evaluation questions. The results indicate circuit court judges are generally convening court without undue delay, using courtroom time efficiently, and are prompt in rendering clear decisions frequently or always. In the areas of patience, knowledge of law, and fairness, retired judges were assessed as exhibiting these characteristics "rarely/never" and "about half the time" for about 15% of the responses. Individual survey results for each retired judge for whom OES received one or more survey responses are attached in alphabetical order by last name.

Based upon the survey responses, 54.5% of the cases in which survey respondents appeared before or observed the retired judges were civil in nature. Civil case types included on the survey were domestic relations, tort, contract, and other civil. Criminal case type was a standalone selection and accounted for 45.5% of the cases in which the survey respondents appeared before or observed the retired judges. Retired judges served for 5,035.5 days over the 18-month survey period.
