Other Highlights

This month I was glad to participate in the Commonwealth's revenue forecast process, attending both the Joint Advisory Board of Economists and the Governor's Advisory Council on Revenue Estimates meetings. Lottery profits and transfers to the Lottery Proceeds Fund provide about 10% of the funding for K-12 public education, and we constantly ensure that our profits are maximized while also maintaining a focus on responsible gaming, the integrity of our games, and efficient operations.
