RE: Report on Small to Mid-Size Existing Virginia Businesses Supported with International Trade Funding

Dear Chairs:

As required by Item 125 M.2 of Chapter 2 of the 2022 Acts of Assembly (the Budget), I am writing to provide an update on the small to mid-size existing Virginia businesses that have been supported with increased funding for VEDP's International Trade programs.

The Budget outlined that the initiatives funded through the increase for VEDP's International Trade programs needed to support an additional 55 small to mid-size existing Virginia businesses. As of December 31, 2022, VEDP had supported a total of 70 additional small to mid-size businesses with this funding. A list of the businesses supported by each initiative is provided below.
