Dear Secretary Mosier, Senator Howell, and Delegate Knight:

Chapter 2, Item 400 D. of the 2022 Amendments to the 2021 Appropriation Act states “The State Board of Local and Regional Jails shall include within its reporting formats on the capacity of each local and regional jail, a measure of the actual jail capacity, which shall include double-bunking, with exceptions as appropriate, in the judgment of the Board, for isolation, segregation, or medical cells, or similar units which would not normally be double-bunked. Exceptions to this measure of capacity may also be made for jails which were constructed prior to 1980. A report including the double-bunking capacity, as well as the standard State Board of Local and Regional Jails measure

of rated capacity, for each jail shall be presented to the Secretary of Public Safety and the Chairs of the Senate Finance and Appropriations and House Appropriations Committees by October 1 of each year.”

The summary report of the actual capacity of the local and regional jails in Virginia is attached. The annualized Average Daily Population (ADP) was pulled directly from the State Compensation Board's LIDS database. A few operational changes in local or regional jails impacted the annual ADP for those particular facilities.

Blue Ridge Regional Jail Authority is currently undergoing maintenance refurbishment of their Bedford and Campbell facilities. Inmates from these two jails were moved to Halifax and Amherst Adult Detention Center in February 2022.


Henry County Jail completed construction of their new, 400-bed facility in late spring 2022. The rated capacity in this report reflects the old, 67 bed facility. The new rated capacity will be reflected in the FY 2023 Jail Capacity Report.

Meherrin River Jail has temporarily closed their Mecklenburg facility. No reopening date has been made available at the time of publication of this report.
