

# Virginia Sexual Assault Forensic Examiner Coordination Program

# **ANNUAL REPORT**

October 2022



During the 2020 Session of the Virginia General Assembly, policymakers enacted Chapters 274 and 276, establishing the Sexual Assault Forensic Examiner Coordination Program at the Virginia Department of Criminal Justice Services (DCJS), effective July 1, 2020. The goals of the program, as outlined in § 9.1-191 of the *Code of Virginia*, include developing and enhancing sexual assault forensic examiner programs across Virginia, establishing a partnership group to plan forensic nurse training, assisting with developing protocols and guidelines for the treatment of victims of sexual assault, and collecting and maintaining information on all available sexual assault forensic services in Virginia. The Sexual Assault Forensic Services Coordinator (Coordinator) at DCJS leads this program.

§ 9.1-191 of the *Code of Virginia* also requires that the "Coordinator shall report annually on or before October 1 to the Governor and the General Assembly. The report shall include a summary of activities for the year and any recommendations to address sexual assault exams within the Commonwealth, including budget needs to increase the availability of sexual assault exam services across the Commonwealth."

The Coordinator has ten responsibilities outlined in the *Code of Virginia*. Current activities related to each responsibility are described below.

- 1. Create and coordinate an annual statewide sexual assault forensic nurse examiner training program in partnership with the Attorney General, the Virginia Department of Health, the Virginia Hospital and Healthcare Association, the Victim Compensation Fund, the International Association of Forensic Nurses, and the Secretary of Health and Human Services.
  - In 2021, the Coordinator convened a committee with the enumerated agencies. The committee met several times in 2021 and 2022 and decided to offer a clinical skills lab training to Virginia forensic nurses. Currently, committee members are meeting with various nursing schools in the Central Virginia region to secure a location for the first training. This will be the first clinical skills lab offered to forensic nurses in Virginia.
- Coordinate the development and enhancement of sexual assault forensic examiner programs across the Commonwealth that include prevention of secondary trauma to survivors and culturally sensitive training for health professionals.
  - Beginning in 2021, the Coordinator met individually with representatives from Forensic Nurse Examiner (FNE) programs in every region of the Commonwealth. In an effort to maintain ongoing communication with the programs, the Coordinator implemented a monthly email communication, which is distributed to all of the programs' coordinators, as well as the president of the Virginia Chapter of the International Association of Forensic Nurses.

The coordinator for Centra Health's FNE program in Lynchburg is actively working towards an opening at Centra Southside Community Hospital in Farmville, which currently does not have forensic nursing services. She has expressed difficulty in obtaining nurses for that hospital.

In addition, the Lewis Gale Alleghany Hospital in Covington is interested in rejuvenating their forensic nursing program; however, obtaining skilled staff and sustainability are concerns for this program.

Additional resources are needed for the Virginia Sexual Assault Forensic Examiner Coordination Program to be able to provide a part-time forensic nurse, who is or can be trained to be a facilitator of the 40-hour International Association of Forensic Nurses didactic course for both adults (SANE-A) and pediatrics (SANE-P). This staff person would be available to travel and offer this course to nurses around the state,

as well as be available to answer technical questions. A part-time (29 hours per week) wage position for this purpose and with the necessary qualifications would require approximately \$70,000 in additional funding each year.

- 3. Participate in the development of hospital protocols and guidelines for treatment of survivors of sexual assault in partnership with the Department of Health.
  - The Coordinator is in communication with staff from the Virginia Department of Health (VDH) and attends the meetings of the Task Force on Services for Survivors of Sexual Assault, coordinated by VDH. The Coordinator is also attending meetings of the recently formed Workgroup on Hospital Services for Survivors of Domestic Violence and Sexual Assault, which is working to develop and implement policies and procedures to routinely screen patients to determine if they are victims of domestic violence or sexual assault; document injuries; make appropriate referrals to victims; and train hospital staff.
- 4. Coordinate and strengthen communications among sexual assault nurse examiner medical directors, sexual assault response teams, and hospitals for existing and developing sexual assault nurse examiner programs.
  - in 2021 and 2022, the Coordinator met with hospital administrators and department managers across the state. The Coordinator is collaborating with DCJS staff working with Sexual Assault Response Teams (SARTs) throughout Virginia.
- 5. Provide technical assistance for existing and developing sexual assault forensic examiner programs, including local sexual assault forensic examiner training programs.
  - There are large areas of the state, particularly in Southwest Virginia, where there are few forensic nurses, especially in places like Alleghany, Smyth, and Washington Counties. The Coordinator is hearing from service providers in that region that there are no pediatric forensic nurses to attend to child victims of sexual assault or abuse. At times, families have to travel 1.5 to 2 hours to see a pediatric forensic nurse.
  - The Coordinator is also exploring existing telehealth programs outside the state and pilot programs inside the state, and has planned a visit to Riverside Hospital where such a program is being piloted. This pilot project is supported with DCJS Victims of Crime Act (VOCA) grant funds.
- 6. Create and maintain a statewide list, updated biannually, to include the following:
  - a. A list of available sexual assault forensic examiners, sexual assault nurse examiners, sexual assault forensic nurse examiners, and pediatric sexual assault nurse examiners;
  - b. The location and facility affiliation of each examiner;
  - c. The duty hours for each examiner and affiliated facility for sexual assault exam services; and
  - d. The location of available local sexual assault forensic examiner training programs.

The Coordinator, in collaboration with the DCJS Criminal Justice Research Center, developed a survey for forensic nursing programs that was first distributed in December 2021. A second survey went out in July 2022. Going forward, the full version of this survey will be distributed annually, with a second structured solicitation of any necessary changes or additions in order to fulfill the statutory requirement of biannual updates. From the data collected, the Coordinator has developed a map directory of all the programs in the state, as well as a text version of the directory (see attached for directory).

There are 20 sexual assault forensic nursing programs in Virginia. Eighteen of the 20 programs are hospital-based and two are stand-alone/mobile programs. Three programs serve pediatric patients exclusively, and four programs serve adults exclusively. Thirteen programs serve both adults and pediatric patients.

Nurses from Ballad Health, which is based out of Tennessee and has hospitals in both Tennessee and Virginia, travel to some Virginia hospitals and clinics in the Southwest region to perform forensic exams. However, Virginia law enforcement is unable to serve subpoenas over state lines. This is problematic because forensic nurses are often important expert witnesses needed to testify during trial.

The remaining four statutory responsibilities are listed below. Activities for these responsibilities will begin as continued progress is made on responsibilities one through six.

- 7. Coordinate, share, and disseminate the list created pursuant to subdivision 6 to the emergency operations communications system available to emergency medical services and law-enforcement agencies as well as the internal emergency and hospital communications system.
  - The Coordinator is preparing to send the directory to the entities as specified.
- 8. Share and disseminate the list created pursuant to subdivision 6 with all other relevant agencies, including law-enforcement agencies, attorneys for the Commonwealth, victim-witness programs, sexual assault service organizations, the Department of Juvenile Justice, the Department of Social Services, the Department of Education, and school divisions.
  - The Coordinator is developing a Virginia Forensic Examiner Coordination Program web page, within the Victims Services web pages, which will feature both the map directory and the text version of the directory, and will be updated biannually. The link for the web page will be distributed to the enumerated departments and agencies.
- 9. Create sexual assault nurse examiner recruitment materials for universities and colleges with nursing programs in partnership with the State Council of Higher Education for Virginia.
  - In 2022, the Coordinator met with the Forensic Nurse Coordinators from South Carolina to discuss the curriculum that they use in nursing schools and is looking at that curriculum, as well as curricula from other states, as models for Virginia. In addition, the Coordinator has reached out to the University of Virginia School of Nursing to start the process for obtaining a nurse intern in fall of 2022 or spring of 2023 to help with this project. The Coordinator has spoken to Piedmont Community College School of Nursing and offered to speak with their nursing students about forensic nursing in Virginia.
- 10. Support and coordinate community education and public outreach, when appropriate, relating to sexual assault nurse examiner issues for the Commonwealth.
  - The Coordinator collaborated with a Richmond-based FNE on a presentation to the full Task Force on Services for Survivors of Sexual Assault regarding the gaps in forensic nursing services in Virginia. In September 2022, the Coordinator presented to the International Association of Forensic Nurses Statewide Coordinators monthly meeting on the Virginia Sexual Assault Forensic Examiner Program. Additionally, the Coordinator has held meetings with service providers in the Southwest Region regarding the lack of forensic nursing services, especially for abused children, in that region.

# Addendum: Feasibility of Establishing Centers of Excellence for SAFE Services

The *Code of Virginia* also requires (via Chapter 276 Enactment Clause 2, Regular Session, 2020) that DCJS explore and report on the feasibility of establishing centers of excellence as a model to increase the availability of sexual assault exam services in Virginia. Based on the Coordinator's research to date, establishing a center of excellence for FNE services is feasible in Virginia.

The Coordinator consulted with Bon Secours Richmond on the Bon Secours Forensic Nursing Services "Program Tiers" (see full Program Tiers list attached). Bon Secours listed the following services<sup>1</sup> needed for programs to meet "Tier 1," which is the highest standard:

- Full Service Forensic Program provides forensic exams for violence across the lifespan, such as adult sexual and physical violence, domestic/interpersonal violence, child maltreatment (sexual and physical abuse), elder abuse, human trafficking, strangulation, workplace violence, and suspect exams. Pediatric forensic services require specially educated and clinically prepared staff to care for these complex patient situations. A coordinated, multidisciplinary approach to address the needs of the child and the family is paramount.
- 2. Sexually transmitted infection (STI) prophylaxis, testing and treatment based on Centers for Disease Control and Prevention (CDC) and national guidelines.
- 3. Advocacy services and referrals (partners with community resources for victims of violence).
- 4. Offers acute and scheduled exams.
- 5. Conducts forensic follow-up exams.
- 6. 24/7 forensic nursing coverage (FNE on site).
- 7. Forensic nurse program manager/coordinator.
- 8. Forensic department assigned cost center.
- 9. Forensic billing services managed by program.
- 10. Nurse completed adults/pediatrics trainings (40-hour courses with clinical components) successfully completed an adult/adolescent sexual assault nurse examiner education program that grants a minimum of 40 hours of continuing nursing education contact hours from an accredited provider (International Association of Forensic Nurses, 2021) <a href="https://www.forensicnurses.org/page/ApprovedSANECourse">www.forensicnurses.org/page/ApprovedSANECourse</a>.
- 11. SANE-A, SANE-P certifications offered by the International Association of Forensic Nurses through the Commission for Forensic Nursing Certification (CFNC). 75% of eligible staff certified as SANE-A and SANE-P.
- 12. Quality Assurance process completed on 100% of the charts.
- 13. Annual competency review department specific annual competences completed.

Bon Secours is currently the only forensic nursing program in the state that provides all of the above "Tier 1" services.

The Coordinator consulted with the South Carolina program coordinators to learn about their newly launched Sexual Assault Forensic Excellence (SAFE) program, in which hospitals and community agencies

meet a set of criteria, including training provided by the program coordinators, in order to earn a "SAFE" designation. The SAFE program in South Carolina came out of their Forensic Nursing Task Force (http://www.scvan.org/safe-designation).

#### **Recommendations**

The Coordinator recommends that a Forensic Nursing Task Force (FNTF) be formed in order to create a tier system by which forensic nursing programs and hospitals can voluntarily apply to be assessed within the tier system, and designated a Virginia Center of Forensic Nursing Excellence. The tier system will outline what the Virginia Sexual Assault Forensic Examiner Coordination Program has identified as best practices for forensic nursing programs, and incentivize hospitals and programs to increase services.

To create opportunities for hospitals to build forensic nursing programs and nurses who are interested in training to become forensic examiners, the Coordinator recommends expanding the Virginia Sexual Assault Forensic Examiner Coordination Program to include a part-time or full-time forensic nurse who is trained and available to offer the 40-hour International Association of Forensic Nurses didactic curriculum to any interested nurse or doctor in the Commonwealth. The nurse would also offer training to other healthcare providers on how to identify and treat a sexual assault victim when a FNE is not available.

The Coordinator would also work on developing a training for hospital staff on trauma, trauma-informed care, forensic nursing care, and the treatment of sexual assault survivors.
