EXECUTIVE SUMMARY

Chapters 765 and 796 of the 2023 Acts of Assembly established the Foreign Entities and Property Ownership Law (Va. Code § 55.1-507 et seq.) (Law), which, in part, requires the Virginia Department of Agriculture and Consumer Services (VDACS), on or before July 1 of each year, to publish a report on certain reporting requirements on VDACS's website and to deliver copies of such report to the Governor, the General Assembly, and the Chairmen of the Senate Committee on Agriculture, Conservation and Natural Resources and the House Committee on Agriculture, Chesapeake and Natural Resources.

Based on the reports submitted to VDACS pursuant to the federal Agricultural Foreign Investment Disclosure Act, 7 U.S.C. § 3501 et seq., and other information VDACS, at its discretion, deems appropriate, VDACS is required to compile an annual report in consultation with the appropriate state agencies and boards for each calendar year containing all of the following, if available:

1. The total amount of agricultural land that is under foreign ownership;
2. The percentage change in foreign ownership of agricultural land in the Commonwealth for each year over the prior 10 years;
3. The purpose for which foreign-owned agricultural land in the Commonwealth is being used currently. To the extent such information is available, the Department shall also include any significant recent changes or trends in the uses of foreign-owned agricultural land in the Commonwealth;
4. With the assistance of relevant state agencies, information regarding the extent of, and any recent changes in, foreign ownership of energy production, storage, or distribution facilities in the Commonwealth to the extent such information is available; and
5. Any legislative, regulatory, or administrative policy changes the Department recommends in light of the information in this report.

Virginia has 560 parcels in foreign ownership as of December 31, 2021, in 81 unique localities. Forty-five different countries are identified as the nationality of the foreign interest with the highest concentration being from Canada (57), France (95), Germany (83), and the United Kingdom (62).

VDACS is not aware of any information regarding the extent of and any recent changes in foreign ownership of energy production, storage, or distribution facilities in the Commonwealth.

VDACS does not recommend any legislative, regulatory, or administrative policy changes in light of the information in this report.

REPORTING

Background and definitions

The U.S. Department of Agriculture (USDA) disseminates an annual report on foreign holdings of U.S. agricultural land as required in the Agricultural Foreign Investment Disclosure Act of 1978 (AFIDA). AFIDA requires any foreign person who acquires or transfers an interest in agricultural land to report the transaction to the Secretary of Agriculture within 90 days. AFIDA also requires reporting on land that either becomes or ceases to be agricultural land or if the ownership entity becomes or ceases to be a foreign person. Failure to comply with AFIDA will subject the foreign person or other entities disclosed on the report to a civil penalty of up to 25 percent of the fair market value of the interest held in the land in question. Nationally, approximately 40 million acres of U.S. agricultural land is held by foreign individuals or entities.

For the purposes of the AFIDA report, “agricultural land” means land in the U.S. used for forestry production and land in the U.S. currently used for, or, if currently idle, land last used within the past five years, for farming, ranching, or timber production, except land not exceeding 10 acres in the aggregate, if the annual gross receipts from the sale of the farm, ranch, or timber products produced thereon do not exceed \$1,000. Farming, ranching, or timber production includes, but is not limited to, activities set forth in the Standard Industrial Classification Manual (1987), Division A, exclusive of industry numbers 0711–0783, 0851, and 0912–0919, which cover animal trapping, game management, hunting carried on as a business enterprise, trapping carried on as a business enterprise, and wildlife management. Land used for forestry production means land exceeding 10 acres in which 10 percent is stocked by trees of any size, including land that formerly had such tree cover and that will be naturally or artificially regenerated¹.

According to the USDA Farm Services Agency *Foreign Holdings of U.S. Agricultural Land – through December 31, 2021*, the information required to be reported consists of the legal name and address of the foreign person; country of government or citizenship, if an individual; if not an individual or a government, nature of the legal entity, including the entity's country of creation and principal place of business; type of interest; legal description; acreage; land use; purchase price or any other consideration given; intended use; information about the representative of the foreign person; if applicable, how the interest in the land was transferred; the relationship of the owner to the operator; type of rental agreement, if any; and the date of transaction. In the case of a disposition, the party disposing of the interest is also required to give the legal name and address of the purchaser. Any change in the legal name or address of the foreign person and other entities disclosed on the report form must also be reported within 90 days of such changes.

Acreage in foreign ownership and percentage increase over a 10-year period

According to the USDA Farm Services Agency *Foreign Holdings of U.S. Agricultural Land – through December 31, 2021*, the total land area of Virginia is 25,340,160 acres, of which USDA considers 20,577,489 acres to be privately-held agricultural land. The following chart² shows the total acreage of foreign-held agricultural land, the proportion of Virginia’s foreign-held to privately-held agricultural land, and the percentage increase from the previous year.

The most significant trend in this data is the increase in cropland and forest land. While the other categories have remained relatively consistent, cropland in Virginia held by foreign investors has increased 46 percent since 2019 and forest land in Virginia held by foreign investors has more than doubled since 2013.









Foreign-Owned Forest Land since 2012 (acres)





Foreign-Owned Other Agricultural Land since 2012 (acres)




