Re: Annual Report on Commonwealth Agency and Department Reporting of Small, Women- and Minority-owned Business Procurement

The Virginia Department of Small Business and Supplier Diversity ("DSBSD") was established and granted statutory powers under §§ 2.2-1603 et seq. of the Code of Virginia. Section 2.2-1606 of the Code grants certain powers and duties to the DSBSD, which specifically includes, inter alia, the duty to "[i] implement any remediation or enhancement measure for small, women-owned, or minority-owned business as may be authorized by the Governor pursuant to subsection C of § 2.2-4310 and develop regulations, consistent with prevailing law, for program implementation."

As part of this duty, the DSBSD Director is required to report to the Governor and the General Assembly on the participation of small, women-owned and minority-owned ("SWaM") businesses in state procurement as well as identify state entities failing to submit annual progress reports on SWaM procurement as required by § 2.2-1610 of the *Code of Virginia*.

COV § 2.2-1610. Reports and recommendations; collection of data.

The Director shall, from time to time, submit directly or through an assistant to the Governor his recommendations for legislation or other action as he deems desirable to promote the purposes of this chapter.

The Director shall report, on or before November 1 of each year, to the Governor and the General Assembly the identity of the state departments and agencies failing to submit annual progress reports on small, women-owned, and minority-owned business procurement required by § 2.2-4310 and the nature and extent of such lack of compliance. The annual report shall include recommendations on the ways to improve compliance with the provisions of § 2.2-4310 and such other related matters as the Director deems appropriate. The Department shall include in its annual report information on the progress of the mentorship program established under § 2.2-1605.1.

The Director, with the assistance of the Comptroller, shall develop and implement a systematic data collection process that will provide information for a report to the Governor and General Assembly on state expenditures to small, women-owned, and minority-owned businesses during the previous fiscal year.

An institution exercising authority granted under this section shall promptly make available to the Department, upon request, copies of its procurement records, receipts, and transactions in regard to procurement from small, women-owned, and minorityowned businesses in order for the Department to ensure institution compliance with its approved reporting and certification criteria.

The compliance rate for FY22 SWaM plan submission is 94.91% for state entities and institutions. Entities that have multiple sub agencies beneath them, that did not submit a plan, are only counted once to obtain compliance rates.

The table below captures the Agency's SWaM Plan submission status as it has been reported to DSBSD.

Of the six agencies listed as non-compliant, five of the agencies submitted the SWaM plan in the system for the Agency Director's approval. However, the SWaM plan was not approved by the deadline. The remaining non-compliant agency failed to submit a SWaM plan.

In order to improve compliance with the provisions of § 2.2-4310, DSBSD makes the following recommendations:

- 1. Agencies should perform monthly adjustments in the Expenditure Dashboard to accurately reflect spend by SWaM category.
- 2. Dashboard SWaM Plan Administrators should contact SBSD if the Agency Director or other users do not have an Active Expenditure Dashboard account.
- 3. If agencies encounter difficulty completing or approving the SWaM Plan, they should utilize resources provided by SBSD designed to support them in the process.
- 4. DSBSD will extend the 30-day time frame to submit SWaM plans to allow more time and flexibility for agencies and Agency Directors to submit and approve SWaM plans.
