II. Actions taken in compliance with §23.1-1301, § 2.2-3711 and §2.2-3712.

The goal of the Board of Visitors of Radford University is to operate in a transparent manner as evidenced by the following:

1) Held Quarterly Board Meetings on the following dates all of which were open to the public, notice was provided pursuant to §2.2-3707 of the Code of Virginia, and the agendas and minutes were published pursuant to state law: February 11, 2022; April 29, 2022; September 9, 2022; and December 2, 2022.

2) Held a Board Retreat on July 25-26, 2022. Both days were open to the public, notice was provided pursuant to §2.2-3707 of the Code of Virginia, and agenda and minutes were published pursuant to state law.

5) At the April 29, 2022 meeting, the Board approved a statement, which complies with House Bill 2120 passed in 2021 and included a SCHEV directive, that states Radford University will provide the public with real-time electronic access to regularly-scheduled meetings of its full Board of Visitors that take place in the usual location for such meetings.

An attorney from the Office of the Attorney General attended committee meetings and was available to all committees for consultations as needed.

III. Actions taken in compliance with §23.1-1303 Boards of Visitors; Bylaws and §2.2-3708.3; Electronic Communication.

At the December 2, 2022 meeting, the Board approved Bylaw changes including the removal of standing committees, except for the Executive Committee; updated the language for individuals participating by telecommunications means; and added the Board's statutory obligation for holding all-virtual meetings.

IV. Actions taken in compliance with §23.1-1303 Boards of Visitors; Annual meeting with the president of the institution.

Pursuant to §23.1-1303 and in accordance with the Bylaws of the Board of Visitors of Radford University, the Board does meet annually with the President concerning his review.

President Bret Danilowicz began his tenure as Radford University President on July 1 2022. The Board met with him at the July 25-26, 2022 and approved a Performance Plan for the upcoming year.
