March Highlights

March 2024 saw several new records set: highest monthly scratcher sales, highest monthly iLottery Instants sales, and highest monthly profits. The scratcher monthly record, for a product sold only at retail locations across Virginia, shattered the previous record established in March 2021. Retail sales have continued to perform strongly in calendar year 2024, with March 2024 retail sales nearly 20% higher than March 2023. Retail sales were strengthened due to both national jackpot games (Mega Millions and Powerball) rolling to over \$1 billion in March, helping to support record profits for the month.

Year to Date Highlights

For the fiscal year, iLottery Instants continue to experience strong growth. Beginning in January, retail sales also began to show growth over the prior year, and we expect that the deficit accumulated in the first half of FY24 will be fully erased by the end of June. Overall profits are up 6.5% compared to last year, and nearly 8% stronger than the updated forecast included in your introduced budget.

Other Highlights

We continue to monitor legislation from the 2024 Session related to the regulation of skill games, as well as the budget process. Our retail sales activity continues to show strength in the months since skill games were widely disabled following the Supreme Court of Virginia's ruling. The conference budget anticipated \$25 million in excess FY24 profits to be available as part of the FY25 Lottery Proceeds Fund for K-12 public education.

On May 1, the Virginia Lottery Board will hold a regular business meeting in Portsmouth at Tidewater Community College, near the first permanent established Virginia casino, and will welcome its newest appointed member: Sherry L. Williams.

This is my first update to you in my role as Executive Director of the Virginia Lottery. I am honored to lead the Virginia Lottery in its continued successes, maintaining its established best-in-class performance. In a state with arguably the most competitive gaming market in the U.S. today, continuing the successful business operations while growing the regulatory oversight responsibilities to maintain the public trust and confidence in Virginia gaming is my baseline goal. I know that we will continue to establish new industry standards, all of which benefit the Commonwealth of Virginia, our public schools, localities, problem gambling treatment, and all of the programs and services associated with gaming.
