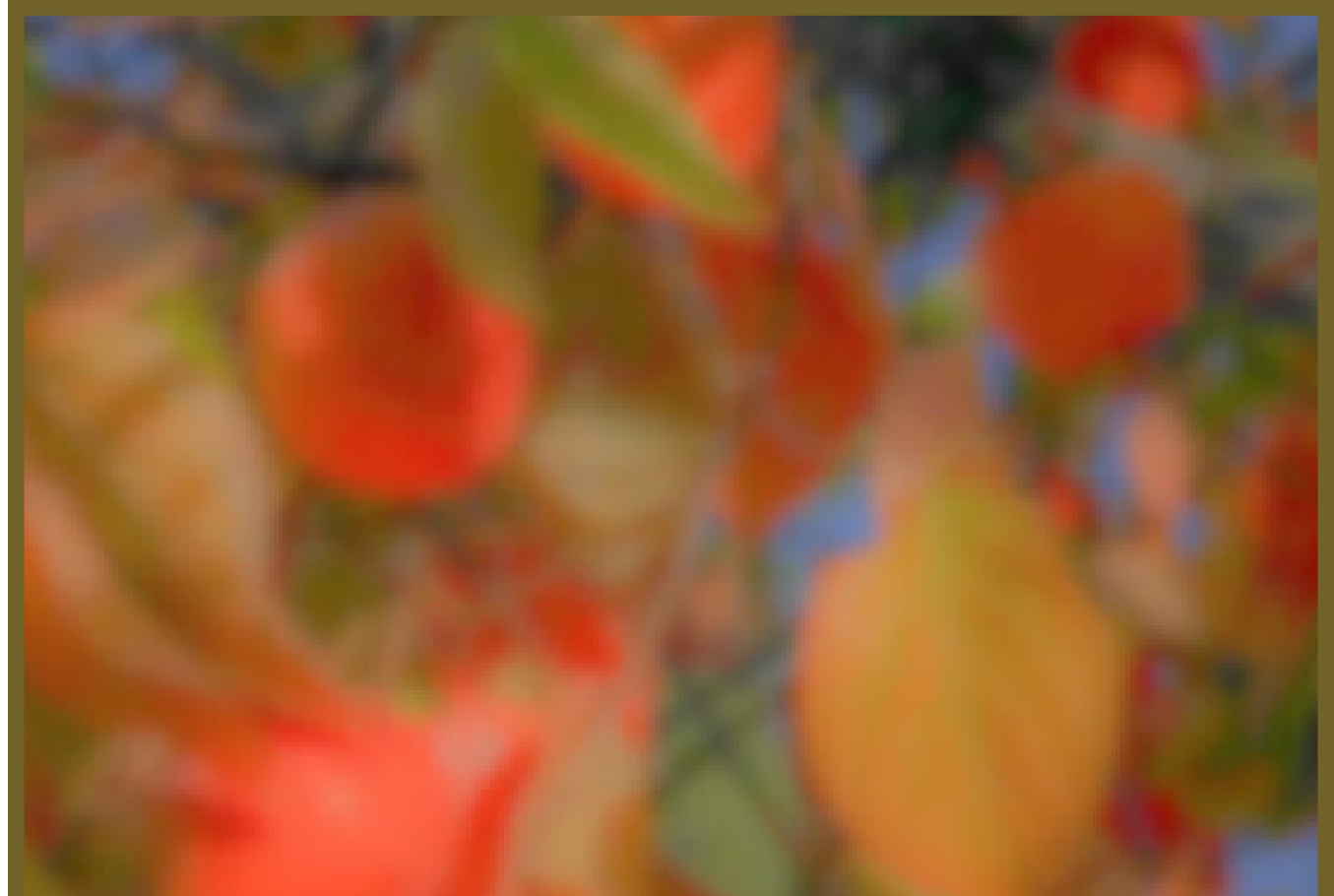

About the Fund



The mission of the Virginia Victims Fund is to administer the Compensating Victims of Crime Act in a compassionate, fair and efficient manner. In so doing, the Fund strives to treat every victim and survivor with dignity and respect, recognizing the tremendous impact that violent crime has upon the victim and our society.



The program is funded through fines levied against individuals convicted of felonies and misdemeanors in the Courts of the Commonwealth and through federal grants under the Victims of Crime Act (VOCA).



The Virginia Victims Fund is administered by the Virginia Workers' Compensation Commission.



Benefits are limited to a total of \$35,000 and are payable for medical expenses, wage loss, moving expenses, crime scene clean-up, counseling costs, and other expenses incurred by or on behalf of a victim. In homicide cases, funeral or burial expenses are payable up to \$10,000; eligible relatives may receive survivors' counseling; and dependent survivors may receive compensation for loss of support from the victim.



As of July of 2008, the Fund also administers the Sexual Assault Forensic Exam (SAFE) Payment Program for the Commonwealth.

About

The Virginia Workers' Compensation Commission (VWC), established in 1918, is an independent judicial and administrative state agency that oversees the workers' compensation system for the Commonwealth. The Commission is headed by three Commissioners who are chosen by the General Assembly and serve six-year terms. The Honorable R. Ferrell Newman, the Honorable Wesley G. Marshall and the Honorable Robert A. Rapaport are the current Commissioners, with Rapaport serving as Chairman from July, 2021 until June, 2024. The Honorable Wesley G. Marshall begins his three-year term as Chairman on July 1, 2024. Ms. Evelyn McGill is the Executive Director and the Honorable James J. Szablewicz is the Chief Deputy Commissioner.

To serve injured workers, victims of crimes, employers, and related industries by providing exceptional services, resolving disputes, and faithfully executing the duties entrusted to us by the Commonwealth of Virginia.

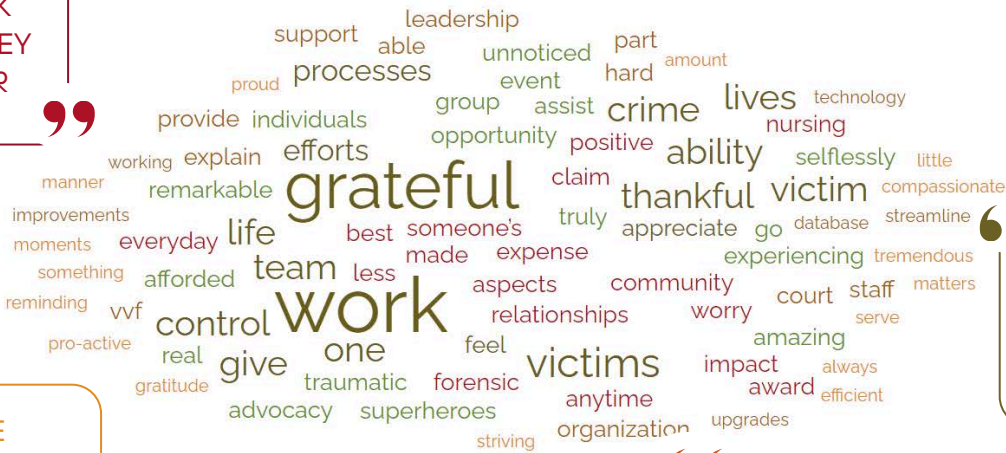

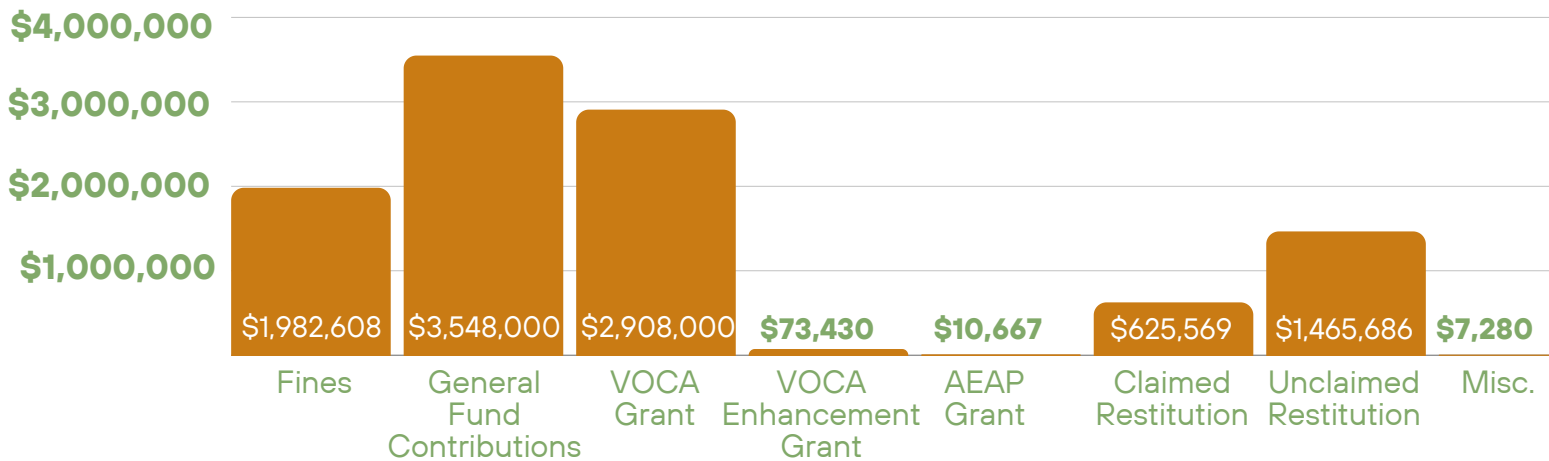

FY2024 REVENUE



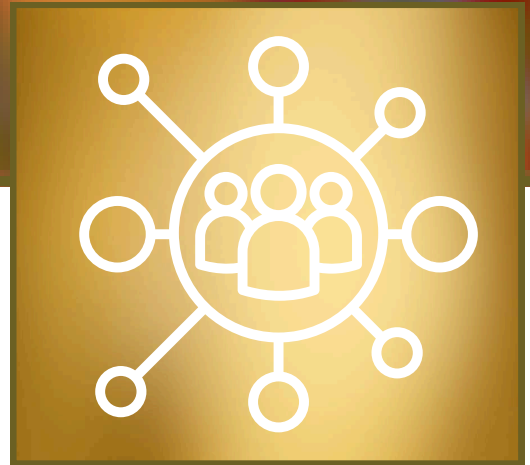

The Virginia Victims Fund provides financial assistance to victims of violent crime, helping cover expenses such as medical costs, lost wages and funeral expenses.

Outreach efforts focus on increasing awareness of available resources, engaging with communities and collaborating with local organizations and law enforcement to ensure that victims know how to access the support they need.

Our Ombudsman is also available to assist claimants and victim witness advocates with the compensation process. This role is vital to ensuring that constituents understand how decisions are made and documentation needed to support awards.

Claim Information

VVF provides financial support to victims of crime, helping cover costs that arise from their victimization. This assistance eases financial burden, allowing people to focus on recovery instead of immediate costs.

REQUIREMENTS

Victim/Claimant Requirements

The victim/claimant must:

- fully cooperate with law enforcement,
- must not have contributed to and caused the crime to occur, or be an accomplice or accessory,
- submit necessary documentation.

Claim Requirements

The claim must be filed with VVF within one year of the crime, unless good cause exists for the delay. The claim must have a minimum loss of \$100.00 after collateral resources.

Eligible Crimes

The crime must:

- occur in Virginia or against a Virginia resident in a state, country, or territory that does not have a compensation program,
- be reported to law enforcement within 120 hours, unless good cause for the delay is shown,
- cause physical injury or death,
- cause emotional injury as a result of a violent felony offense.

Open Claims

Claims remain open until maximum payment is received and claimants may add expenses as they occur.

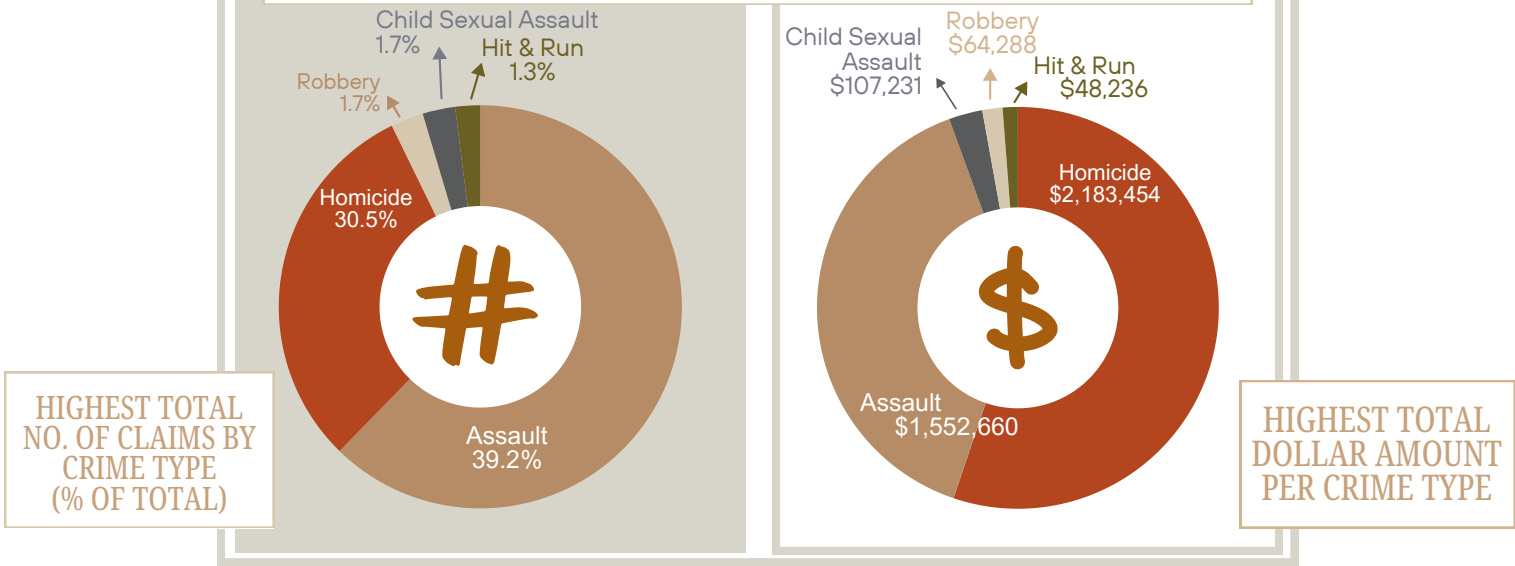

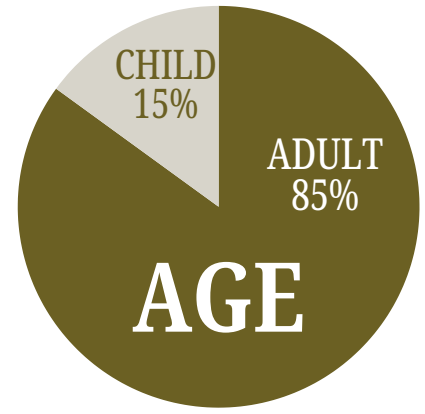
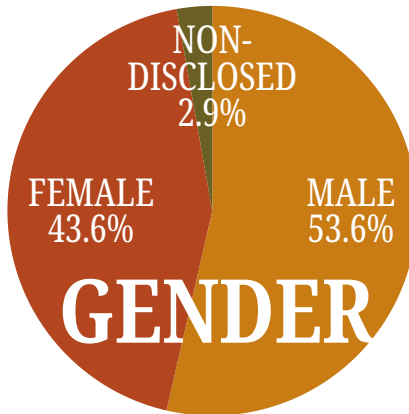

COMPARING HIGHEST TOTAL NUMBER OF CLAIMS TO HIGHEST TOTAL DOLLAR AMOUNT

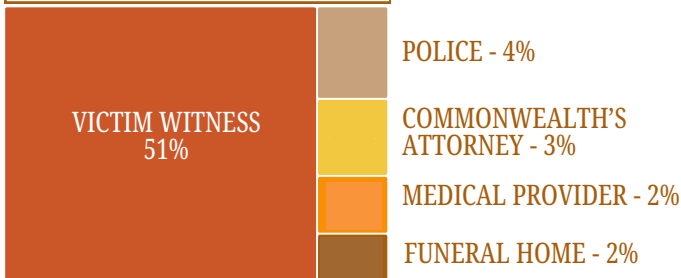


\$4,175,914 PAID TO CRIME VICTIMS AND THEIR FAMILIES

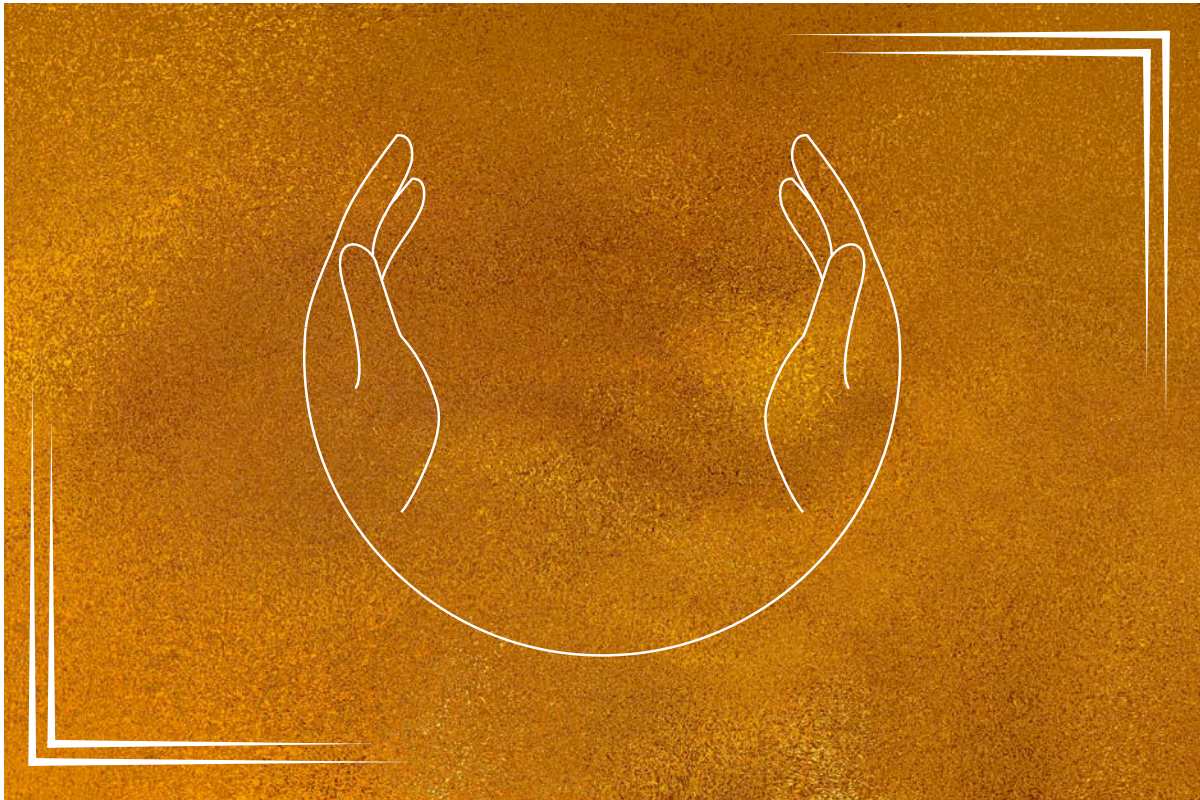


TOP REFERRAL SOURCES

SAFE Payment Program



SAFE: SEXUAL ASSAULT FORENSIC EXAMINATION PAYMENT PROGRAM

The SAFE Program is crucial because it ensures that survivors of rape or sexual assault receive timely, compassionate, and **free** forensic exams, preserving evidence that is vital for legal proceedings. The SAFE Program helps to remove financial barriers for survivors, encouraging reporting and supporting the journey toward healing.

SAFE Exams

ACUTE

Acute Exams are done within approximately 120 hours of an assault. Virginia law caps the reimbursement rate for acute exams at 60% of actual eligible costs.

NON-ACUTE

Non-Acute Exams are done more than 120 hours after an assault. Commission policy caps the reimbursement for non-acute exams at \$1,500 of actual eligible costs.

FOLLOW-UP

Follow-Up Exams are done as a continuum of care for victims and can include documenting injuries and testing for sexually transmitted infections. Commission policy caps the reimbursement for follow-up exams at \$1,000 of actual eligible costs.

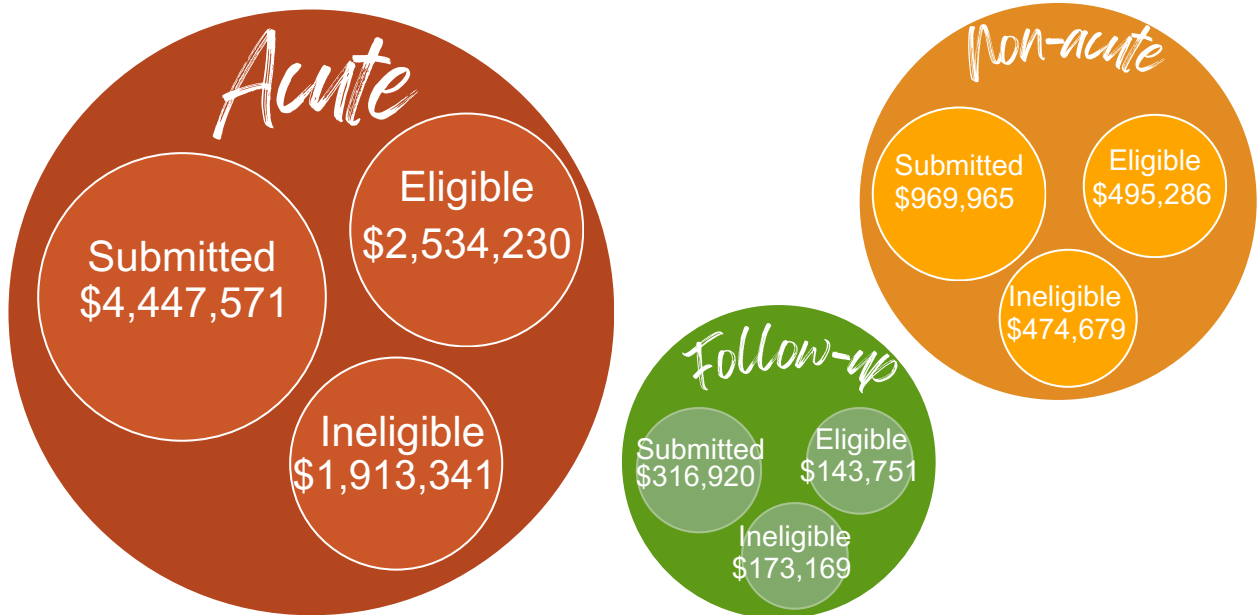

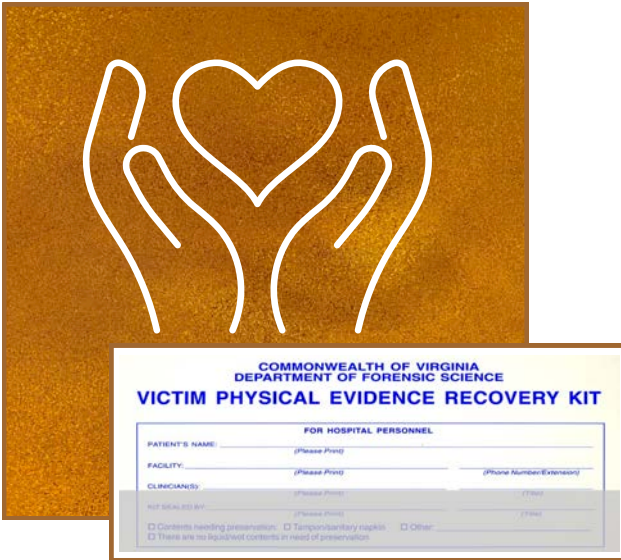
SAFE Exams: Acute, Non-acute and Follow-up: Submitted, Eligible and Ineligible



Why may a claim be deemed ineligible?

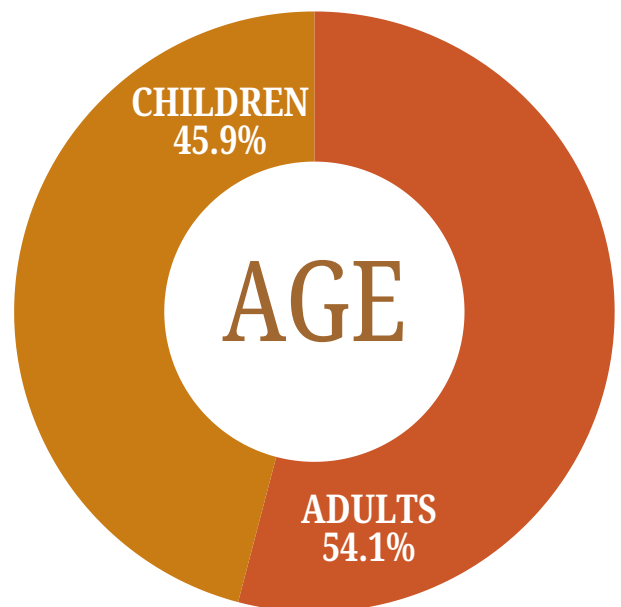
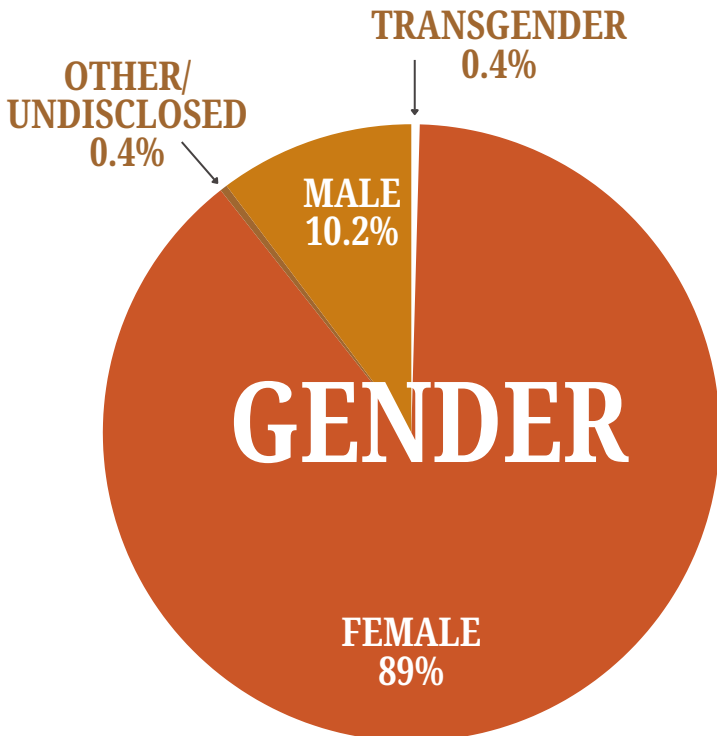
- It was an out of state incident,

- The expenses submitted for were not covered by the program (but may be covered by the Virginia Supreme Court).

SAFE Payment Program



Health care providers bill the SAFE Payment Program directly, so victims do not need to worry about filing for reimbursement in what is already a stressful and emotional time. Evidence is collected through a Physical Evidence Recovery Kit (PERK) and does not require the filing of a police report if the PERK is completed within 120 hours of the incident.

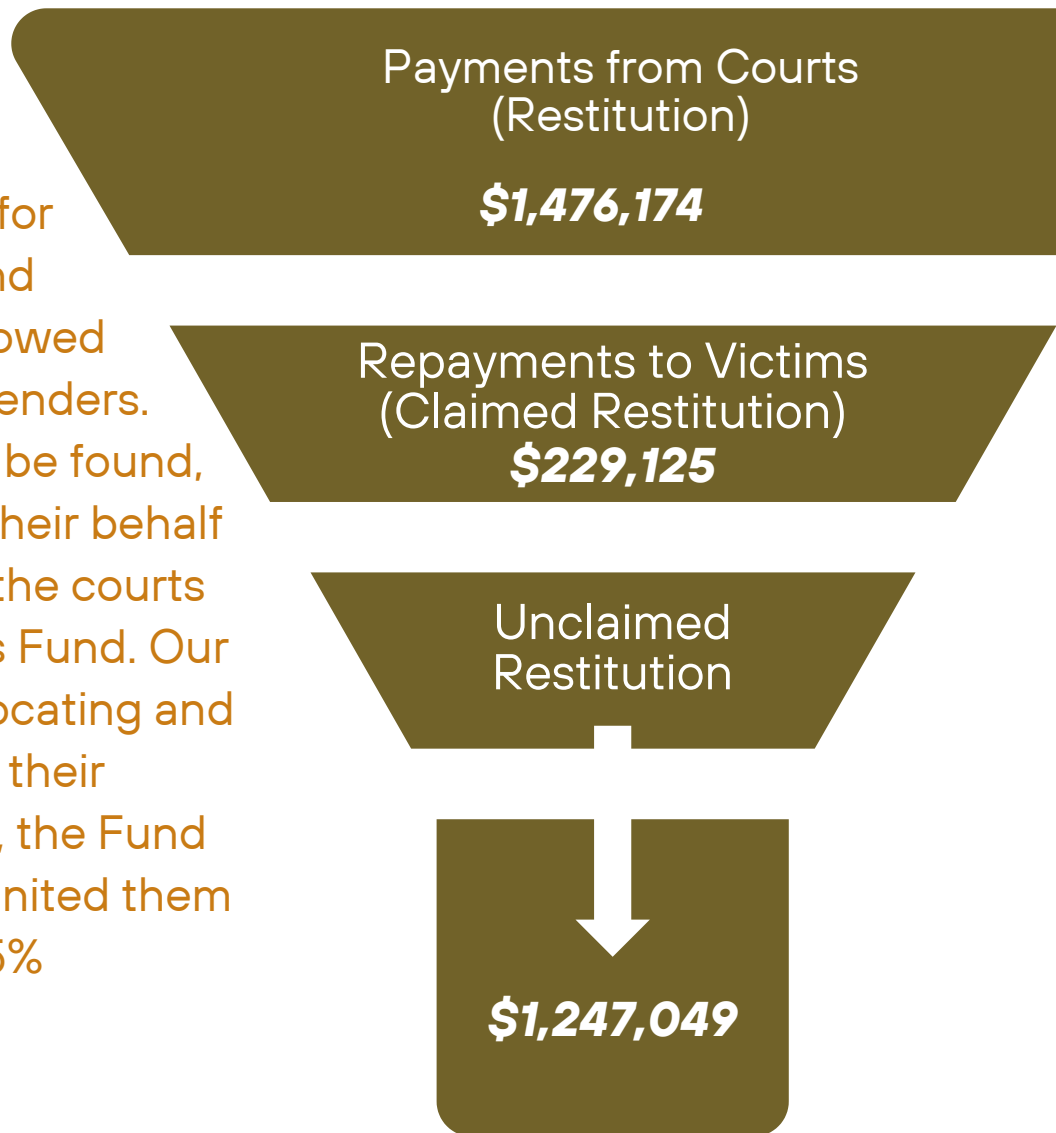

Restitution

A CONVICTED OFFENDER MAY BE ORDERED TO REIMBURSE THE VICTIM FOR FINANCIAL LOSSES INCURRED DUE TO THE OFFENDER'S CRIME.

Every year, courts throughout the Commonwealth look for victims (individuals and businesses) who are owed restitution paid by offenders. When victims cannot be found, monies collected on their behalf are transmitted from the courts to the Virginia Victims Fund. Our staff is dedicated to locating and reuniting victims with their restitution. In FY2024, the Fund found victims and reunited them with restitution at a 15% repayment rate.



Mass Casualty

BY OFFERING TIMELY AND COMPASSIONATE SUPPORT, THE MASS CASUALTY PROGRAM NOT ONLY AIDS IN THE HEALING PROCESS BUT ALSO STRENGTHENS COMMUNITY RESILIENCE IN THE FACE OF DEVASTATING EVENTS.

VVF Crisis Response Process



The VVF mass casualty coordinator, along with the Virginia Department of Criminal Justice Services (DCJS), is responsible for responding to critical events, coordinating VVF activities, and assisting victims with applying for claims. Additionally, this position handles all claims arising from crimes that result in three or more victims.

Virginia law requires local and state entities, K-12 public schools, and public colleges and universities to include VVF and DCJS within their emergency plans, which should be notified and deployed in certain emergency situations that create multiple victims of crime. An effective response by VVF depends upon preparation, training, and having a dedicated person to lead the VVF efforts. As such, in FY24, VVF prioritized this responsibility by creating a position that is 100% dedicated to serving victims of mass casualty events.
