SUBJECT: New LIS and Other Legislative System Expenses

Pursuant to Item 5C of HB6001 (Chapter 2) from the 2024 Special Session I, attached is a report on the detailed accounting of funding provided to DLAS since fiscal year 2020 for the replacement of legacy legislative tracking system, and separately for other legislative system replacements and upgrades, The FY2025 figures represent expenses through September 30, 2024 (first quarter FY25).
