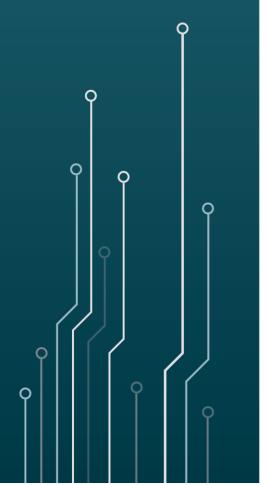


# Information Technology Advisory Council

**Annual Report** 

2024



# **BACKGROUND**

Pursuant to Section <u>2.2-2699.6 (C)</u> of the Code of Virginia, the Virginia Information Technologies Agency (VITA) respectfully submits this report, which provides an update "regarding the work of the Information Technology Advisory Council (ITAC) and any advisory subcommittee." This report covers ITAC's second year, from October 2023 through September 2024.

The Council met two times and has reviewed and discussed multiple presentations, which are summarized below. ## ITAC'S PURPOSE

ITAC is responsible for advising and making recommendations to the Chief Information Officer (CIO) of the Commonwealth and the Secretary of Administration regarding information technology in the Commonwealth.

Specifically, pursuant to Virginia Code § <u>2.2-2699.6</u>, ITAC advises regarding:

- 1. Cybersecurity policies, standards, and guidelines, for
  - a. assessing security risks,
  - b. determining appropriate security measures,
  - c. performing security audits of government electronic information,
  - d. strengthening the Commonwealth's cybersecurity, and
  - e. protecting against and responding to breaches of information technology security;
- 2. Strategies and priorities for information technology for executive branch agencies.
- 3. Information technology planning and projects;
- 4. Policies, standards, and guidelines for the Commonwealth's information technology and data; and
- 5. Information technology budgeting, investments, and expenditures.

### **ITAC MEMBERS**

ITAC consists of up to 20 members, including:

- The CIO of the Commonwealth,
- The Secretary of Administration,
- The Secretary of Labor
- Four members of the House of Delegates, appointed by the Speaker of the House,
- Three members of the Senate, appointed by the Senate Committee on Rules, and
- An even number of non-legislative citizens appointed by the Governor.

This year ITAC achieved a full complement of 20 members. Current members are:

# APRIL 25, 2024 MEETING

During the April 2024 meeting, ITAC heard and discussed the following presentations (which may be found in full in the agenda packet at the above meeting link):

  provided an overview of key legislation VITA followed in the 2024 Session
  of the General Assembly. Bills discussed involved government technology,

  Al in the Commonwealth, in which VITA and the rest of the executive
  branch are operating under Executive Order 30 and policies pursuant to it.

# AUGUST 8, 2024 MEETING

The August 2024 meeting occurred during a declared state of emergency, pursuant to Governor Youngkin's Executive Order 34 (August 6, 2024). The requirements of Virginia Code § 2.2-3708.2 having been met, the meeting was held without the requirement for a physically assembled quorum.

The Council heard and discussed the following presentations (which can be found in the agenda packet in the above meeting link):

- Dan Wolf, Director of State Programs at the Alliance for Digital Innovation,
  discussed the benefits of modernization and public sector IT funding in other
  states and federally (including federal grant funding and the US Tech Mod Fund).
   States have set up a variety of funding mechanisms to meet the critical need of

- VITA personnel presented regarding current and future IT governance.

    project management governance, including governance models, risk
    management, and strategic planning steps from start to finish. The

- Finally, Amy Braden, Director of Security Governance, was scheduled to
  present regarding cybersecurity governance, but that presented was
  postponed to ITAC's next planned meeting, in December 2024, due to the
  meeting running long.

Many of the issues presented by dynamic and often complex technology are not unique to government, making it essential to have ITAC members with diverse backgrounds and experience with technology.
