

Background

During the 2020 Session of the Virginia General Assembly, policymakers enacted Article 14 of Chapter 1 of Title 9.1 of the *Code of Virginia*, establishing the Sexual Assault Forensic Examiner Coordination Program at the Virginia Department of Criminal Justice Services (DCJS), effective July 1, 2020. The goals of the program, as outlined in the *Code of Virginia* § 9.1-191, include developing and enhancing sexual assault forensic examiner programs across Virginia, establishing a partnership group to plan forensic nurse training, assisting with developing protocols and guidelines for the treatment of victims of sexual assault, and collecting and maintaining information on all available sexual assault forensic services in Virginia. The Sexual Assault Forensic Services Coordinator (Coordinator) at DCJS leads this program.

The Code of Virginia § 9.1-191 also requires that the "Coordinator shall report annually on or before October 1 to the Governor and the General Assembly. The report shall include a summary of activities for the year and any recommendations to address sexual assault exams within the Commonwealth, including budget needs to increase the availability of sexual assault exam services across the Commonwealth."

Activities

The Coordinator has ten responsibilities outlined in the *Code of Virginia*. Current activities related to each responsibility are described below.

 Create and coordinate an annual statewide sexual assault forensic nurse examiner training program in partnership with the Attorney General, the Virginia Department of Health, the Virginia Hospital and Healthcare Association, the Victim Compensation Fund, the International Association of Forensic Nurses, and the Secretary of Health and Human Services.

The Coordinator created and coordinated an Adult/Adolescent Sexual Assault Nurse/Forensic Examiner Clinical Skills Lab (lab) at Valley Urgent Care in Harrisonburg, Virginia, in partnership with the International Association of Forensic Nurses (IAFN), the Office of the Attorney General, the Virginia Department of Health, and the Virginia Victims Fund.

The purpose of the lab, as stated in the IAFN curriculum document, is "to prepare the didactically trained SAFE/SANE [Sexual Assault Forensic Examiner/Sexual Assault Nurse Examiner] for clinical aspects of the adult/adolescent sexual assault medical-forensic examination, regardless of the provider's practice setting."¹

Fifteen forensic nurse examiners, who all completed 40-hours of the Adult/Adolescent Didactic Training, attended the intensive and hands-on lab training. The training used the IAFN "Clinical Skills Lab Curriculum," as well as trainers and Gynecological Training Associates (GTA) contracted by the IAFN.

Four trainers and four GTAs offered students opportunities to perform speculum exams on live simulation patients and practice trauma informed care in mock scenarios.

Forensic nursing programs represented at the training included:

- Augusta Health Forensics Nurse Team
- Bon Secours Violence Response Team, Richmond

- Chesapeake Forensic Specialists
- Inova Ewing Forensic Assessment and Consultation Team, Falls Church
- MWHC Forensics –Mary Washington Hospital, Fredericksburg
- Sentara Peninsula Forensic Nurse Examiners Program, from the Sentara CarePlex Hospital location
- Valley Urgent Care and Occupational Medicine, Harrisonburg
- Virginia Commonwealth University Health System Adult Forensic Examiner Team, Richmond and Tappahannock
- 2. Coordinate the development and enhancement of sexual assault forensic examiner programs across the Commonwealth that include prevention of secondary trauma to survivors and culturally sensitive training for health professionals.

The Coordinator met with the new University of Virginia (UVA) Forensic Program coordinator to discuss changes to the program and support of their Health Resources and Services Administration (HRSA) grant application. The Coordinator agreed to support UVA's proposed projects under the grant by assisting with the recruitment of registered nurses into the Sexual Assault Nurse Examiner (SANE) training program, leveraging the Coordinator's network and resources to attract a diverse group of dedicated and compassionate professionals. The Coordinator agreed to aid in publicizing educational webinars, ensuring widespread dissemination across relevant platforms and stakeholders to maximize participation and impact. The Coordinator also agreed to collaborate with the project team to identify and develop content for the Virginia-specific bridge training module.

Additionally, the Coordinator:

- Met with the new Ballad Health program coordinator to provide information and support for their efforts in increasing forensic exam services in their Virginia hospitals in Southwest Virginia.
- Provided information and support to a student at Virginia Tech, who was working on a project to bring sexual assault forensic exam services to the Virginia Tech campus.
- Collaborated with the DCJS Improving Criminal Justice Responses Program Coordinator on a one-day expert witness testimony training, attended by 32 forensic examiners from across the state.
- Participated in a working group, convened by the Virginia Victims Fund's SAFE Payment
 Program, to discuss transportation needs across the state, as they explored ways to best
 support localities in providing transportation to survivors seeking a sexual assault forensic exam.
- 3. Participate in the development of hospital protocols and guidelines for treatment of survivors of sexual assault in partnership with the Department of Health.

The Coordinator is in communication with staff from the Virginia Department of Health (VDH) and attended the meetings of the Task Force on Services for Survivors of Sexual Assault, coordinated by VDH. The Task Force released model and guidance documents for both adult and pediatric transfer and treatment of sexual assault patients. DCJS is not a member of the Task Force; however, the Coordinator provided information to the Task Force regarding sexual assault programs in the Commonwealth as needed.

4. Coordinate and strengthen communications among sexual assault nurse examiner medical directors, sexual assault response teams, and hospitals for existing and developing sexual assault nurse examiner programs.

The Coordinator met with hospital administrators and department managers across the state, and she is collaborating with DCJS staff working with Sexual Assault Response Teams (SARTs) throughout Virginia.

The Coordinator has provided technical assistance to both forensic nursing programs and community advocacy centers on building stronger relationships and creating policy and practices where advocates are automatically called in when a survivor presents themselves for a sexual assault forensic exam.

5. Provide technical assistance for existing and developing sexual assault forensic examiner programs, including local sexual assault forensic examiner training programs.

The Coordinator sends out a monthly email communication to all forensic nursing programs. These emails detail information pertinent to the practice of sexual assault forensic nursing. Emails covered the following topics during SFY 2024:

- The importance of collaboration between the forensic nurse and community advocates.
- Updates on the Virginia Victims Fund Sexual Assault Forensic Exam Payment Program.
- Updates on training, including the Clinical Skills Lab and the Expert Witness Testimony Training for Forensic Examiners.
- Program news and highlights.
- Updates from the Task Force on Services for Survivors of Sexual Assault.
- Legislation updates.
- Updates to the Forensic Examiner Program Directory.
- Updates on forensic exam services guidelines and protocols.
- Developing tools for resilience and combating the effects of vicarious trauma.

The Coordinator also convenes a quarterly meeting with forensic nursing program coordinators to provide and facilitate technical assistance. The first meeting hosted the Virginia Victims Fund SAFE Payment Program Coordinator, who discussed updates and took questions from the group. Future meetings will continue to address the needs of the programs, such as billing to the SAFE Payment Program and the Virginia Supreme Court, evidence collection, hiring practices, sustainability of programs, and legislation updates.

Technical assistance for specific programs included meeting with Augusta Health emergency room management, which oversees the forensic nursing team, to discuss a plan for maintaining the operation of the program after the current program coordinator retires. The Coordinator will continue to support that team during their transition to ensure that sexual assault forensic exam services for both adults and children continue to be available in that part of the state.

- 6. Create and maintain a statewide list, updated biannually, to include the following:
 - a. A list of available sexual assault forensic examiners, sexual assault nurse examiners, sexual assault forensic nurse examiners, and pediatric sexual assault nurse examiners;
 - b. The location and facility affiliation of each examiner;
 - c. The duty hours for each examiner and affiliated facility for sexual assault exam services; and
 - d. The location of available local sexual assault forensic examiner training programs.

The Coordinator, in collaboration with the DCJS Research Center, developed a survey for the Sexual Assault Forensic Exam programs that was first distributed in December 2021. This survey is distributed annually, and

collects the data enumerated in the *Code of Virginia* responsibility. From the data collected, the Coordinator has developed a map directory of all the programs in the state, as well as a directory.

The survey was most recently distributed in July 2023 and provided information necessary for an updated directory. The survey also gathered data points for Virginia forensic exam programs, as well as additional information to help identify the needs and challenges with the programs. *See Appendix A, Forensic Services Survey: July 2023 Update*.

The Coordinator distributes the directory regularly in the monthly email communication that she sends out. Programs regularly communicate with the Coordinator on any changes that the program has undergone, which aids in keeping the directory up to date. See Appendix B, Commonwealth of Virginia Sexual Assault Forensic Examiner Programs – Directory.

7. Coordinate, share, and disseminate the list created pursuant to subdivision 6 to the emergency operations communications system available to emergency medical services and law-enforcement agencies as well as the internal emergency and hospital communications system.

The Coordinator has shared and disseminated the directory with the enumerated agencies and entities.

8. Share and disseminate the list created pursuant to subdivision 6 with all other relevant agencies, including law-enforcement agencies, attorneys for the Commonwealth, victim-witness programs, sexual assault service organizations, the Virginia Department of Juvenile Justice, the Virginia Department of Social Services, the Virginia Department of Education, and school divisions.

The Coordinator has shared and disseminated the directory with the enumerated agencies and entities. The directory also appears on the Sexual Assault Forensic Coordination Program web pages under the DCJS public facing website.

9. Create sexual assault nurse examiner recruitment materials for universities and colleges with nursing programs in partnership with the State Council of Higher Education for Virginia.

The Coordinator is working on a partnership with Valley Urgent Care in Harrisonburg to visit the nursing program at Blue Ridge Community College and give a presentation on forensic nursing in the fall of 2024.

10. Support and coordinate community education and public outreach, when appropriate, relating to sexual assault nurse examiner issues for the Commonwealth.

The Coordinator is working on a partnership with Valley Urgent Care in Harrisonburg to visit the nursing program at Blue Ridge Community College and give a presentation on forensic nursing in the fall of 2024.

Forensic Nurse Examiner Programs Across the Commonwealth by the Numbers

There are 26 health systems listed as members of the Virginia Hospital and Healthcare Association, representing a total of 111 hospitals.²

In July 2023, DCJS conducted a study of sexual assault forensic nursing programs across the Commonwealth and found 23 active forensic nursing programs, serving a total of 76 locations, including hospitals, emergency departments, urgent care clinics, stand-alone (non-hospital affiliated) programs, and child advocacy centers.

The Coordinator has identified the following challenges to sustaining existing forensic nurse examiner (FNE) programs and expanding FNE programs in Virginia:

- a. The state reimbursements for forensic nursing exams increased in April 2022, but still do not cover all costs associated with the exams. The average cost of a Physical Evidence Recovery Kit (PERK) exam was \$3,934 in State Fiscal Year (SFY) 2022, which means that on average, Virginia covered only 40.67% of the cost of a PERK exam in SFY 2022 (according to data from Virginia Victims Fund Sexual Assault Forensic Exam (SAFE) Payment Program). Additionally, FNE programs are not reimbursed for the costs associated with the time nurses spend in court preparation and court testimony, so hospitals must absorb these unreimbursed costs.
- b. Hospital management and administrators often do not know what sexual assault forensic nurses do or how their services fit into a healthcare framework. Sexual assaults are often not viewed as a public health crisis and sexual assault forensic nursing is also not seen as an essential healthcare service.
- c. Lack of funding and support from hospital administration results in a lack of nurses pursuing forensic nursing as a career, and with so few nurses in the field, this results in overworked and underpaid nurses with little incentive to remain in the field of forensic nursing.

Recommendations

Given the vested interest that the state has in prosecuting sexual abuse of children and sexual assaults against adults, the Coordinator recommends:

- 1. Regular increases in the SAFE payment reimbursement rates to more closely reflect the actual and total costs of the sexual assault forensic exam.
- 2. Reimbursing programs through the SAFE Payment Program for forensic examiner time spent on court preparation and testimony.

In order to address the lack of knowledge, funding, and support for sexual assault forensic nursing and FNE programs from many hospital administrators/management, the Coordinator recommends:

- 3. In collaboration with the Virginia Hospital and Healthcare Association, educating hospital systems on sexual assault as a public health matter, why forensic nursing is an essential healthcare service, and how to create sustainable FNE programs in their hospitals.
- 4. Creating and updating written materials for distribution to sexual assault patients at the time of the forensic exam, to include the following information: reported sexual assaults, anonymous sexual assaults, the PERK tracking system, statutory time limits on the storage of the PERK, and what to do if you receive a bill for the sexual assault exam.
- 5. Updating the model and guidance documents for both adult and pediatric transfer and treatment of sexual assault patients every two to three years.
