I. Introduction

This report will provide an annual update from Virginia Electric and Power Company d/b/a Dominion Energy Virginia (the “Company”) regarding its implementation of a pilot program for municipal net energy metering (“Pilot Program”), as required by Section XI. of the Guidelines for Municipal Excess Renewable Generation Pilot Program (the “Municipal Pilot Guidelines”).¹ The Municipal Pilot Guidelines were established pursuant to Chapters 746 and 747 of the 2019 Virginia Acts of Assembly and codified as § 56-585.1:8 of the Code of Virginia (the “Code”).² The Municipal Pilot Guidelines were subsequently amended pursuant to Chapter 388 of the 2022 Virginia Acts of Assembly. On May 16, 2023, in Case No. PUR-2022-00211, the State Corporation Commission of Virginia (the “Commission”) issued an Order Revising Guidelines to adopt the revised Municipal Pilot Guidelines.

The revised Municipal Pilot Guidelines will govern the Pilot Program for the treatment of any Municipal Customer-Generator’s excess generation, as envisioned by the Code and as described in the Commission’s May 16, 2023 Order Revising Guidelines. The revised Municipal Pilot Guidelines are attached hereto as Appendix A.

II. Program Reporting Requirements

Section XI. of the Municipal Pilot Guidelines states that the Company shall submit a report to the General Assembly and contemporaneously provide a copy to the Commission by December 1 of each year in which the Pilot Program is in effect, commencing in 2020, regarding the status of the Pilot Program’s enrollment and any other information the Company deems appropriate. At a minimum, the report must include (i) number of Municipal Customer-Generators enrolled; (ii) amount of Excess Generation; (iii) number of Metered Account(s) and Target Account(s); (iv) aggregated amount of bill credits by customer; (v) number and type of Municipal Customer-Generator(s); and (vi) administrative costs in aggregate on average by customer. According to the revised Municipal Pilot Guidelines, the Pilot Program will be available until July 1, 2028.

III. Program Status

As of November 26, 2024, no Municipal Customer-Generators have enrolled in the Pilot Program.

Below is the information required by the Municipal Pilot Guidelines:³

² The Commission was directed to establish rules or guidelines for this Pilot Program in the uncodified Second Enactments of these Acts of Assembly.

³ In its May 16, 2023 Order Revising Guidelines, the Commission declined to expand the reporting requirements in the Municipal Pilot Guidelines and ordered the Company to continue to file this report in Case No. PUR-2019-00182.
