I. <u>Introduction</u>

This report will provide an annual update from Virginia Electric and Power Company d/b/a Dominion Energy Virginia (the "Company") regarding its implementation of a pilot program for public school excess wind or solar renewable generation ("Pilot Program") as required by Section XI. of the Guidelines for Public School Excess Wind or Solar Renewable Generation Pilot Program (the "School Pilot Guidelines").¹ The School Pilot Guidelines were established pursuant to House Bill 1451, enacted as Chapter 415 of the 2018 Virginia Acts of Assembly and codified as § 56-585.1:7 of the Code of Virginia (the "Code").² On November 26, 2018, the School Pilot Guidelines were adopted by the State Corporation Commission (the "Commission") in Ordering Paragraph (1) of its Order Establishing Guidelines, entered in Case No. PUR-2018-00061. The School Pilot Guidelines will govern the Pilot Program for the treatment of any Host School's excess generation, as envisioned by the Code and as described in the Commission's Order Establishing Guidelines. The School Pilot Guidelines are attached hereto as Appendix A.

II. <u>Program Reporting Requirements</u>

Section XI. of the School Pilot Guidelines states that the Company shall submit a report to the General Assembly by December 1 of each year in which the Pilot Program is in effect, commencing in 2020, regarding the status of the Pilot Program's enrollment and any other information the Company deems appropriate.

III. Program Status

As of November 26, 2024, no Host Schools are participating in the Pilot Program for public school excess wind or solar renewable generation.
