Item 319 of the 2023 Appropriation Act, the purpose of this letter is to report on the general fund and non-general fund allocations for each state-operated behavioral health facility. The language reads:

The Commissioner, Department of Behavioral Health and Developmental Services, shall report by August 1 of each year to the Secretary of Finance, and the Chairmen of House Appropriations and Senate Finance and Appropriations Committees the general fund and non-general fund allocations and authorized position levels for each state-operated behavioral health facility. The report shall be made available on the agency's public website.
