Review of Campaign Finance Reports and Records

Executive Summary

Purpose of Report

2022 Acts of Assembly Chapter 258 (HB 492), which added Va. Code § 24.2-948.5¹, went into effect January 1, 2024. It requires that the Department of Elections (ELECT) review campaign finance reports and records prepared by a selection of candidate campaign committees within 180 days following the November General Election. The purpose of the review is to: (1) reconcile the balance in the campaign depository with the amounts reported in the candidate's reports of receipts and expenditures, and (2) review the reports for mathematical accuracy and facial completeness including the reporting of specific information required by law.

Following a random selection of seven candidate campaign committees at the State Board of Elections meeting on November 18, 2024, ELECT undertook a process for the review of campaign finance records and individual campaign committee record submissions. In furtherance of the statutory requirements, the Campaign Finance Reports and Records Review (referred to in this report as "CFR3" or "review") was designed to focus on the required areas of campaign depository reconciliation, mathematical accuracy and facial completion of submission.

Key Findings and Highlights

- The review for the 2024 General Election ("2024 review") revealed an 84% Overall Compliance² for areas that could confidently be tested:
 - o Reconciliation checks identified 77% accuracy compliance.
 - Mathematical Accuracy checks confirmed the reliability of the selected campaign committee reports with 98% compliance.
 - Facial Completeness checks showed 79% compliance.
 - Timeliness checks had a rate of 95% across all committees indicating that committees effectively complied with the report submission timeline requirements.
- While the review revealed some mathematical discrepancies in reported data across the selected committees, most could reasonably be attributed to timing differences between financial statement production dates and the close of filing periods.
- Generally, selected committees complied with requests for financial records and supporting
 documentation (e.g., bank statements, copies of checks), though for a small percentage of
 requests either the documentation was not provided, provided and not reported, or the
 provided copies were illegible.
- The 2024 review highlighted several compliance challenges and limitations within the Virginia Campaign Finance System. Addressing these issues through targeted system

improvements will enhance the system's transparency, accountability, and overall effectiveness in managing campaign finance activities and providing accessible, user-friendly data.³

 While only one percent of candidate committees for local elections were required to be reviewed in 2024, the required data analysis was nevertheless a significant undertaking. The review in 2025 will be significantly larger in scope and must include all committees for candidates for statewide office, 10 percent of committees for candidates for House of Delegates, and one percent of committees for candidates for all other offices.⁴

I. Background

In conducting its review duties, § 24.2-948.5(D) permits ELECT to employ the services of additional personnel. The Campaign Finance Division at ELECT worked with GME Enterprises (GME) to develop procedures for the campaign finance reviews, conduct the reviews, analyze the findings, and develop this report.⁵

The inaugural review commenced after the General Election held on November 5, 2024. Seven campaign committees were randomly selected for review at a meeting of the State Board of Elections on November 18, 2024. For the review, ELECT was authorized to request and review bank statements for, and copies of checks issued on, campaign depositories and itemized bills, invoices, and receipts for any expenditure of campaign funds in an amount greater than \$500⁶, so requests for this information were issued in addition to notices of selection for review.

The following sections summarize the methodology applied to complete the 2024 review, including the review components, selection process, review process, and the review results. The report concludes with a section that highlights conclusions and observations from the first review that may help with subsequent annual reviews.

II. Methodology

Review Components

The following activities were undertaken to complete the review:

- 1) Drafted procedures and guidelines for the conduct of the reviews.
- 2) Reviewed campaign committees' campaign finance reports and records, scrutinized campaign committee reports and records in accordance with ELECT's candidate campaign committee policies, drafted procedures and guidelines.⁷
- 3) Reviewed the reports for mathematical accuracy, and facial completeness including the reporting of specific information required by law. In doing so, ELECT requested and reviewed monthly bank statements for, and copies of checks issued on, campaign depositories and itemized bills, invoices, and receipts for any expenditure for campaign funds in an amount greater than \$500°, and

4) Completed by July 1, 2025, a report of the results of the reviews for submission to the State Board, Governor, and General Assembly and posting to the Department's website.¹⁰

Selection Process and Criteria

Consistent with the requirements of § 24.2-948.5(B), the committees of one percent of candidates, including losing primary candidates, for all offices sought at the 2024 General Election were randomly selected for the review (only local offices were up for election in 2024). For future general elections featuring statewide and General Assembly races, committees for all statewide candidates and 10 percent of General Assembly candidates must be reviewed, in addition to one percent of candidate committees for all other races.¹¹

Candidate committees that received less than \$25,000 in contributions during the campaign (including the transfer of surplus funds from a prior campaign) are not subject to review and, therefore, were not included in the draw. ELECT maintains the percentage selection criteria by selecting the next randomly selected campaign committee for review if a selected committee is ineligible. Otherwise, candidates campaign committees that submitted Statements of Organization were included. If a candidate has multiple Statements of Organization and a candidate committee is selected for a CFR³, then all associated candidate campaign committees are automatically included in the CFR³ and must be reviewed. Further, candidates named on the ballot who have not submitted a Statement of Organization are included in the CFR³ drawing.

The random drawing for selection took place at the State Board of Elections meeting on November 18, 2024¹⁴. Forty-four tickets were drawn before staff were assured that there were seven qualified committees to review for the 2024 cycle. Figure 1 contains a list of the selected campaign committees.

Notifications

ELECT utilized multiple means throughout the year¹⁵ to notify 2024 candidate campaign committees of the § 24.2-948.5 requirements and to request committee-related financial statements and records to conduct the CFR³, which are required to be retained by campaign committee treasurers.

Upon selection for the CFR³, ELECT sent:

- 1) a certified *General Election CFR*³ *Selection Notification Letter*¹⁶ and instructions to the candidate (mailed to candidate's residential mailing address where they are registered to vote), and
- 2) an email to the candidate, campaign treasurer, and committee's Committee Electronic Tracking (COMET) administrator (admin user role).

The formal *General Election CFR*³ *Selection Notification Letter* included instructions and a list of supporting financial statements and records required.

For the annual General Election CFR³ communication, ELECT also provided CFR³ Reminder Letters to active campaign committees. 2024 notices were sent August 6th, September 3rd, October 1st, and one-(1) day prior to the Annual General Election CFR³ selection which was held on November 18th, 2024.

III. Review of 2024 Campaign Finance Reports and Records

Campaign committees that were selected for CFR³ were requested to submit records by January 16th, 2025 (fourteen (14) calendar days from the date on the certified CFR³ Notification Letter). Outreach to two of the seven campaigns that failed to submit campaign finance records by the deadline was completed on February 6, 2025. No campaigns were deemed non-responsive to requests for reports and records. All committees were cooperative.

The following campaign reporting schedules were evaluated.

- Schedule A: Cash Contributions (Cash, Check, Money Order, Credit, or Debit Card)
- Schedule B: In-Kind Contributions (Goods, Services, Property, or Anything of Value)
- Schedule C: Refunds, Rebates, and Interest
- Schedule D: Expenditures
- Schedule E: Loans (Income and Repayment)
- Schedule F: Debts Remaining Unpaid
- Schedule G: Summary Page for Reporting Period
- Schedule H: Summary Page for Current Reporting Year for Committees

The CFR³ review team completed the reviews by evaluating numerous data elements that were compiled, committee submissions of records to ELECT, and reports contained in *CFReports*, ELECT's campaign finance reporting system.



IV. Results of Campaign Reports Review

The table in Figure 3 contains the aggregate results of the CFR³ for all selected campaign committees and review areas and review categories. Results for individual campaign committees are reported by schedule in the Appendices.

Tests were completed to evaluate the summarized data submitted through the *CFReports* system against financial records submitted by the campaign committees. As part of the review of selected candidate committees, compliance was assessed across three key categories: 1) Reconciliation, 2) Mathematical Accuracy, and 3) Facial Completeness. Each committee's performance in these categories was measured as a percentage, and these individual compliance percentages were rolled up into the Overall Compliance.

1) Reconciliation Compliance

Reconciliation checks focused on verifying the accuracy and reliability of reported data against supporting documentation. This included:

- Matching contribution amounts to supporting evidence (e.g., check copies)
- Ensuring In-Kind Contributions were properly itemized and reasonable
- Verifying amounts and descriptions for Rebates, Interest, and Expenditures

These reviews ensured that reported financial data aligned with the supporting campaign

records.

2) Mathematical Accuracy Compliance

Mathematical Accuracy compliance was evaluated using the automated checks built into the COMET system. These checks focused on ensuring that required fields—such as Contact Name, Address, Occupation, Employer Address, and Employer—were completed with valid and meaningful data (i.e., not left blank or filled with placeholder values such as "NA" or "NULL"). As expected, these system-based checks were highly accurate, resulting in consistently strong compliance in this category.

3) Facial Completeness Compliance

Facial Completeness focused on whether all required disclosures were provided in accordance with legal and reporting standards. This included:

- Submission of required Large Contribution Reports (LCR)
- Adequate descriptions of In-Kind Contributions (products and services)
- Clear descriptions of Rebates and Interest
- Proper itemization and description of Expenditures
- Campaign Committees were assessed on whether these items were fully completed and sufficiently detailed to meet statutory requirements.

Overall Compliance

The final Overall Compliance for each committee was calculated by averaging the compliance percentages from the first three key categories. This aggregate compliance provides a comprehensive view of each committee's adherence to reporting and documentation standards.

The review included the evaluation of timeliness of the committees completing scheduled report filings. Scheduled reporting dates for 2024 were April 15, June 10, July 15, September 16, October 15, October 28, December 5, and January 15, 2025. Six of the seven committees filed all reports on time. Incidences of late report filings was high for one committee. Alexander for Mayor filed the April 15, October 16, October 28, and December 5 reports late. See *Figure 4: Timeliness Results*.

V. Conclusions and Observations

All campaign committees selected as part of the 2024 General Election CFR³ submitted financial reports and records to facilitate the required review. While the review uncovered inconsistencies in how campaign committees evidenced financial records, all campaign committees demonstrated that attempts were made to comply with timely and accurate reporting of financial reports and records. In part, the issues related to inconsistences and multiple submissions might indicate the need for increased campaign committee training on filing requirements.

Reviews indicated the following trends of non-compliance across selected campaign committees.

- Inadequate expenditure reporting Records for cash contributions and expenditures were amended multiple times.
- Unreported expenditures Checks were provided that were not included in campaign committee reporting records.
- Lack of support Support documentation was not required for all reported credit card expenditures or for loans and therefore could not be reviewed.

The following are observations recorded in developing and administering the review process that may be helpful in informing future reviews and discussions about amendments to the review process:

- 1) A high volume of amendments was submitted by the selected campaign committees to revise reports and records from initially filed reports, which caused confusion and delays in the sorting of the data points to review.
- 2) The review uncovered several areas where the data to complete the review of all schedules (i.e., Schedule E. Loans or Schedule F. Debts Remaining Unpaid) was not accessible for reviewers to evaluate the data elements. Requirements of § 24.2-948.5 specify source documents related to bank statements and checks be submitted for campaign finance records review. However, it does not require source data for loans and unpaid debt to be reported.



- 3) The CFR³ process required extensive data synthesis using the existing campaign finance systems. System enhancements would increase the efficiency of the review process, including the addition of automation and preventive system controls which would limit data errors and miscalculations by campaigns during entry of information and prevent many non-critical errors.¹⁷
- 4) The 2025 General Election cycle includes statewide elections for the Governor, Lieutenant Governor, and Attorney General, elections for constitutional offices in the independent cities, and elections for all 100 seats in the House of Delegates. The volume of required reviews and the data within the reviews will be significantly higher than the reviews required for the 2024 CFR³ cycle (for example, a recent gubernatorial committee Schedule A filing for a single reporting period contained 38,268 cash contributions, 9,848 of which exceeded the \$500 threshold). Campaign finance system enhancements related to data management and campaign finance reporting would make this review more feasible. Further, additional staff resources will certainly be required to conduct all the required 2025 General Election committee reviews in the allotted time.
 - a. A random sampling approach for the review of large data sets could make such reviews more feasible.
- 5) ELECT is provided 180 days from the date of the election to complete the reviews, meaning for this iteration the review portion should have been completed by May 4, and then the report developed for submission by July 1. However, the reviews cannot begin in earnest until January 16, 2025, because the committee campaign finance report due January 15, 2025, provides the totals for the election cycle which ended on December 31, 2024. This only leaves 108 days to complete the reviews and produce the report by July 1. A deadline of October 1 for the completion of the report of findings would bring the actual time for review closer to the 180 days contemplated by § 24.2-948.5, which will be crucial in high volume review elections like the 2025 General Election (this date is also in line with other mandated reports by ELECT to the General Assembly).
- 6) Training is provided by ELECT of reporting requirements and is available to candidate committee staff. ELECT will continue to reiterate reporting requirements through training and information provided to campaign committees to share common reporting errors and raise awareness of § 24.2-948.5 requirements, including acceptable documentation and required timelines.







Pursuant to §24.2-948.5 of the Code of Virginia (the Code), the Department of Elections (ELECT) has the authority to review **campaign finance reports and records** prepared by campaign committees and is required to undertake such reviews as set forth by law. The purposes of the campaign finance reviews are to (1) reconcile the balance in the campaign depository with the amounts reported in the candidate's reports of receipts and expenditures and (2) review the reports for mathematical accuracy, facial completeness, and timeliness including the reporting of specific information required by law. In the performance of the campaign finance review, ELECT is authorized to request monthly bank statements for, and copies of checks issued on, campaign depositories and itemized bills, invoices, and receipts for any expenditure of campaign funds in an amount greater than \$500.

Campaign Finance Records, Review & Report (CFR³) process must be completed within 180 days after the general election for the following types of campaign committees:

- Statewide Office: All campaign committees for candidates running for statewide office, including those who
 lost in the primary election.
- General Assembly (GA)/Senate and House of Delegates: Ten percent of campaign committees for candidates running for the GA, Senate, and House of Delegates, including losing primary candidates.
- Local/All other offices in any election year: One percent of candidates running for local or other offices in years when these positions are being elected, including losing primary candidates.

This Reminder Letter is provided to all active Virginia campaign committees that filed a Statement of Organization (SOO) to provide information about the CFR³ process and timeframe, remind candidates about campaign finance reporting requirements, and provide information about records that should be retained in the event of selection for a CFR³. A sample, nonexclusive list of required records for a CFR³ is included to assist with planning efforts. This Reminder Letter is emailed to candidates and campaign committee treasurers in August, September, October, and 1-day prior to the Review selection. Key Review dates for the current election cycle are as follows:

Review Selection Date: November 2024

CFR³ Records Submission Date: within 10-calendar days of Review Selection Date

Review Selection

On the Review Selection Date provided above, the State Board of Elections will, at a public meeting, randomly select campaign committees for a CFR³ in accordance with the required percentages stated above.

CFR³ Requirements

For candidate campaign committees selected, ELECT will request campaign committee financial statements and records necessary to conduct the Review. These records are required to be retained by the campaign committee treasurer. This includes, but is not limited to, monthly bank statements, and copies of checks issued, campaign

- Virginia's Campaign Finance Disclosure Act, Chapter 9.3 of Title 24.2 of the Code of Virginia

Appendix C: Statutory Excerpt of § 24.2-948.5

§ 24.2-948.5. Reviews of campaign finance reports and records.

A. The Department shall have the authority to review the reports and records of the campaign committees. The purposes of the review shall be to (i) reconcile the balance in the campaign depository with the amounts reported in the candidate's reports of receipts and expenditures and (ii) review the reports for mathematical accuracy and facial completeness including the reporting of specific information required by law. In the performance of its review, the Department is authorized to request the production of monthly bank statements for, and copies of checks issued on, campaign depositories and itemized bills, invoices, and receipts for any expenditure of campaign funds in an amount greater than \$500.

B. The Department shall review the reports and records of the campaign committees within 180 days following the general election. The Department shall review the reports and records of all of the campaign committees for candidates, including losing primary candidates, for statewide office; 10 percent of the campaign committees for candidates, including losing primary candidates, for the Senate and House of Delegates; and one percent of candidates, including losing primary candidates, for all other offices in any year in which such offices are elected. The State Board shall meet publicly to select the campaign committees to be reviewed by a drawing that ensures selection on a random basis.

C. No review shall be conducted of a campaign committee for any office that has received less than \$25,000 in contributions during the campaign, including the transfer of surplus funds from a prior campaign. Campaign committees for candidates that are exempt from review pursuant to this subsection shall not be included in the drawing provided for in subsection B or counted in determining the number that equals the relevant percentage of the campaign committees to be reviewed.

D. In the performance of its duties under this section, the Department may employ the services of additional personnel to the extent that appropriated funds are available to the Department for such purpose.

E. The Department shall make a report of the results of its reviews available to the State Board, the Governor, and the General Assembly by July 1 of each year following the election year for the office to which the review pertains and the same shall be posted to the Department's website.
