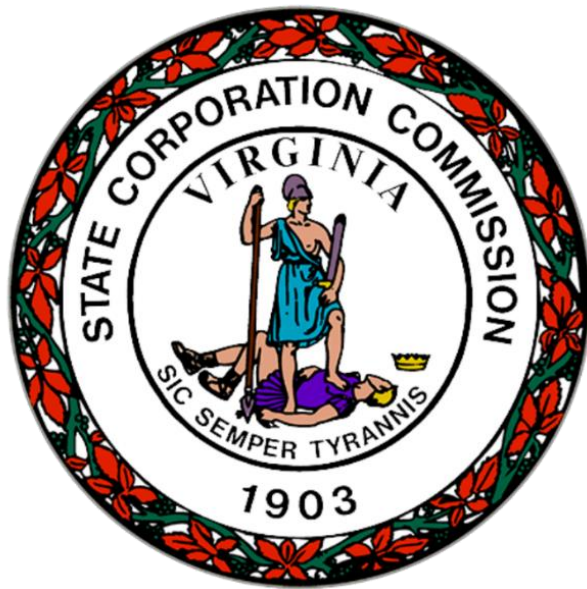


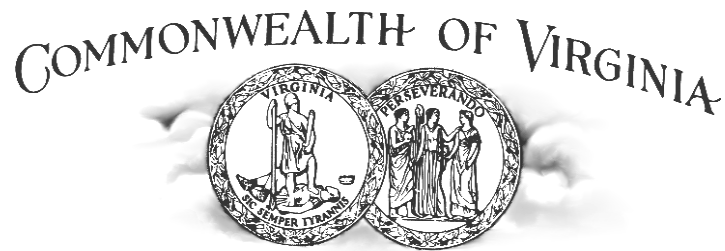

Executive Summary

On behalf of the State Corporation Commission (Commission), the Bureau of Insurance (Bureau) submits this annual health insurance balance billing arbitration report. It summarizes information received from arbitrators related to the resolution of balance billing disputes between health care providers and health carriers, as required by [§ 38.2-3445.02](#) of the Code of Virginia (Code).

This report covers the period May 15, 2024, through May 15, 2025. During this time, the Bureau received 252 arbitrator decisions.¹ Key highlights include the following:

- Of the total arbitration decisions rendered, 55% were decided in favor of the health carrier, and 45% were decided in favor of the provider.
- Health carriers prevailed in 68% of the decisions rendered in the emergency medicine specialty, while providers prevailed in 66% of the decisions rendered in the plastic or reconstructive surgery specialty, 95% in the anesthesiology specialty, and 64% in the neurology specialty.
- The average amount awarded per claimant by specialty was \$439 in emergency medicine; \$1,185 in anesthesiology; \$11,882 in plastic and reconstructive surgery; and \$6,624 in neurology.
- The emergency medicine specialty accounted for 69% of the arbitration decisions and plastic or reconstructive surgery for 18%. The anesthesia specialty made up 8%, and neurology 6%.
- Decisions were rendered on behalf of nine provider practices. Among these nine, one group received 68% of the arbitration decisions. Nine carriers within six carrier groups were named in the decisions. Among these six, one group received 70% of the arbitration decisions.

Scope of Report

Effective January 1, 2021, under Virginia's balance billing law,² when an enrollee receives emergency services from an out-of-network health care provider or receives out-of-network surgical or ancillary services at an in-network facility, the enrollee is not required to pay the out-of-network provider any amount other than the applicable cost-sharing requirement. This amount cannot exceed the cost-sharing requirement that would apply if the services were provided in-network.

When a health care provider disputes the amount to be paid by the health carrier for services rendered to an enrollee, the provider and the health carrier are required to make

a good faith effort to reach a resolution on the reimbursement amount. If the health carrier and the provider cannot agree on a commercially reasonable payment amount, either party may seek to resolve the dispute through arbitration. Arbitrator decisions are provided to the Bureau.³

On behalf of the Commission, the Bureau has prepared this annual report summarizing the health insurance balance billing dispute resolution information received from arbitrators, as required by [§ 38.2-3445.02 I](#) of the Code:

I. The Commission shall prepare an annual report summarizing the dispute resolution information provided by arbitrators, including information related to the matters decided through arbitration as well as the following information for each dispute resolved through arbitration: the name of the carrier, the name of the health care provider, the health care provider's employer or the business entity in which the provider has an ownership interest, the health care facility where the services were provided, and the type of health care services at issues.

Annually, by July 1, the Commission must submit the report to the Chairs of the Senate Committees on Commerce and Labor, and Finance and Appropriations, and the House Committees on Labor and Commerce, and Appropriations. It also must post the report on its website. This report covers the reporting period May 15, 2024, through May 15, 2025.

Reported Decisions

For this reporting period, arbitrators rendered 252 decisions across four specialty areas: emergency medicine, plastic and reconstructive surgery, anesthesia, and neurology. Table 1 shows specialty areas and the number and percentage of reported decisions over the past three years.

Note: For this table, a “plan” is a health insurance carrier or self-funded group health plan that opted into the balance billing protections for their enrollees pursuant to 14VAC5-405-80 of the Virginia Administrative Code.

Table 2 shows the total number of decisions rendered by specialty area, with the number and percentage decided in favor of the plan and the provider.

Distribution Among Provider Groups

Nine provider groups were named in the decisions. Among these nine, one group received 172 (68.3%) of the arbitration decisions, one group received 43 (17.1%), one group received 20 (7.9%), with the other six provider groups receiving a combined 17 (6.7%).

Distribution Among Carriers and Carrier Groups

Nine health carriers within six carrier groups were named in the decisions. Among these nine, one group received 176 (69.8%) of the arbitration decisions and one carrier group received 50 (19.8%). The remaining four carrier groups together received 26 (10.3%).

Conclusion

In conclusion, the emergency medicine specialty continues to dominate this year's report, accounting for 68% of the 252 arbitration decisions. The trends seen in arbitration outcomes and financial awards are also consistent with those of last year's report.⁴ Of note, neurology arbitrations increased to 14 after having had a single arbitration in the previous year. Providers in all of the specialties other than emergency medicine prevailed in the majority of

cases.

In addition, one provider group and one carrier group accounted for the vast majority of arbitration decisions at 68.3% and 69.8%, respectively.

Pursuant to § 38.2-3445.02 I of the Code, this report is the last in the series of annual reports due in July since inception of the balance billing law in 2021. The Bureau will continue to produce the balance billing annual report due in December as required by [§ 38.2-3445.2 C](#) of the Code, and monitor developments in the trends highlighted in the July balance billing reports.
