Executive Summary

James Madison University was established in 1908 as the State Normal and Industrial School for Women at Harrisonburg and became James Madison University in 1977. The Board of Visitors was established in 1964 and currently has fifteen members who serve on the board. Mr. Charles W. King serves as the interim president of the university. The Board of Visitors met five times in 2024: February 15-16; April 18-19; September 12-13 and November 7-8. The Executive Committee met on August 21. The board also held a public comment period on the proposed tuition and fees on April 3, 2024.

The Board has the following committees: Academic Excellence, Advancement and Engagement, Athletics, Audit, Risk and Compliance; Executive Committee; Finance and Physical Development, Governance, and Student Affairs. All of these committees, with the exception of the Executive Committee, meet during the two-day board meeting. The committees hear reports from various staff regarding current issues, new initiatives, and compliance with requirements and/or regulations.
