ANNUAL EXECUTIVE SUMMARY FOR THE WILLIAM & MARY BOARD OF VISITORS

2024

The Board of Visitors is the governing authority of William & Mary (W&M), which includes the Virginia Institute of Marine Science (VIMS), and Richard Bland College (RBC). The Board has taken multiple actions to ensure compliance with the provisions of the *Code of Virginia §23.1-1303, subsection B.13.*, which require the Boards of Visitors of each public institution of higher education to submit to the General Assembly and the Governor an annual executive summary no later than the first day of each regular session of the General Assembly.

During 2024, the W&M Board of Visitors held regular meetings on February 7-9, April 24-26 (annual meeting), September 25-27 and November 20-22, and a Board Retreat on July 23-25. Two meetings of the Executive Committee were also called. See the Table 1 below for details.

The Board met in closed session during its July retreat to discuss its annual evaluation of the performance of the Presidents of W&M and RBC. Further discussion took place during a closed session at the September meeting following which the Board made adjustments to the compensation of the Presidents.

The Subcommittee on Compensation is a subcommittee of the Executive Committee and was officially established during the September 2024 meeting at the request of the Board in accordance with the Board Bylaws.
