Background

During the 2020 Session of the Virginia General Assembly, policymakers enacted Article 14 of Chapter 1 of Title 9.1 of the *Code of Virginia*, establishing the Sexual Assault Forensic Examiner Coordination Program at the Virginia Department of Criminal Justice Services (DCJS), effective July 1, 2020. The goals of the program, as outlined in *Code of Virginia* [§ 9.1-191](#), include developing and enhancing sexual assault forensic examiner programs across Virginia, establishing a partnership group to plan forensic nurse training, assisting with developing protocols and guidelines for the treatment of victims of sexual assault, and collecting and maintaining information on all available sexual assault forensic services in Virginia. The Sexual Assault Forensic Services Coordinator (Coordinator) at DCJS leads this program.

Code of Virginia § 9.1-191 also requires that the “Coordinator shall report annually on or before October 1 to the Governor and the General Assembly. The report shall include a summary of activities for the year and any recommendations to address sexual assault exams within the Commonwealth, including budget needs to increase the availability of sexual assault exam services across the Commonwealth.”

Activities

The Coordinator has ten responsibilities outlined in the *Code of Virginia*. Current activities for state fiscal year 2025 related to each responsibility are described below.

- 1. Create and coordinate an annual statewide sexual assault forensic nurse examiner training program in partnership with the Attorney General, the Virginia Department of Health, the Virginia Hospital and Healthcare Association, the Victim Compensation Fund, the International Association of Forensic Nurses, and the Secretary of Health and Human Services.**

An Adult/Adolescent Sexual Assault Nurse/Forensic Examiner Clinical Skills Lab (lab) was held in April 2024 and was reported in the 2024 Annual Report. The final costs of that lab exceeded the Sexual Assault Forensic Examiner Coordination Program’s annual budget. Given the costs, it was not possible to host another lab in state fiscal year 2025. The next lab is being planned for the fall of 2025.

DCJS, in partnership with the Bon Secours Violence Response Team and a consulting firm, Justice 3D, hosted *Mastering the Stand: Expert Witness Testimony for Forensic Nurses*, a two-day training. The Coordinator assisted with and promoted this training within the Virginia forensic nursing field. Nineteen forensic nurse examiners attended this training.

- 2. Coordinate the development and enhancement of sexual assault forensic examiner programs across the Commonwealth that include prevention of secondary trauma to survivors and culturally sensitive training for health professionals.**

Personal wellbeing and self-care can not only mitigate the impacts of burnout among health professionals, but it also leads to better healthcare for patients.¹ Burnout among forensic nurses is one component of high turnover. The Coordinator implemented quarterly meetings with all Virginia forensic program coordinators to not only provide information and resources for the enhancement of sexual assault forensic examiner programs, but to also address the issue of burnout and high turnover.

The January 2025 coordinators' quarterly meeting focused on developing self-care practices within sexual assault forensic examiner programs.

The April 2025 meeting included a presentation on the TeleEcho Program for forensic examiners at the New England School of Nursing. TeleEcho is a tele-mentoring program that includes a didactic education component, as well as case review and peer mentoring, with the goal of addressing vicarious trauma among sexual assault nurse examiners, improving retention and sustainability of sexual assault forensic programs, and improving healthcare of sexual assault and intimate partner violence patients. The Coordinator is in the planning stages of bringing TeleEcho for forensic examiners to Virginia.

3. Participate in the development of hospital protocols and guidelines for treatment of survivors of sexual assault in partnership with the Department of Health.

The Coordinator was in communication with staff from the Virginia Department of Health (VDH) and attended the meetings of the Task Force on Services for Survivors of Sexual Assault, coordinated by VDH, in accordance with the *Code of Virginia* § 32.1-162.15:11. The Task Force released model and guidance documents for both adult and pediatric transfer and treatment of sexual assault patients. DCJS was not a named member of the Task Force; however, the Coordinator provided information to the Task Force regarding sexual assault programs in the Commonwealth as needed.

The General Assembly passed legislation in 2025 repealing § 32.1-162.15:11, thereby sunseting the Task Force on Services for Sexual Assault Survivors.²

4. Coordinate and strengthen communications among sexual assault nurse examiner medical directors, sexual assault response teams, and hospitals for existing and developing sexual assault nurse examiner programs.

Of particular note during the reporting period:

- The Coordinator consulted with the Harrisonburg area Sexual Assault Response Team (SART) on a training conference that was held in June 2025. The Coordinator attended this conference and consulted with Harrisonburg Child Protective Services representatives on accessing a child forensic examiner in the Harrisonburg area.
- The Coordinator consulted with an advocate on the Eastern Shore of Virginia regarding establishing forensic nursing services for the area.
- The Coordinator provided technical assistance to both forensic nursing programs and community advocacy centers on building stronger relationships and creating policies and practices where advocates are automatically called in when a survivor presents themselves for a sexual assault forensic exam.

5. Provide technical assistance for existing and developing sexual assault forensic examiner programs, including local sexual assault forensic examiner training programs.

The Coordinator sends out a monthly email communication to all forensic nursing programs in Virginia. These emails detail information pertinent to the practice of forensic nursing and have covered the following topics:

- Upcoming trainings and conferences;
- Information/education on vicarious trauma;

- Updates on legislation pertaining to forensic nursing;
- Principles of clear communication with patients;
- U.S. Centers for Disease Control and Prevention (CDC) report on intimate partner violence and pregnancy, released December 2024;
- Information from the Virginia Department of Forensic Science (DFS) on Trace Evidence Collection Kits, also known as Neck and Fingernail Kits (NFK), available to programs starting July 1, 2025, as well as an option for patients to submit an anonymous NFK, starting July 1, 2025; and
- Updates on forensic nursing programs and services around the state.

The Coordinator convenes a quarterly meeting with all Virginia forensic program coordinators to provide and facilitate technical assistance on the following topics:

- Billing to the Supreme Court of Virginia;
- Forensic toxicology testing and testimony capabilities;
- Developing self-care among forensic nursing program staff; and
- Information on developing a statewide TeleEcho Program, with the goal of developing peer mentorships and reducing the impacts of vicarious trauma and isolation among forensic nursing program staff.

6. Create and maintain a statewide list, updated biannually, to include the following:

- a. A list of available sexual assault forensic examiners, sexual assault nurse examiners, sexual assault forensic nurse examiners, and pediatric sexual assault nurse examiners;**
- b. The location and facility affiliation of each examiner;**
- c. The duty hours for each examiner and affiliated facility for sexual assault exam services; and**
- d. The location of available local sexual assault forensic examiner training programs.**

The Coordinator, in collaboration with the DCJS Criminal Justice Research Center, developed a survey for forensic nursing programs that was first distributed in July 2023. This survey is distributed annually, and collects the data enumerated in the *Code of Virginia*. From the data collected, the Coordinator developed a map directory of all the programs in the state, as well as a list directory.

The survey was most recently distributed in January 2025. The outcome of the survey was an updated directory. The survey also gathered data points for Virginia forensic nursing programs, as well as additional information that helps to identify the needs and challenges experienced by the programs.

The Coordinator distributes the directory regularly in the aforementioned monthly email communication. Programs regularly communicate with the Coordinator on any changes that the program has undergone, which aids in keeping the directory up to date.

7. Coordinate, share, and disseminate the list created pursuant to subdivision 6 to the emergency operations communications system available to emergency medical services and law-enforcement agencies as well as the internal emergency and hospital communications system.

The Coordinator shared and disseminated the directory with the enumerated agencies and entities.

8. Share and disseminate the list created pursuant to subdivision 6 with all other relevant agencies, including law-enforcement agencies, attorneys for the Commonwealth, victim-witness programs, sexual assault service organizations, the Virginia Department of Juvenile Justice, the Virginia Department of Social Services, the Virginia Department of Education, and school divisions.

The Coordinator shared and disseminated the directory with the enumerated agencies and entities. The directory also appears on the Sexual Assault Forensic Coordination Program web pages under the DCJS public facing website.

9. Create sexual assault nurse examiner recruitment materials for universities and colleges with nursing programs in partnership with the State Council of Higher Education for Virginia.

The Coordinator created a presentation for student nursing associations, which was used in the presentations described in the subsequent section.

10. Support and coordinate community education and public outreach, when appropriate, relating to sexual assault nurse examiner issues for the Commonwealth.

The Coordinator partnered with Sentara Rockingham Memorial Hospital (RMH) Sexual Assault Nurse Examiner (SANE) Program and Valley Urgent Care & Occupational Medicine SANE Program in a virtual presentation to the James Madison University (JMU) student nurse association. A total of 150 nursing students were in attendance.

The Coordinator also partnered with the University of Virginia (UVA) Forensic Team on an in-person presentation to the UVA student nursing association. Twenty-eight students attended this presentation.

The Coordinator attended and presented at the 2025 Virginia Chapter of the International Association of Forensic Nurses (IAFN) Training Conference, and provided updates on legislation, training, and information from DFS on Trace Evidence Collection Kits/NFKs.

The Coordinator regularly attends both the Virginia Chapter of the IAFN and the IAFN State/Territory/Tribal Coordinators meetings and provides Virginia updates.

Forensic Nurse Examiner Programs Across the Commonwealth by the Numbers

In January 2025, DCJS conducted a survey of sexual assault forensic nursing programs across the Commonwealth and found 22 active forensic nursing programs, serving a total of 79 locations, which includes hospitals, emergency departments, urgent care clinics, stand-alone (non-hospital affiliated) programs, and child advocacy centers. Programs reported a total of 184 forensic examiners in Virginia. Of the 22 active forensic nursing programs, four are stand-alone programs and 18 are hospital-affiliated programs.

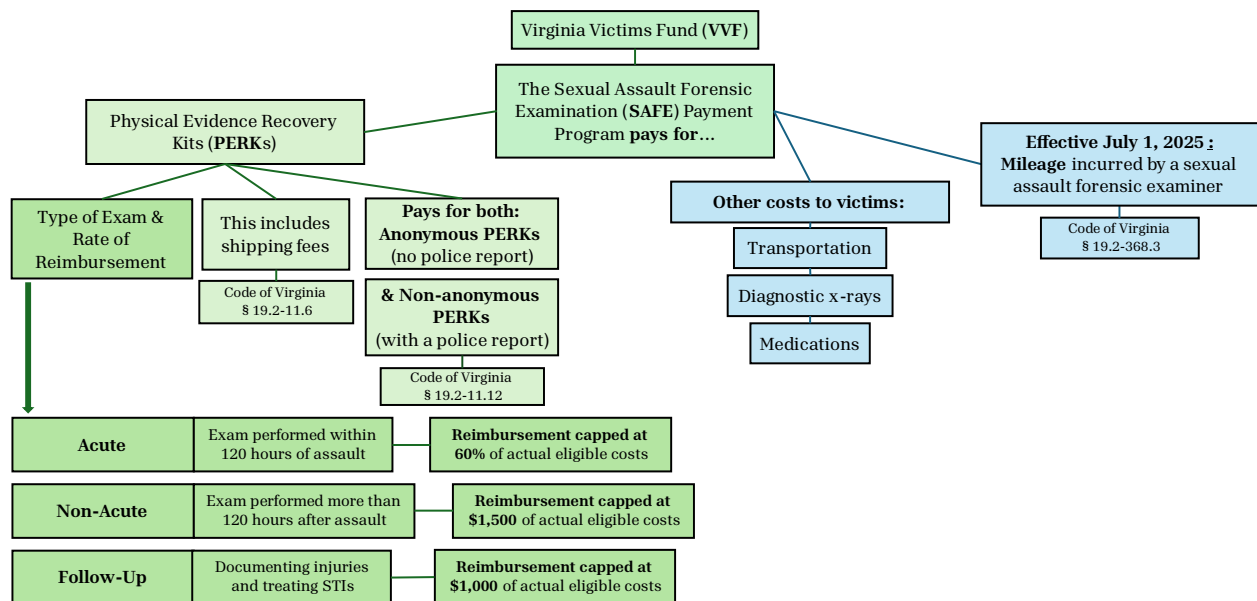

Sustaining Virginia's Forensic Nursing Programs

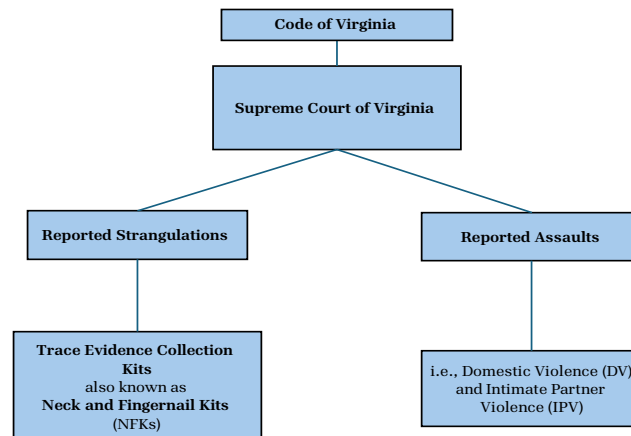
The Coordinator identified the following challenges to sustain existing Forensic Nurse Examiner (FNE) programs and expanding FNE programs in Virginia:

1. Virginia has two avenues for reimbursing FNE programs for the services they provide: the Virginia Victims Fund³ and the Supreme Court of Virginia. The Virginia Victims Fund's Sexual Assault Forensic Exam (SAFE) Payment Program reimburses for both reported and non-reported sexual assault exams. The Supreme Court reimburses for the collection of evidence for all criminal cases where medical evidence is necessary to establish a crime has occurred (*Code of Virginia* § 19.2-165.1).

The SAFE Payment Program reimbursement process is diagrammed below:⁴

The SAFE Payment Program and the Supreme Court not only reimburse for different types of criminal evidence collection, performed by FNE programs, but their processes for reimbursement are very different. The SAFE Payment Program process is very straightforward, in which FNE programs bill the SAFE Payment Program via their online WebFile system. The Supreme Court requires that bills be sent to the local Commonwealth's Attorney for submission, causing confusion among not only the programs themselves, but among hospital billing departments.

2. The last increase to the rate of reimbursement through the SAFE Payment Program occurred in April 2022, over three years ago, while costs associated with FNE exams continue to rise.
3. The following are provided by FNE programs, as required by the *Code of Virginia* §19.2-11.6, but these are not currently reimbursed or funded by the state:
 - a. Effective July 1, 2025, Trace Evidence Collection Kits will be made available to FNE programs. These kits will be used to collect evidence from alleged or suspected strangulation, as defined by the *Code of Virginia*. The Virginia Department of Forensic Science refers to these as Neck and Fingernail Kits (NFK). Patients will have the option of obtaining a non-reported NFK; however, there is no state entity assigned to reimburse FNE programs for these non-reported NFK.⁶
 - b. For a patient presenting for a medical exam after a sexual assault, that medical exam is not SAFE Payment Program reimbursable unless the patient opts to collect evidence.
 - c. Unreported forensic medical exams are not reimbursed.
 - d. The time forensic nurse examiners spend preparing for court, and the time spent in court hearings and/or waiting for court, are not currently reimbursed.
 - e. The time forensic nurse examiners spend in Sexual Assault Response Team meetings and other multidisciplinary team meetings is not currently reimbursed.
 - f. The time forensic nurse examiners spend in training, and associated training costs, are not currently reimbursed:
 - The IAFN offers an online adult/adolescent Sexual Assault Nurse Examiner (SANE) training, which includes 41 contact hours and costs \$375 for members and \$600 for non-members. The IAFN also offers online pediatric SANE training which costs \$450 for members and \$600 for non-members.⁷
 - Certification costs are \$275 for IAFN members who register early, and late registration is \$455 for members; for nonmembers those costs are \$425 for early registration and \$605 for late registration.⁸
 - The IAFN is a membership organization with an annual membership fee.
 - In addition to the online courses and certification fees, programs spend time and resources at the program level on training nurses and preparing them for certification, as illustrated by the IAFN prerequisites for certification:
 - Current, unrestricted licensure as a registered nurse (RN) or advanced practice nurse (APRN);
 - Minimum practice as a RN for the SANE adult/adolescent exam is two years and for the SANE pediatric exam it is three years;
 - Completion of a minimum 40-hour SANE didactic course by an accredited provider
 - Completion of a SANE clinical preceptorship; and
 - Accrual of 300 hours of SANE-related practice within the past three years (at least 200 hours with the intended exam population).⁹

- g. FNE programs incur costs for continuing education, which vary depending on the course. Programs report that it takes anywhere from \$32,000 to \$75,000 to train and onboard a forensic nurse examiner, but that the average time that forensic nurse examiners are spending in the field is only 1.5 years.
- h. Funding for the Sexual Assault Forensic Examiner Coordination Program resides in the general fund budget; however, the amount currently allocated does not sustain the mandated responsibilities for the position, such as training and technical support.

The 2025 Virginia General Assembly passed, and the Governor signed House Bill 1731, which includes an enactment clause directing DCJS to:

...convene a work group to address sustainable funding for sexual assault medical forensic examinations and services to include the Commissioner of Health or his designee, the Executive Director of the Virginia Workers' Compensation Commission or his designee, the Executive Secretary of the Supreme Court of Virginia or his designee, two representatives from the Virginia Hospital & Healthcare Association, two representatives from the Virginia Chapter of the International Association of Forensic Nurses, one representative from the Medical Society of Virginia, one representative from the Virginia Nurses Association, two representatives from the Virginia Sexual and Domestic Violence Action Alliance, and other stakeholders designated by the Director or his designee. The work group shall submit a report with recommendations to the Chairs of the House Committee on Health and Human Services, the House Committee on Appropriations, the Senate Committee on Education and Health, and the Senate Committee on Finance and Appropriations by November 1, 2025.¹⁰

This work group held its first meeting on June 9, 2025, and is in the process of generating recommendations.

Recommendations

1. Reimbursements and funding:

- a. Include regular increases in the SAFE Payment Program reimbursement rates to more accurately reflect the actual and total costs of sexual assault forensic examinations.
- b. Increase funding for the Sexual Assault Forensic Examiner Coordination Program to sustain *Code of Virginia*-mandated training and technical assistance responsibilities.
- c. Identify avenues for reimbursement and funding for FNE programs for:
 - Medical exams of patients presenting due to sexual assault or domestic/intimate partner violence, but who opt not to collect evidence.
 - Reported and non-reported domestic/intimate partner violence medical forensic exams, eliminating the Supreme Court as the reimbursement entity for collection of evidence from reported domestic/intimate partner violence.
 - Reported and anonymous Trace Evidence Collection Kits/NFKs.
 - Mileage of nurses traveling from one exam site to another to perform a medical forensic exam on a patient presenting due to domestic/intimate partner violence.
 - Time examiners spend preparing for and in court.
 - Time examiners spend in SART and other multidisciplinary team meetings.
 - Costs associated with nurses obtaining SANE adult/adolescent and SANE pediatric training.
 - Costs associated with obtaining SANE certifications.
