I am writing on behalf of Buena Vista City Public Schools to affirm that our division is in full compliance with the requirements outlined in HB2278 regarding accessibility for individuals with physical disabilities.

In consultation with stakeholders, Buena Vista City Public Schools has completed a comprehensive review that includes:

- Examining our public school buildings and grounds to identify any physical accessibility challenges or barriers that may limit participation in school activities for individuals with physical disabilities;
- Assessing access to programming, resources, and supports available to individuals with physical disabilities across all public elementary and secondary schools in the division;
- Evaluating and documenting completed efforts, ongoing initiatives, and planned strategies to address and eliminate accessibility challenges and barriers; and
- Identifying opportunities for state agencies to provide support and assistance to ensure that all schools remain fully compliant with applicable state and federal laws.

We found no limitations during our review. Our commitment to ensuring that all students, staff, families, and community members can fully access and engage in school environments and activities remains a top priority. We will continue to collaborate with state partners and stakeholders to sustain this work and maintain compliance moving forward.
