- Twenty petitions were pending on January 1, 2024.
- Twenty-four petitions were filed in 2024.
- Twenty-four petitions were disposed of in 2024. The dispositions of those cases were as follows:
  - o Two writs were issued, and the convictions vacated.
  - o Twenty-one petitions were summarily dismissed.
  - One petition was dismissed following consideration of the Attorney General's response to the petition and petitioner's reply thereto, if any, and the circuit court's findings of fact.
- Twenty petitions were pending as of December 31, 2024.
