<u>HB2278 – Surveys of School Districts & School Facilities Survey</u>

Sussex County Public Schools

Sussex County Public Schools conducted an ADA Survey of all School Facilities on the Campus during October 2025 in accordance with the Guidelines of GAO-20-448 Accessibility of School Facilities.

Sussex Central High School - Built in 2001 and complied with all ADA Guidelines as approved by the Architect and Engineer at the time of construction. The survey revealed that all Entry, Classroom and large space doors are a minimum of 36 inches. The Public areas such as Gymnasium, Auditorium, Cafeteria and Media Center are all ADA compliant. The Bathrooms and Locker Rooms all meet ADA Guidelines for accessibility. There are no second floor areas that require an elevator or lift for access.

Sussex Central Middle School – Built pre-1967 and added on to and renovated in 2006. This building was added on to and remodeled within all ADA Guidelines as specified and approved by the Architect and Engineer at the time of construction. The survey revealed that all Entry, Classroom and large space doors are a minimum of 36 inches. The Public areas such as Gymnasium, Auditorium, Cafeteria and Media Center are all ADA compliant. The Bathrooms and Locker Rooms all meet ADA Guidelines for accessibility. The second floor media center office space area has accessible by a lift that is ADA compatible with a max 4 employee weight limit.

Sussex Central Elementary School – Built in 2013 was constructed with all ADA Guidelines as specified and approved by the Architect and Engineer at the time of construction. The survey revealed that all Entry, Classroom and large space doors are a minimum of 36 inches. The Public areas such as Gymnasium, Auditorium, Cafeteria and Media Center are all ADA compliant. The Bathrooms and Locker Rooms all meet ADA Guidelines for accessibility. There are no second floor areas requiring an elevator or lift for access.

Sussex Administration Building – Built in 1968 and renovated in 2005. This building, only for Employees and Visitors, was added on to and remodeled within all ADA Guidelines as specified and approved by the Architect and Engineer at the time of construction. The survey revealed that all Entry, Office and large space doors are a minimum of 36 inches. The Public areas such as School Board Meeting Room, Kitchen/Work Area and Conference Rooms all meet ADA Guidelines for accessibility.

Sussex Operations Center – Built in 2007 was constructed with all ADA Guidelines as specified and approved by the Architect and Engineer at the time of construction. The survey revealed that all Entry, and large space doors are a minimum of 36 inches. The areas such as Office Space, Garage and Technology Center all meet ADA Guidelines for accessibility. There is an office area on the second floor for technology staff that only has stairway access. If an employee needed handicapped accessibility there is office space on the first floor.

Sussex Field House – Built in 2003 and was constructed with all ADA Guidelines as specified and approved by the Architect and Engineer at the time of construction. The survey revealed that all Entry,

and large space doors are a minimum of 36 inches. This area houses a kitchen, serving area, storage and locker rooms and is 100% in compliance with ADA Guidelines for accessibility.

<u>Parking areas for all Buildings</u> – All parking areas for School and other Buildings meet the minimum requirement of marked handicapped accessible spaces, including signs, for the number of employees and/or visitors that we may have an any given day.

In summary, all School Buildings and all other supporting buildings on the Campus of Sussex County Public Schools meet the requirements of the ADA for School Districts.
